This is definitely a frenzied time for elections office staff and candidates as the reality of so little time sets in so soon after the holiday season. It has also been a busy time for our voter services subcommittees as they have been preparing for what the next two months will bring. 2020 presents many opportunities for our members to be involved in voter services and put the October training to good use.

ADOPT-A-POLL- LWV of SLO County is once again committing to staffing 2-3 polling places for the March 3<sup>rd</sup> election. This is not only a great fund raiser for the League as the county pays a minimum of \$52 per precinct, but it also provides our members an op-

# Talking to Family and Friends about Climate Change

Most of us are generally inclined to avoid contentious topics when we talk with our relatives and friends. Unfortunately, climate change often falls into this category. But if we discuss this topic by really listening to and respecting each other, my experience is that such conversations can be 'a teaching moment.' With this point of view, here are some suggestions about talking to your relatives and friends about a topic high up on the LWV agenda.

Each one of us carries a "world view" and set of values and tends to feel close to and loyal to that group which shares these values. So, the first step is to understand those values and the group the person you are talking to identifies with. I find it useful to consider three different groups: a) those who strongly doubt the scientific consensus about the reality and seriousness of human caused climate change and are suspicious any governmental action to deal with it; b) those who have heard about climate change, but are not well informed, or maybe misinformed about it: c) those who accept the scientific consensus and agree that action should be taken, but are not sure what to do.

For the *first* group (the 'dismissive'), I strongly urge watching this 8-minute video by climate scientist and excellent communicator Katharine Hayhoe: "If I just explain the facts, they'll get it, right?" <a href="https://www.youtube.com/watch?">https://www.youtube.com/watch?</a> v=nkMIjbDtdo0. Her main mes-

PROS & CONS—With only one statewide ballot measure on the ballot for the March election, (Proposition 13, a statewide bond measure for school funding), it is a slow start to this important educational function. **Sharon Whitney**, the committee chair, is preparing information to be able to conduct pros and cons for those organizations requesting this assistance from the League.

VOTER'S EDGE—Shelly Higginbotham, committee chair, is working with the state League to populate San Luis Obispo County's candidates and measures. As soon as this is accomplished, the Voter's Edge team is ready to contact candidates to encourage their participation. If you personally know any candidates for office, urge them to participate in this free resource. Shelly is planning outreach to the media and voters at candidate forums to encourage the use of Voter's Edge. We hope that all of our members will use https://votersedge.org/ca as you study the candidates and ballot propositions on the March election ballot.



VOTER REGISTRATION—In addition to the four high school visits held in January, the voter registration team presented a PowerPoint and registered voters at the Villages, a senior living residence, on January 3<sup>rd</sup> and participated with a voter registration booth at the Women's March on January 18<sup>th</sup>.

sage: Don't dwell on the science but talk about how it affects values that you and your friend mutually share. If we're both parents, how is it affecting our children and their health—we all want clean water and air for our kids. So why not use as much wind and solar energy as possible now that they have become costcompetitive and will also create new jobs without a lot of outsourcing. Or, maybe you share a love of recreational activity—our forests, streams, bird and wildlife habitats are all being adversely affected. Are you both being affected by more flooding in your streets, more severe wildfires, heat waves or severe storms? If you are both concerned about rising insurance costs or national security explain how climate change is impacting insurance costs and what the military is saying about how climate change impacts national security by, for example, melting arctic sea ice and the challenges faced for control of these new sea lanes. And finally, if you are persons of religious faith, point out that all the great religions of the world share the concept of "stewardship of the earth."

For the *second* group "the disengaged," much the same approach is helpful. But you can augment this by explaining the basics of climate science. In a nutshell, it is simply this: By burning fossil fuels we've drastically changed the amount of heat-trapping gases in our atmosphere, mainly carbon dioxide. This basic idea has been understood for more than 100



# Program Planning Meeting – January 25, 2020

Twenty-one members and prospective members attended Program Planning for the 2020 -2021 League program year on January 25 at the United Methodist Church in San Luis Obispo. 2<sup>nd</sup> Vice President and program organizer Deb Humphreys welcomed everyone. Co-President Ann Havlik explained the purpose of Program Planning – to set priorities for the year ahead, hear updates on ongoing projects, and identify national and state issues to follow. We reviewed the status of the Program adopted by the membership at last year's Annual Meeting and planned what we want to do next Program Year, beginning in July 2020.

Voter Service Director Julie **Rodewald** reviewed the highlights of the 2019 - 2020 Program Year so far. The Program adopted at last year's Annual Meeting emphasized Voter Service and Civil Discourse. Ms. Rodewald described voter registration, candidate forums, Voter's Edge, and Adopt-a-Poll activities that we are currently engaged in. We held a successful Voter Service training last October and have been pleased that so many members have volunteered to work on the Voter Service activities. Ms. Humphreys reported on Civil Discourse and the Democracy Concierge Service at SLO City Council meetings. There is a need for more volunteers at these meetings.

We discussed the League's nonpartisanship position. Eric Greening raised a question about working a Candidates Forum if you have endorsed or donated to a candidate. Ms. Rodewald explained

that we have to protect the League's reputation and public face from perceptions of bias. Someone who has endorsed or donated to a candidate should not work a forum in which that candidate is participating. Marilee Hyman explained an issue with regard to the Brown Act that we are facing with a forum scheduled for February 11. The sponsor, NAACP San Luis Obispo County, has invited all six incumbents and challengers to participate. We are investigating with the County Attorney's Office how this should be handled. Sharon Whitney, Chair of the Rules Committee, reported that her committee is reviewing and proposing changes to our current nonpartisanship policy to update it and make it clearer.

Co-President Cindy-Maire Absey reported that the LWVC Climate Change Task Force has encouraged us to ask LWVUS to add "Climate Emergency" to the proposed National Program focus for 2020 - 2021. The current LWVUS focus is the Campaign for Making Democracy Work. As part of the planning process, local Leagues are asked to make recommendations to LWVUS. Mr. Greening noted the possible unintended consequences of calling the climate situation an "emergency." Such a designation may invite government interventions that weaken environmental standards, restrict individual decision-making, and might even suspend civil liberties. Ms. Absey requested that we discuss this today as part of our Program Planning. She also encouraged

everyone to attend the Central California Climate Change Forum organized by the state task force on March 28 in Santa Barbara. We will arrange for car-pooling down to the event.

Ms. Humphreys introduced the Café Dialogue format used for the meeting to generate a proposed Program which will be presented to the Board for their approval. The Board recommended Program will then go to the membership for adoption at the Annual Meeting on May 30. She explained the process and introduced the table hosts: Patti Dale, Richard Moore, Nancy Welts, and Sharon Whitney. Carol Courcy served as a back-up facilitator. The emphasis of our discussion was on local issues, the issues that we care about personally and that we would like to see our League involved in locally. We focused on the question: Recognizing our commitment to support current State and National League Programs related to Healthcare Reform, Voting Rights, Election Support, the Environment, the Census, and Immigration Reform, what other critical local issues make sense for us to address? We broke into small groups for three rounds of dialogue on each question, facilitated by the table hosts. We summarized the results

years and about 29 of 30 climate scientists agree.

For the *third* group, "the engaged and concerned," encourage them to become even better informed, and to participate in organizations such as the Citizens Climate Lobby. This group has initiated a bipartisan effort in Congress to promote policies, such as a revenue-neutral carbon tax, in order to encourage switching to renewable energy. Additionally, you can explore the LWVC Climate Change Task Force to obtain resources and advocacy tips.



Most important and for all groups, emphasize that we already have the ability to solve the problem of climate change, both individually and collectively. As individuals we can insulate our homes more effectively, walk more and drive less, buy low emission cars and install solar panels where possible. Collectively we can generate low emission power and switch to, more public transportation and low emission vehicles which result in clean air and water and provides good paying jobs. And, preserve the only planet we have. A winwin situation for all of us.

and a spokesperson from each table reported on the results of the discussion at their table.

<u>Issues and Actions that emerged from our discussions:</u>

We agreed by consensus that we need to modernize our outreach and engagement with members and the community at large. We agreed to propose to the Board that we establish a Modernizing Outreach & Engagement Committee which will introduce new (to us) methods of communicating, increase League exposure to voters 18 - 44 years of age and other politically ignored voters, give us greater access to north county members and voters, and make participation in League activities easier. The Board will act on this immediately. It is a process and will not be part of the Program for 2020 - 2012 as such.

We agreed by consensus that the request from LWVC Climate Change Task Force to add "Climate Emergency" to the LWVUS program will be handled by the Board. It will not be in-

cluded in our local Program for 2020 - 2021.

We agreed to maintain all current local positions. No new studies were recommended.

To support the broader issues of combating climate change, protecting the environment, advancing economic justice, and making democracy work, the local issues we want to focus on are:

Land use issues, including the decommissioning of Diablo Canyon, the Cal Poly Master Plan, approval for quarries in the county, use of the Oceano Dunes for vehicular recreation, concerns with CEQA and the permitting process.

Water issues, including local conservation efforts, water quality, and county ground water policy.

Homelessness, including defining homelessness, increasing awareness of the nature of homelessness, projects to support safety, sanitation, and mental health services for the homeless population.

Renewed and strengthened civil discourse activities to ensure the safety and protection from harassment of elected officials, candidates, and others participating in public life.

Continued emphasis on voter outreach, education, and motivation.

We will support these issues through public education efforts, advocacy for particular programs or projects, and cooperation with other organizations and groups that are also committed to these issues.

Janice Carr, Co-Chair of the Centennial Celebrations Committee, presented an update on activities for the 2020 anniversary celebrations. She noted that the yellow & purple suffragist sashes are available for a recommended donation of \$8.00 and vintage signs stating "A woman living here is registered to vote" for a recommended donation of \$5.00.

Ms. Humphreys and Board Secretary Vallerie Steenson will consolidate the results of the discussion and present them to the Board for approval. A proposed program for 2020 - 2021 will be included in the Annual Meeting packet to be voted on at the Annual Meeting on May 30, 2020.

The meeting adjourned at 12:00 pm.

The League of Women Voters of San Luis Obispo County has received another National Education Fund High School Voter Registration Grant in the amount of \$500, which will supplement the \$1400 in grants received over the last 2 years. These funds will continue to provide the resources to ensure the team can reach as many students as possible.

Our high school voter registration program began in 2017, and since that time over 1600 students have been registered or pre-registered

Since the registration deadline for the March 3<sup>rd</sup> primary election is February 17, the voter registration team has already visited four high schools in January. Many of the students registering now are eligible to vote in March, and over 90% will be able to vote in November. An exciting election year for their first election!
