## **Voter's Edge Update**

Voter's Edge is a website that assists voters in getting information about candidates for office as well as info about the measures and propositions on the ballot. It is a statewide program, serving several



million people, and is advertised in our voter registration programs with a bookmark explaining how to use it.

The information on Voter's Edge is inputted by volunteers in each county. There is a formal, established system for contacting candidates and getting their data. This fall there will be approximately 150 candidates running for office in Solano County:

mayors, city councilmembers, school board members, and others. We will need a lot of volunteers to help with this important resource to the public. The LWVC Voter's Edge team will be offering a webinar training in July (date TBD). That team is very helpful and can guide us well with our own county endeavors. We will start entering data in late August or early September and continue until November. It's a short term, intense job that is satisfying to do. ## **DUES and Tax Deductibility**

Unless you have paid your dues recently **it is time to pay annual dues** which come due each year at our Annual Membership meeting. As noted above, our annual dues is \$70 for a single membership and \$105 for two members in one household. The simplest way to pay this is to write a check to the League of Women Voters Solano County or go to our <u>website</u> and use PayPal to pay. If you would like to receive a partial tax deduction the LWV US has determined that half

of the payment we send to them is eligible for a tax deduction and the LWV CA has determined that a quarter of the payment we send to them is eligible for a deduction. You could write two separate checks. If you are a single member you can make one check out to *LWV Solano County* for \$47.00. This amount is not tax deductible. You can make a second check out to *LWV Solano County Education Fund* for \$23.This is the taxdeductible portion. If you are a two-member household make out one check for \$70.50 to *LWV Solano County* and a second check for \$34.50 to *LWV Solano County Education Fund*. The \$34.50 check is tax deductible. ### **Donations to the LWV Solano County**

Any time is a good time to make a donation to the League of Women Voters Solano County. Our annual membership dues, \$70 for a single membership and \$105 for two members in the same household goes mostly to support the extensive educational, advocacy, lobbying and legal action to further the educational and advocacy goals of the LWV US, LWV California and the LWV Bay Area organizations. **Only 10% of the money we collect supports the work of our local organization.** Our organization's activities are greatly enhanced by the donations and grants we receive from members and organizations.

**Adopt-A-Poll:** Many members and friends worked at polling places during the primary election in March. This is an important service that our members provide to the community. Many members donate the money they earn to the League of Women Voters Solano County. These donations are greatly appreciated and help fund our voter registration and educational events. If you would like to donate all or part of your earnings from working the Polls you need to deposit the check you receive from the Registrar of Voters' office and write a check for the amount you would like to donate to either the *League of Women Voters Solano County*, (this is the non-tax deductible option) or to the *League of Women Voters Solano County Education Fund* (this is the tax deductible option.)

**501 (c)(3)s and 501 (c)(4)s.** Our local chapter of the League and the federal and state chapters are tax exempt 501 (c) (4) organizations. Known as Social Welfare organizations they are allowed to advocate and lobby for their exempt purpose although they may not participate in a campaign for or against a particular candidate for office. Donations to these organizations are not tax deductible. Examples of well-known 501 (c) (4) organizations are the Sierra Club, the American Civil Liberties Union, and Club for Growth, the National Rifle Association, the California League of Conservation Voters, and AARP. The League of Women Voters has a distinct organization which is a 501 (c) (3). Its purpose is solely to provide educational and voter services programs. None of its funds can be used for advocacy. We have an account with this organization, the League of Women Voters Solano County Education Fund. Checks deposited in this account are tax deductible for the donor and are restricted in use.

# **MEMBERSHIP COMMITTEE**

The Committee is focusing on outreach via calls and Zoom and planning now for "in person" events once we can again meet in the real world and not just virtually.

**2020 Priorities**. With its successful 2019 outreach to Solano College and diverse community organizations and churches, the committee has committed to expanding and building on our 2019 Goals and Priorities.

#### **Team Member Activities Updates**

**Solano Community College**, Marilee sent a questionnaire to all of our Student Members to actively engage them in LWVSC activities. Meaningful work that fits a student's class and work schedule is challenging but once students are involved, they will be a powerful force. Marilee is also doing follow up calls to the students.



- League Members, she has also developed a similar outreach email to encourage member participation in our committees and activities.
- **Local Organizations,** Marilee is also building a general purpose email we can use for organizations which we would like to connect with and those which want to know more about our League activities.

<u>Margo and Alice</u> are working with Delta Sigma Theta Sorority to expand our working relationship with this dynamic and well-established organization. They have already co-sponsored a forum with LWVSC, helped us register Vallejo high school students, and are very interested in leveraging their existing youth programs to support our new high school civics competition.

**Community Church Connections.** Margo is networking with Common Ground a group of Catholic churches, the Homeless Alliance, and Benicia Liberty Church pastors to provide LWV information online and in person.

**Napa League Connection**. Margo and Niles had a productive Zoom meeting with LWV Napa. The current Napa League has been active for 5 years but there was a previous Napa League that started in the 1940's and was active for 30 years. They were particularly wanted to know what we had done for membership and were very impressed by what we have been able to achieve in the last year along with our restructuring for countywide membership and our diversity efforts.

The Voter Service Committee is holding regular Zoom meetings.

### **Campaign Finance Reform in Benicia**

The City Council had their second reading of the new campaign finance ordinance in early April. The meeting was supposed to be televised with an option for public comment, but there were major

technical difficulties, so only audio was available with no public comment. It appears that more changes were suggested by the lawyers and the ordinance has been returned to staff for updating. Stay tuned, we may get a new ordinance in place in time for the August filing deadline for the fall election.

## **Voter Service: Planning for the Future**

The Voter Service Committee is actively engaged in restructuring the committee, delegating the various tasks to specific positions. Area Coordinators will be taking on more responsibilities for jobs tied to their

current efforts, but more volunteers will be needed to help with candidate forums, Voters Edge, and sign distribution. We hope to be able to send out a finalized copy of our structure and tasks with the Membership Packet in May.

### **Youth Voter Registration Project**

We want to continue our Youth Voter Registration Program and expand our college

and adult registration programs, but the pandemic is anticipated to restrict some of our activities into the fall. We may not be able to physically go into the classrooms once school resumes, but the LWVCA has put together a "virtual voter service visit" that we can use, with just a little tweaking. Plans for volunteer training for voter registration continues and will most likely occur by Zoom in late July or early August. On a more positive note, the parameters for the grant we received from LWVUS have been extended timewise from June through November, so we will have more time to spend the \$520 we have already been awarded and to expect another \$230 when our paperwork is completed afterward.

# Adopt-a-Poll

Our March Adopt-a-Poll in Benicia was very successful. We had a good turn-out of well-trained volunteers, many of whom donated their poll worker paychecks back to our League earning us nearly \$1000. A winwin! Not only did we help with the election, we raised money to keep our League doing its good work. Other League members worked as individual poll workers at Rodriquez High and at other sites around the county.

The future of Adopt-a-Poll is uncertain because of the pandemic and also because of a statewide push for California to become a total vote by mail state. Local officials are concerned that many of the poll workers who are senior citizens will need to stay quarantined at home during the election creating a void in available workers. There is also concern about spreading disease at the polls. In the last election, various counties experimented with voting only by mail and officials in those counties determined that it was successful, efficient, and cost-effective.







# **PROGRAM AND PLANNING COMMITTEE**

Annual Membership Meeting. The Program Planning and Events Committee is planning for the League's Annual Membership Meeting. Because the League, locally, state and nationally have committed to only remote, electronic meetings for the foreseeable future, our Annual Membership Meeting will be very different this year.

> Vote to Adopt the Program for the year. Get an updated Nominating Committee Report. Vote to elect the Board officers and directors for positions that need to be filled this year.

Vote to elect the Nominating Committee for the next year.

Vote to Adopt the Budget.

Vote to Adopt the Bylaw changes.



As you can see, you should plan ahead to be prepared to vote which is why you should carefully read and follow the links in the May 11th email.
