As you have seen on the front page, we have planned two important programs for November. Both events will take place on Veterans Day weekend. The Veterans Day National Ceremony will be held on Friday, November 11, at Arlington National Cemetery and observed throughout the country. On the following day, Saturday, November 12, Meg Giberson has prepared a fabulous water program.

Just a note here that on September 8, 2016, Governor Brown signed SB 32 and AB 197. Both bills expand state GHG reduction policies into the future and add a focus on equity in carrying them out. SB 32 will extend the landmark Global Warming Solutions Act (AB 32) of 2006, by setting a target reduction of GHG pollution to 40% below 1990 levels by the year 2030. Its companion bill, AB 197, requires more transparency and accountability of the California Air Resources Board. It calls for priority consideration of disadvantaged communities and those most affected by air pollution and includes the social costs of carbon as a factor for evaluating the cost-effectiveness of GHG reduction measures.

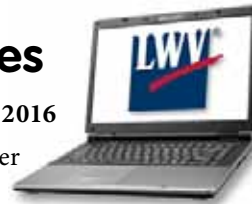

The required insurance for Los Gatos Council Chamber is being worked on, but the Forum is still going forward.

With 17 Measures on the Calif. ballot, Pros & Cons meetings are also very well attended. The Board encouraged talking about LWV at beginning of events.

• **Education:** Eleanor Yick let the Board know that the presentation to Middle-Schools at the Casa di Mir Montessori School on how government works was very well received. It is a good presentation to do since civics is no longer required to graduate in California!

• **Voter's Edge:** Tom Picraux requested volunteer help with contacting candidates. Gail Pedersen will email the flyer with



the bookmarks to the Board for suggested distribution at events.

• **Observers:** Raquel needs one or two volunteers to observe Monte Sereno City Council meetings. They can be watched on TV. It was requested that dates of the meetings be added to the reports in the Voter.

• **Membership:** President Itani requested that the join form be displayed at all our events. A needed brochure presenting LWV and also displayed at events was discussed, as National is no longer providing the one we used to use.

• **Voter:** The *Voter* Editor will decide on a case-by-case basis the inclusion of non-League articles. Editor will ask for Board assistance when unsure.

# Water Bond Spending

**Dollars for water: a few billion here, a few billion there—when should we begin to care?**

Proposition 1, the Water Bond Act of 2014, authorized over \$7 billion in bonds for state water supply infrastructure improvements. Projects such as public water system improvements, surface and groundwater storage, water recycling and advanced water treatment technology, drinking water protection, and wastewater treatment were listed in the bond language. Money from the General Fund will be used to pay off the bonds.

California has previously focused on surface storage for water. Two new reservoirs—Sites and Temperance Flat—have been suggested as potential bond-funded projects. Yet, Stanford’s Woods Institute for the Environment has estimated that groundwater storage can provide six times more storage capacity than surface reservoirs for the same amount of money. The two reservoirs

mentioned above “would increase the state’s current surface storage capacity by only 7% at a cost of \$7 billion”; these reservoirs would only augment supply by one percent.

The California Water Commission (a Governor-appointed body) is currently developing the guidelines and regulations that will guide decisions weighing public benefits vs. cost in deciding which projects should be funded and built with the bond money. Given climate change and our ongoing drought—which are likely leading to a permanently drier climate in our region—saving and storing water have even more relevance than ever before.

“One of the most controversial issues [concerning the bond money] will be how to spend the \$2.7 allocated to water storage facilities”, noted Professor Barton (Buzz) Thompson, Stanford. The need

to produce “real and measurable public benefits” will be critical in this process.

Professor Thompson—contributor of a large body of scholarship on environmental issues ranging from the future of endangered species and fisheries to the use of economic techniques for regulating the environment—will join us for a discussion about Prop 1 bond spending and “getting our money’s worth”.

## Panel Discussion

**100% Carbon Free and 50% Renewable Energy starting in April 2017**

In March, 2016, twelve communities in Santa Clara County formed Silicon Valley Clean Energy Authority, a local non-profit public agency that will run a Community Choice Energy (CCE) program. With SVCE, PG&E would continue to provide essential services as a partner, delivering the electricity over existing infrastructure, maintaining the power lines and providing customer service. You will continue to receive your bill from PG&E, but the local non-profit will buy cleaner energy at a lower cost.

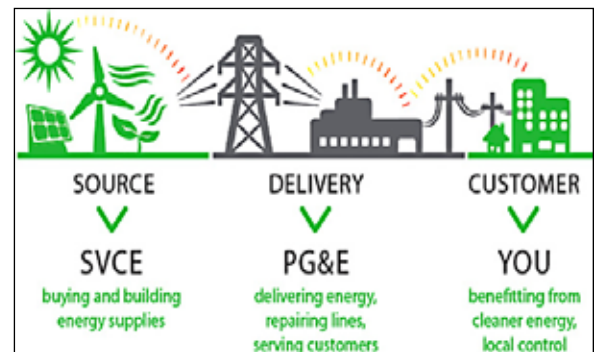
To start, the offer of electricity will be 100% carbon free and 50% renewable. Customers can also choose to have 100% renewable energy at a slight cost premium. In fact, Silicon Valley is already leading the way in installed solar projects and has a great potential to develop even more local renewable energy. In Santa Clara County, electricity consumption is a significant contributor of Greenhouse Gas emissions because most electricity is generated by burning fossil fuels.

Many cities and counties have adopted Community Climate Action Plans which outline different measures to reduce those emissions and prepare for the risks of climate change. For example, Sunnyvale and Cupertino both estimate that joining a CCE will help them achieve 24-54% of their 2020 GHG reduction targets—it’s the single most effective action their communities can take to curb local climate impacts. Community Choice Energy is an opportunity to change the electricity market and provide residents and businesses with a new choice.

Before service launch in 2017, there are a few additional steps SVCE needs to take to engage with the community, ensure compliance with applicable regulations, and provide the best energy product for consumers. When a community decides to create or join a CCE, all customers within that jurisdiction

are automatically enrolled. However, customers can choose to opt-out and remain with or go back to PG&E. In existing programs, 85-90% of customers have chosen to stay with the new local agency as their electricity provider, opting for the cleaner, greener, local choice. This presentation to the LWVSWSCV is part of a significant outreach and engagement where you can learn more about SVCE’s vision, timeline and how it will affect you.

## Vote By Mail: Things to Remember!

Our long awaited November 8 Election Day is just a few days away. When voting by mail, here are some important reminders:

- **Sign your name by the red X**, and then print your address and the date on the back of the return envelope.



If your signature is missing or does not match your voter registration card, your ballot cannot be counted.

- **Return Your Ballot on Time by Mail**  
Ballots returned by mail must be

postmarked on or before Election Day AND must be received no later than three days after Election Day.

- **NO POSTAGE REQUIRED!**

All **Vote by Mail return envelopes are now postage paid**. Ballots that are returned in-person **must be received by 8P.M. on Election Day**. Ballots can be returned at:

## Single-payer Health Care, What Do You Know?

What are the Myths and Lies about Single Payer?

- **Myth** – Single payer leads to rationing, like in Canada.

**Wrong** – Right now in the United States, the private health insurance companies ration care.

If you do not have health insurance, you do not get health care. More than 30 million Americans currently lack health insurance. That is why 120 Americans die every day from lack of health care. There are some problems in the Canadian system, but most of what you hear about long lines is health insurance industry propaganda. Zero people die every day in Canada due to lack of health insurance.

- **Myth** – Costs will skyrocket under single payer.

**Wrong** – Single payer is the only health care reform that will save enough money to insure everyone. By eliminating the health insurance industry we would save \$350 billion a year or more in administrative costs and profits. We would then use that money to insure those who lack insurance and fully cover those who are under-insured. Yes, more people will be seeking health care because they will now have insurance. But they will be taking care of medical problems early, thus preventing more costly treatment later.

- **Myth** – Drugs will be more difficult to get under single payer.

**Wrong** – The drug industry would have you believe that there will be less research

and development under a single payer system. In fact, much medical research is currently funded by the National Institutes of Health. Under single payer, this would grow. Also, drugs will be cheaper under single payer. When all patients are under one system, the payer wields a lot of clout. For example, the Veterans Administration gets a 40% discount on drugs because of its buying power. This single payer buying power is the main reason why other countries' drug prices are lower than ours. Now you know why the drug industry is so opposed to single payer.

## City & Town Council Observers

**Campbell: 9/13/16**– The Pruneyard’s new owner has proposed a 10-year upgrade, including construction of a five-story office building with a two-story underground parking garage facing Campbell Avenue. Two designs for the new office building were presented to the Planning Commission. The Commission recommended the project to the City Council with the modification that new office building designs should be submitted.

Mayor Jason Baker gave the State of the City address on September 22 and proclaimed “The state of the city is really great!” More Campbell residents are employed today than ever before in the history of Campbell. A recent resident satisfaction survey showed that 95% of residents are satisfied with the city’s quality of life. The affordable housing and homelessness in the entire region continues to be a crisis, however. Current housing developments under construction will have 30 new below-market-rate housing units in Campbell—11 will be for low and very low-income families.

**Los Gatos: 9/27/16**  
- After discussion, Council members each contributed a wish list of changes to the North 40 Specific Plan for the General Plan Committee to consider on 10/27/16.

**10/4/16** - The Council rejected town staff’s proposed changes to the current parking requirements for restaurants. It will remain: 1 parking space/300 sq. ft of restaurant space; per 4 dining seats; per 3 seats in restaurant with a bar.

**10/18/16** - Staff were authorized by the Council to contract for litigation defense. North 40 developers, Grosvenor USA, Summerhill Homes, & Eden Housing, filed civil lawsuit against Los Gatos, on 10/6/16, for rejecting its plan for phase I development of the North 40 property. Legal fees per contract are not to exceed \$100,000.

Council discussed the town-owned Dittos Lane property which was previously purchased with redevelopment funds and not successfully developed due to easement and density issues. The Town Manager is directed to seek sale of property.

**Monte Sereno: No Report**  
Observer Needed



**Saratoga: 9/21/16**– The Council adopted a resolution authorizing the Bainter Avenue Retaining Wall improvement project, transferring money from the Hillside Stability Reserve to fund the project. The design contract with Cotton, Shires & Associates, Inc. was approved with authorized personnel to approve any change orders up to \$3000. This project will repair and reinforce a retaining wall which was affected by a landslide during the winter of 2015.

**10/5/16** – The Council announced a neighborhood Watch meeting for mid October 5. The City Council and Sheriff’s Office will give tips and present success stories by fellow residents.

Approval was given to a work plan for the overall needs assessment on future transportation solutions and a senior taxi pilot program. The plan could help the city when applying for Measure B funds. Included in the assessment will be public transportation ridership and routes, bicycle, sidewalk gaps and pedestrian needs.

An October 15 all-day workshop on the tree mortality problem in the Sierra Nevada was announced by Dr. Richard Harris. The workshop addresses landowners who have dead trees on their property interested in learning more about the issues facing the trees in Santa Clara County.

## Climate Change Update: Presidential Politics and Related News

The past few months were noteworthy because of many news items that are related to climate change such as extreme weather, intense forest fires and the ratification of the Paris Accord. It was also noteworthy for the near lack of mention of climate change in the presidential debates. Here is a related excerpt about the second debate from the *Washington Post*, October 9, 2016: "...climate change, the issue on which future civilization hinges, (had) a slim chance of securing some representation in the 100-minute proceedings. Toward the end there, however, a guy named Ken stood up and posed this inquiry: What steps will your energy policy take to meet our energy needs, while at the same time remaining environmentally friendly and minimizing job loss for fossil power plant workers?"

Was that a climate change question? Of course not. Here's a climate change question: "As president, what are the

steps you will take to address climate change?" As it turns out, that was the fourth-most popular question submitted to the Open Debate Coalition, behind questions about background checks for gun sales, the Second Amendment and Social Security.

**Here's a case of the most critical sort of media bias — bias against a complex and important issue that involves... science... hard-to-check facts... and every living organism."**

Here is where I'd like to editorialize... why are the hard questions not being asked? And why are our candidates not addressing one of the biggest threats to our environment, economy and security? Are we so afraid of alienating the climate change skeptics that we will silently allow our societies to continue on the path to eventual environmental catastrophe? Let your voices be heard! The clock is ticking... tic... tic... tic...!

The National Geographic Channel will present its latest episode of *Before the Flood* by Academy Award winning filmmaker Fisher Stevens and actor and environmental activist Leonardo Di Caprio. It will present a riveting account of the dramatic changes now occurring around the world due to climate change and will initially air on October 30, 9:00P.M. PST... And if you miss it I'm sure it can be viewed by googling the title.

On a local note, Silicon Valley Clean Energy, a community based agency that will provide clean energy at a lower cost, will have a panel discussion on enrollment options that begin April 2017. It will be held at the Campbell City Council Chambers on November 12, 16 and is being hosted by LWV Southwest Santa Clara County.

Sharon Graham reported on the French view of democracy in America from the days of Alexis de Tocqueville in 1831 to today—how the French see democracy not just as a political system but also as a social state. deTocqueville was impressed with the openness of American society, with government not available to just a few at the top.

Anne Stewart asked if we should have a Bill of Rights related to the Internet needed for the consumers of e-mail? Evidently, we are the only major country

who doesn't have this, but some say it would hurt companies and innovation. A discussion took place about Edward Snowden and the new film about his actions relative to the NSA.

Pat White quoted pollsters saying that if only women voted, Clinton would win; and if only men voted, Trump would win in the swing states. Some Trump supporters are suggesting repeal of the 19th Amendment, which gave women the right to vote. Nate Silver, noted pollster, says that Clinton will win by a landslide.

Cherri Nelson reported on an interesting article on gerrymandering. There is a battle within the Republican Party itself between the hardcore right and the moderate Republicans. The current problems have led to extremists taking over the party. What California did to correct gerrymandering needs to be done in the rest of the nation.

Dale Hill talked about Governor Brown's "By Right" housing plan which didn't pass in the Legislature but merits another

try. Cost was one factor. The concept was that if plans come in and measure up to requirements, the housing should have a right to be built. The labor and environmental groups were standing in the way, and the Legislature was not willing to break ranks. 80% report concern about low-income people, but NIMBY is a strong factor in solving the problem.

Ann Roberts discussed the last article, which was from Time Magazine on the value of exercise. It pointed out how Americans are exercising less and some not at all, with children not playing outside because their parents are afraid to let them out. PE is coming back into elementary schools, but lack of exercise is a national problem. We treat professional athletes as our big heroes but don't do anything ourselves.

# Great Decisions 2017

## It's time to sign up for the Great Decisions 2017 program.

Anyone can participate! Discuss the eight most critical issues facing America this year. Organized by the Foreign Policy Association, read further details at [www.fpa.org/great\\_decisions](http://www.fpa.org/great_decisions).

Locally the program is sponsored by the League of Women Voters of Southwest Santa Clara Valley, The American Association of University Women Los Gatos-Saratoga Branch, the Saratoga Area Senior Coordinating Council (SASCC) and the Saratoga Retirement Community (SRC). The 2017 program is expected to function with two groups, as it did in previous years.

**Group One** is expecting to enroll about forty members. As in past years each of the **Group One** sessions will begin in the SASCC's Oak Room, which is a modular classroom. That initial assembly is for viewing a DVD, provided by the FPA, pertaining to each session's scheduled topic. Half of **Group One** then adjourns

to the Magnolia room. Separating into the two sub-groups facilitates greater individual participation in discussions. **Group Two** which meets in the Saratoga Retirement Community's Barnes Hall is expected to attract about 20 participants and will function in 2017 as it did in 2016. Both **Groups One & Two** will hold their first study session on February 2, 2017. As in past years, **Group One** will meet from 1-3P.M. on the first and third Thursday of each month. **Group Two's** participants will hold their first study session at 2P.M. in the SRC's Barnes Hall, also on February 2, the same day as **Group One**. It will then meet weekly thereafter from 2 - 4P.M. in Barnes Hall.

For **Group One** only, Course materials will be distributed at a planning session beginning at 1P.M. on January 26, 2017, in the SASCC Oak Room. The 2017 regular sessions which begin for **both groups** on February 2 will be dealing with the following topics:

- 1) EU, 2) Trade, 3) China
- 4) Gulf Cooperation Council/Saudi Arabia
- 5) Geopolitics of Energy
- 6) Latin America
- 7) Afghanistan/Pakistan
- 8) Nuclear Security.

The registration fee for Great Decisions 2017 is \$35 for an individual and \$45 for a couple sharing a workbook. Everyone desiring to participate is urged to sign up as soon as possible. The absolute sign-up deadline is November 30, 2016, to insure that course materials are received in time for the start of the local program.
