## LWVUS: STATEMENT ON RACIAL EQUALITY: June 27, 2020

The League of Women Voters of the United States advocates against systemic racism within the justice system and, at a minimum, for preventing excessive use of force and brutality by law enforcement. The following resolutions were passed and adopted at the LWVUS 2020 National Convention:

We Resolve First, That the League advocates against systemic racism in the justice system and, at a minimum, for preventing excessive force and brutality by law enforcement. We also call for prompt actions by all League members to advocate within every level of government to eradicate systemic racism and the harm that it causes;

We Resolve Second, That the League help our elected officials and all Americans recognize these truths to be self-evident; that Black, Indigenous and all people of color (BIPOC) deserve equal protection under the law; and that we demand solutions for the terrible wrongs done, so that regardless of race, ethnicity, religion, disability, and gender identity or sexual orientation we may truly become a nation "indivisible, with liberty and justice for all."

### MEET THE LWVUS NEW PRESIDENT

At the League's 54th National Convention (conducted virtually), delegates representing Leagues throughout the United States elected Dr. Deborah Turner, MD, JD, as the new LWVUS president. Dr. Turner is the 20<sup>th</sup> President of the League of Women Voters of the United States (LWVUS) and chair of the Board of Trustees of the League of Women Voters Education Fund (LWVEF). She will serve until June 2022. Dr. Turner was president of Des Moines Metropolitan League and vice president of the LWV Iowa board from 2011 until 2015. She was elected to

the League's national board of directors in 2016 where she served on the Finance and Governance Committees and chaired the Diversity, Equity, and Inclusion (DEI) Committee. As chair of the DEI Committee, Deborah and her colleagues focused on organizational culture changes to the League's mission work. They emphasized racial equity as well as equity for all the diverse groups in American society. Dr. Turner lives in Nebraska and has two grown children—a son and a niece.

# CANDIDATE FORUMS AND PROS & CONS

## SAFE, CLEAN WATER—PARCEL TAX

On July 21, the Santa Clara Valley Water District (SCVWD, Valley Water) Board of Directors voted unanimously to put a parcel tax measure (Safe, Clean Water) on the November ballot, with no provision for a sunset clause. The new tax would continue "until ended by voters," indefinitely extending a current parcel tax by the same name that still has eight years to run. The Leagues of Women Voters of Santa Clara County (LWVCC) requested that a sunset clause be included, in keeping with longstanding League policies.

The Safe, Clean Water tax is being promoted as a "community-preferred" program, incorporating six community "priorities." Yet, the fourth highest-ranking category in SCVWD community surveys—"building sustainable, locally controlled water supply projects that are drought resilient"—is not included. LWVCC has asked that this important category be included among the program's priorities.

Neither of the LWVCC's requests appears in the ballot measure. The LWVCC's request is available on our League's Google Drive site, under LWVSWSCV>Committee>Natural Resources>LWVCC re Safe Clean Water item and also on the LWVSCC Google Drive.

## **COVID-19 & THE NEED FOR HEALTH CARE REFORM**

The Covid-19 pandemic has brought into sharp focus the need for health care reforms that promote universal access to affordable care. Although all aspects of U.S. health care will face incredible challenges in the coming months, the patchwork way we govern and pay for health care is unraveling in this time of crisis, leaving millions of people vulnerable and requiring swift, coordinated political action to ensure access to affordable care. About half of Americans receive health coverage through their employer, and with record numbers filing for unemployment insurance, millions find themselves without health insurance in the midst of the largest pandemic in a century. Even those who maintain insurance coverage may find care unaffordable.

## CITY & TOWN COUNCIL OBSERVERS

**Campbell:** July 7 – The City Council moved unanimously to allow downtown restaurants to use the public street on Campbell Avenue between the light rail and Third Street for setting up outdoor dining, thereby giving them a chance to

increase their business by seating more patrons. The cross streets will remain open (First, Second and Third Street). This will be a 30-day trial, with review as needed. Staff is looking into ways to make sure traffic can be physically kept out of the dining area with barriers that are fillable with water or sand, while also making sure there is access for emergency vehicles. Los Gatos: July – Council members held several public meetings in recent weeks, utilizing the Zoom platform. Adjustments were made to the proposed, and later approved, fiscal year 2020-21 budget. Revenue is less from sales tax, transient occupancy tax (hotel tax), and business license tax, due to COVID-19 restrictions. Previous actions which help Los Gatos continue funding priorities include the voter-approved 1/8 cent sales tax, property taxes from recently annexed properties, sales of excess town-owned properties, and grants. Council members heard from the Chamber of Commerce and multiple business owners. They then approved reallocating \$1.9 million of town funds to support the Community Vitality and Economic Recovery Initiative. South Santa Cruz Avenue and parts of Main Street are affected. Businesses will be allowed to utilize outdoor space as street parking is eliminated and parklets are built. Curbside pick-up spaces will be designated. Town staff will streamline approval of business permits.

**Monte Sereno:** July – The Council noted strong financial reserves and a stable fiscal budget despite Covid 19 pandemic. The Council adopted five goals for the year that included quality public service, community character, enhanced mobility, community, safety and environmental sustainability.

**Saratoga:** July – Saratoga City Council agenda reported aterm-limit proposal to be placed on the November 3, 2020, ballot. Also on the ballot would be filling a vacancy on the Council. Passed was a modified regulation to permit tree removal to reduce risks from wildfires. Staff reported stable fiscal outlook for the yearly budget as impacted by COVID-19 with reductions in revenue and planned reduction in spending and reserve funds offsetting need to reduce services for the public.
