Message from the LWVSWSCV Presidents

The fall calendar is heavy with League events celebrating the passage of the 19th Amendment (recognizing women's right to vote), the upcoming 100th anniversary of the League of Women Voters (LWV) in 2020, and LWV's longstanding fight for voter access, engagement and equality.

Yet, let us pause to grieve for the victims in Gilroy and El Paso. Commenting on gun violence, LWVUS president Chris Carson noted these events were the latest in a long series of bloodlettings that Americans have endured. As much as we feel outrage, we need to continue to work for legislation that promotes gun safety. President Carson felt this was really about voting rights. Those who become victims—and their families—have not always been able to vote. Until voting

barriers are eliminated, it is difficult to pass legislation that makes a difference.

The LWV defends the right of every American citizen to vote. League—at the national, state, regional, county and local levels—also continues outreach on issues of gun violence, voter rights, gerrymandering, environmental justice and women's equality and rights.

We continue here our summary of LWVUS Impact Issues 2018-2020 that we began last month. Social Policy represents one of the four pillars of these policies. The goal is to secure equal rights and equal opportunity for all and to promote social and economic justice and health and safety for all Americans.

1. Equality of Opportunity: support the ratification of the Equal Rights Amendment and support equal rights for all under state and federal law regardless of race, color, gender, religion,

national origin, age, sexual orientation or disability.

2. Fiscal Policy: support adequate and flexible government funding through an equitable tax system that is progressive and broad-based; support federal role in old-age, survivors', disability and health insurance.
3. Health Care: promote a health care system that provides affordable access to a basic level of quality care, including behavioral health, for all US residents that is integrated with and achieves parity with physical health care system.
4. Immigration: promote reunification of immediate families, meet economic and business needs of the US, be responsive to those facing persecution; ensure fair treatment under the law.

On August 15, "the American Medical Association—the largest association of doctors and medical students in the United States—took a big step towards dropping their decades-long opposition to single payer. The Association announced that it is leaving the Partnership for America's Health Care Future—a coalition of lobbyists from the insurance, pharmaceutical, and for-profit hospital companies—whose sole purpose is to fight Medicare for All."

City & Town Council Observers

Campbell: Camping and Storage Code Amendment: The Council has been presented with a proposed text amendment to update the city code about sleeping in cars and camping in public places. The amendment would define the word "camping" and restrict where it is allowed and would outline enforcement procedures.

Two churches in Campbell are participating in a county-sponsored program that allows people to camp in their cars in the parking lots at night. The Council discussed the proposed amendment and asked staff to incorporate some changes to the amendment that would address RVs parked on streets for long periods and unintended consequences of an ordinance that is too strict.

Green Stormwater Infrastructure Plan: One of the new requirements of the Municipal Regional Stormwater Permit (MRP) is that each of its municipalities and agencies develop and implement a Green Stormwater Infrastructure Plan, to reduce the amount

of untreated runoff that goes directly into creeks and storm drains. To clean pollutants from runoff water, the water needs to first be diverted to the ground with several ways to achieve this.

The Council has heard a presentation on the city's new plan which will be submitted to the Regional Water Quality Control Board in September. It contains criteria for choosing and developing public and private projects. They voted to approve the plan.

Los Gatos: Council members approved rezoning a property located at the corner of Shannon Rd and Los Gatos Blvd to allow for construction of a commercial building. The developer's proposal for a 2-story building there includes revision of the streets' intersection to include safety measures in accordance with Safe Routes to School's Plan. The developer will pay for these safety improvements, which

are estimated to cost up to one million dollars. This saves the town from having to budget for this. The intersection is crossed by numerous students attending Van Meter Elementary and Fisher Middle schools. A previous proposal to build high-density housing on the property had failed to gain town approval and community residents had objected to it.

LWVUS: People-Powered Fair Maps Campaign

The League of Women Voters of the United States will be leading a national 50-state redistricting campaign focused on creating fair political maps nationwide—the People-Powered Fair Maps Campaign. Although California is in much better shape than many states, we'll be part of this effort.

The June 27, 2019, decision by the United States Supreme Court in three partisan gerrymandering cases (including *Rucho v. League of Women Voters of North Carolina*) was a call to action for the League of Women Voters. When the court

decided to take a hands-off approach to redistricting, the League decided to jump into a People-Powered Fair Maps Campaign to ensure fair representation across the country.

Because the Supreme Court has said they won't hear any more of these cases, state legislators have a green light to continue the undemocratic process of political party-based voting maps that silences voters. We don't have an equal playing field when it comes to election maps across the country, and the redistricting process set to begin in 2021 is in danger. We do not have to rely on the Supreme Court to solve partisan gerrymandering.

The LWV campaign includes:

- Education/Advocacy
- Organizing and Mobilizing
- Partnership Building

- Ballot Initiatives/Referendums
- State Constitutional Option/Litigation
- Federal Legislative Fixes

The League will ensure that there is an opportunity to restore the Voting Rights Act prior to the redistricting cycle in 2021. The pending Voting Rights Advancement Act modernizes the 1965 Voting Rights Act.

The national board authorized half a million dollars to launch this campaign, and every state League will receive some of that funding through grants. This work will look different in each state, and the campaign will be unveiled in the Tele-Town Hall.

Registrar of Voters: EAP Hearing

Public Hearing on the Draft Plan for the Administration of Elections Conducted Pursuant to the Voter's Choice Act

September 4 • 6-8:00 P.M.

The Santa Clara County Registrar of Voters (ROV) invites anyone interested to provide input on the County's draft Election Administration Plan (EAP) related to the Voter's Choice Act (VCA). The purpose of the hearing is to provide a forum for public input on the Plan.

The VCA introduces a new elections model where voters can choose how, when, and where they cast their ballot. Voters may choose to mail in their ballot, drop it off at any secure ballot drop-box location, or vote in person at any Vote Center in the county. Ballots may be

mailed or dropped off in a drop-box as soon as they are received, while Vote Centers will be available to voters for up to 10 days prior to Election Day and including Election Day.

The EAP is the formal plan for the implementation of VCA. Throughout June and July, the ROV collaborated with Santa Clara County residents through several consultation meetings regarding the new election model to consider input and feedback on how Santa Clara County can make the transition smooth and effective for its diverse community members. The ROV received valuable input from residents who primarily speak a language other than English, seniors and disabled voters, as well as the general public. Upon

consideration of the input received at the meetings, the ROV created a draft plan of the EAP, which will be discussed at the public hearing at the September meeting after which the final plan will be released by the County of Santa Clara.

Natural Resources: Climate Change, Toxic Algae and Canine Alert

The League of Women Voters of California (LWVC) recognizes that climate change has reached the level of an emergency. LWVC has been at the forefront of the climate effort, and now recognizes climate change as a key area for action to protect not only our planet, but also our democracy.

The League of Women Voters of the U.S. lobbied vigorously in the late 2000s for comprehensive legislation to control global climate change by setting a cap on greenhouse gas pollution and by encouraging conservation and renewable energy (<https://lwvc.org/news/league-women-voters-california-stands-youth-fight-climate-emergency>).

With climate change “the defining issue of our time”, according to a recent United Nations report, come associated threats to food production, rising sea levels, increased threats of flooding and drought, diminishing snow levels, warming oceans—along with a lack of fresh water that is causing crises around the world.

Global warming also brings problems such as toxic algae blooms, which have been popping up in California and worldwide. Warm temperatures, nutrients from runoff (urban/agricultural/septic), and slow-moving water are the major contributors to the problem.

What makes them such a problem? Cyanobacteria in the harmful algal blooms (HABs) create cyanotoxins that, through contact with the water, can cause “eye irritation, allergic skin rash, mouth ulcers, vomiting, diarrhea, and cold- and flu-like symptoms. Pets can be especially susceptible because they tend to drink while in the water and lick their fur afterwards”, according to the California Department of Water Resources (DWR). Dogs have been known to get sick or die suddenly after swallowing contaminated water or licking it from their fur. There were 18 cyanotoxin-related dog deaths in 2017, according to California officials (https://mywaterquality.ca.gov/habs/resources/domestic_animals.html).

This year, DWR has issued “danger” warnings at least twice, telling people to avoid physical contact with the water at San Luis Reservoir because of toxic blue-green algae. (Incidentally, San Luis Reservoir is where Santa Clara Valley Water District stores some of its imported water.)

The Centers for Disease Control and Prevention (CDC) cautions that these HABs may be impossible to see, although the cyanobacteria can produce visible “foam, scum, or mats”; the blooms can be “blue, bright green, brown or red. Blooms can sometimes look like paint floating on the water’s surface. As cyanobacteria in a bloom die, the water may smell bad, similar to rotting plants.” www.cdc.gov/habs/pdf/cyanobacteria_faq.pdf. The CDC recommends that people report any “musty” smell or taste in their drinking water to their local water utility.

The League of Women Voters of California recognizes that climate change has reached the level of an emergency. “Our California LWV passed a resolution unanimously at our June, 2019 Convention to declare a climate emergency. Similar Climate Emergency Declarations also passed at state League Conventions in Oregon, Florida, Massachusetts, Illinois, and Colorado. It’s time for all hands on deck!”

As LWVBAE has pointed out, the two key challenges for California are sea level rise and changing weather patterns, the latter influencing drought, stronger storms, and agricultural disruptions. One meter of sea level rise—very probable by 2100—will flood almost to Manteca, encroach on major transportation routes, and impact many of the Bay’s sewage treatment facilities.
