HEALTHCARE COMMITTEE: ANTI-RACIST PROJECT:

The Healthcare Committee has also proposed that our League, along with the other four (4) Leagues in Santa Clara County, support efforts to have our Santa Clara County Board of Supervisors publish a proclamation declaring racism as a public health crisis. Leagues in Contra Costa County, California and in Manatee County,

Florida, have both gotten their local Boards of Supervisors to publish such a proclamation! On November 11, the American Medical Association House of Delegates (HOD) adopted a new policy to "acknowledge that, although the primary drivers of racial health inequity are systemic and structural racism, racism and unconscious bias within medical research and health care delivery have caused and continue to cause harm to marginalized communities as a whole." Other provisions further recognize racism as a serious threat to public health, to the advancement of health equity, and a barrier to appropriate medical care. The LWVUS Social Policy Position on Justice supports: "Secure equal rights and equal opportunity for all. Promote social and economic justice and the health and safety of all Americans. " And the LWVUS Adopted A Resolution for Racial Justice at the LWVUS Convention, which can be read in its entirety on our website. (Barbara Lea)

NATURAL RESOURES:

The future of natural resources in the United States has changed as a result of the recent presidential election. Policies of the president-elect, as well as newly-selected cabinet members, will promote reduction of greenhouse gases (GHGs) and other activities in an aim to bring us back from the brink of no-return climate change. The United States will rejoin the Paris Agreement on global warming, a 2015 agreement signed by 194 countries meant to combat climate change—but from which the US withdrew on Nov. 4, 2020. New policies that recognize—and actions that reduce—air and water pollution will help address long-standing problems that have particularly afflicted Black and Latino communities. The pledge to conserve 30 percent of America's lands and waters by 2030 will help protect biodiversity, slow extinction rates and help promote natural climate solutions. And, in a nod to California, which has been a leader in setting and meeting environmental goals, Mary Nichols, the 13-year head of California's Air Resources Board, will lead the federal Environmental Protection Agency. The new year may bring us better news. (Meg Giberson)



CITY & TOWN COUNCIL OBSERVERS

Campbell - November 24, 2020, Jackie Costanzo, Observer

General Plan: Information provided by City Councilwoman Liz Gibbons.

The **General Plan Process** continues to evaluate and recommend changes to land use designations and densities. The draft GP identified additional parcels and increased density in some locations to 45 units per acre vs the current 27 units per acre.

As the draft documents have become available, **Campbell's Regional Housing Needs Allocation (RHNA)** has changed. In Cycle 5 it is 633 units; but when the Housing Element updates to Cycle 6, which will start mid-2021, it will be 3,964 units. Therefore, the Council is reviewing the pros and cons of the draft land use map.

There are currently at least three mixed-use projects being proposed. Typically, they require a zoning change. Recently a 25-unit housing project was approved with a 20% Density Bonus requiring two "very low" Below Market Rate (BMRs) and 15% Inclusionary Affordable (BMRs) units.

Street Closure: Campbell's complete downtown street closure has been replaced with parklets allowing parking for business/retail customers.

Farmers' Market: Campbell's Farmers' Market has reopened on Sundays from 9:00 to 1:00 but is being held at the Campbell Community Center parking lot. Masks and social distancing are required.

Los Gatos – November 25, 2020, Lynda Jandron, Observer

Council members approved three police department reforms. First, the role of an independent police auditor will be established. The police auditor will have a background in law and/or policing. The police auditor will respond to all individual citizen concerns regarding police actions and report findings to the town's attorney. Second, Santa Clara County will continue to respond to mental health and homeless calls for service in Los Gatos. Third, data on police stops will be made available in a timely manner for public review. Community members and Town staff have been developing the Los Gatos General Plan 2040. Council members were asked to provide direction regarding land use and housing development. Challenges identified: limited large-scale employers, most residents commute for work; limited open space for development; developers expected monetary return on projects. Recommendations: increase public transportation modes; increase number of multifamily housing units; raise height limits of multifamily housing units; increase number of rental units; increase number of accessory dwelling units. Council members amended and broadened the belowmarket-price housing program

BOARD BYTES: November 4, 2020

The following items were discussed:

- 1. The quarterly Treasurer's Report was accepted.
- 2. The results of the election and, in particular, Propositions 15 and 16 as well as Measures S, A, and B. Concerns were expressed about how much money is spent on campaigning and passage of propositions.
- 3. The lack of sunset clauses in many propositions is also a concern.
- 4. Membership status: 102, including 78 individuals and 34 households.
- 5. Member Planet Database was discussed re:pros and cons of our usage. We will examine other options.
- 6. Candidate Forums and Pros and Cons were extremely successful and will be conducted in this manner going forward we reached many more people because it was more convenient and could be viewed online after the event.
- 7. The first Chinese version of Pros and Cons was an extremely successful undertaking and sets the bar for excellence in the future. Over 500 attended the live presentations and over 1900 viewed online.
- 8. Member Engagement during Covid-19: a member survey will be sent out requesting feedback on program ideas to pursue.
- 9. Health Committee: Medicare for All is not supported by Pres elect Biden but the issue of access to affordable healthcare is even more important now during the pandemic.
- 10. Meg reported that with the passage of Measure S, the SC Valley Water District might be able to secure funds to support the proposed Delta Tunnel project. This need to be watched carefully.
- 11. Next Zoom Board Meeting: Wednesday, Dec. 2, 2020.
