# LWVSC Holiday Fling


On December 10, LWVSC members and guests attended our annual Holiday Fling to celebrate the season and enjoy nibbles and conversation. Our special guest for the event this year was Daren Williams, Communications Director for the Almond Board. Daren's presentation was "Holodomor 1932-33: Through the Eyes of Ukrainian Airtists."

Daren's father, Morgan Williams, worked in Ukraine beginning in the 1990s, and he learned about the Holodomor then. The Soviet regime under Stalin systematically set out to starve the Ukrainian people by not allowing them to harvest their own crops, either for their own sustenance or to sell. Also known as the Ukrainian famine, this massive man-made famine killed millions of Ukrainians from 1932 to 1933.

As he learned more about the Holodomor, which means, "death inflicted by starvation," Morgan Williams began to collect artworks related to the era and commission more art to be made. It became the world's largest collected of Holodomor-related art and was donated to the Holodomor Museum in Kyiv, Ukraine.

Daren shared the story of the Holodomor with us, showing images of his father's collection. This moving presentation prompted much discussion throughout the evening.

LWVSC appreciates Daren's time and informational presentation.



# Modesto General Plan 2050 Meeting Recap

In mid-December, the city of Modesto hosted three meetings for public input on the next phase of Modesto 2050, the current general plan update process they are navigating. Five members of the LWVSC Board of Directors attended the third and final meeting to gain insight and perspective into the planning process.

Staff provided an overview of their work to date and unveiled the three land use alternatives that have been developed for review and consideration. Their presentation offered perspective around how the community has changed since the last update in 1995 and why they believe growth is important into the future. In addition, information was shared on how the city has navigated living within it's existing sphere of influence and how those efforts, while successful, will not be sufficient moving forward.

The three land use alternatives, named Competitive Regional Hub Alternative, Emerging Economic Opportunity Alternative, and Minimal Economic Opportunity Alternative, focus on growing the city's limits in the north, west, and to a lesser extent, the east. As was requested by staff, Board members in attendance provided feedback by way of questions focused on what we saw as the most glaring issues not addressed. We felt details were lacking specific to the transportation impact all the alternatives pose, how growth will comply with state groundwater regulations, and the impact to economically disadvantaged communities. In addition, we noted our disappointment in the naming of the alternatives, which we believe reflect bias and are in poor form.

At our January meeting, the Board of Directors will be discussing our collective next steps to provide more thoughtful, detailed, and robust comments when that period is made available in Spring 2026. Be on the lookout for dedicated communication and action specific to these next steps.

## You have two options for your donation

## You have two donation categories

### 1. **The General Fund:**

- Our General Fund supports everything we do, but because of IRS rules, donations to this fund are **NOT** tax deductible.

### 2. **The Education Fund (Local Impact Fund):**

- Nonpartisan voter information and activities including Candidate Forums and Ballot measure Pros/Cons, Voter Guides, and “Your Elected Official” contact lists
- Building citizen participation in the democratic process including voter registration event and youth outreach

If tax deductibility of your donation is important for you, consider donating through the mechanism of the Education Fund, administered for us by the California State League of Women Voters. The Education Fund is a nonprofit, nonpartisan, public policy educational organization used to conduct voter service and citizen education activities. By IRS rules, donations to this fund can **only** be used for above mentioned activities.

*Donations to our LWVSC Education Fund are received and managed by the **League of Women Voters of California Education Fund (LWVCEF)**, a 501(c) 3 corporation and are fully tax-deductible where allowed by law.*


