LWVSC Board Meeting Highlights August 2024

The LWVSC Board of Directors met on August 10, 2024, to conduct its regular business. Highlights are as follows:

- Education Fund (Ed Fund) donations will now be directed to a new website dedicated to Ed Fund donations. Payments to the Ed Fund must be made directly to the Ed Fund (not LWVSC) to be tax deductible. The new Ed Fund website is expected to be complete before the Finance Drive. This change is being implemented by all LWVUS.
- Vivian Lopez and Ellen Meyer attended the national LWV convention in Washington, D.C., and Laurie Carley attended virtually. Presentations included topics on engaging young voters, LWV collaboration with the Girl Scouts, abolishment of the electoral college, and DC statehood.
- The LWVSC advertisements are running at the Galaxy Theaters in Riverbank through October. The advertisements promote voter registration and voting.
- The Board discussed the need to recruit new members and increase member engagement. More meetings will return to in-person meetings, and Meet and Learns will alternate between in-person and Zoom meetings. Ideas to increase membership and engagement are welcome.

It was a privilege to attend the LWVUS 2024 National Convention in Washington DC.

I attended the 2008 LWVUS National Convention in Portland and times have changed! The League members attending both the 2008 and 2024 conventions were passionate and very vocal about our concerns, of course, but this year's was very exciting. Our membership has changed! League's membership includes more young women and men under thirty from different walks of life. They are very knowledgeable and energetic individuals with concerns about saving our democracy. It was a joy to see that these individuals found the League to be the place to be involved and take action.

The speakers at the event were excellent! DC Mayor Muriel Bowser expressed her support and appreciation for the work LWVUS has done backing legislation for DC statehood. The keynote speaker was Delegate Kim Teehee who is the director of government relations for the Cherokee Nation. She is a Cherokee attorney, politician, and activist on Native American issues. She is a Delegate-designate to the House of Representatives from the Cherokee Nation. She served as

She talked about the history of the Cherokee people and how women are the driving force in their nation. VERIFY IT - The Youth Outreach Service Committee of the League of Women Voters Alameda has created a free, fun and informative online game. It was developed to address media literacy and voting knowledge, and to encourage civic engagement. River Walk Update

Attended 2 meetings

- June 2nd at the Walton home
 - Review of comments on EIR (animal & plant species, Native American land near the river, several instructors from UC Davis weighed in on EIR.
 - Comment period was extended due to Spanish draft not available. Several people at this meeting made sure that Spanish comments were sent in.
 - Plans for another an initiative.
- July 6 at the Riverbank Rifle Range
 - Signature drive has begun. Utilizing committee, and paid signature gathers.
 - Additional yard signs.
- The Ballot Initiative signatures were turned in to Riverbank on July 24th. They needed 1,316 valid signatures and we got 1,542 so we exceeded our goal (15% over, or 1,513).
 - Riverbank has requested a "full count" meaning each signature will be examined by the County Registrar of Voters office (vs. the random process allowed by the Election Code).
 - They have 30 working days to complete this so we should hear the results by Sept. 5th. Confident that they will qualify for the ballot this time.
- The fraud matter from last year's attempt to make the ballot is currently being investigated by the District Attorney's office.
- Two matters that are very closely related to our NO River Walk efforts are the City's updates of their Housing Element and General Plan. The Housing Element, which becomes part of the City's General Plan, is CURRENTLY being updated for the next 8-year cycle (2023-2031) and will move forward at a pretty rapid rate. Specifically, the City held a Public Workshop on July 31st.
- They also hope to take it to the PlanningCommission in Sept and the Council in October. Why is this important? -The General Plan currently covers the period of 2005-2025 so it will also have to be updated and bears close watching when that process begins.

If Stanislaus County intends to remain one of America's top 10 ag producing counties, it must protect its prime farmland. If our cities accommodate growth by incrementally expanding their borders, Stanislaus County is destined to follow the path of Los Angeles County — it will become a commuter county with traffic congestion, crime, unaffordable housing and all the costs associated with

unsustainable growth (with the caveat that Los Angeles County was the nation's most productive agricultural county for 45 years, until 1955). Each of the county's nine cities needs to accommodate growth by building up, repurposing underutilized and blighted areas, infilling and putting development on the poorest soils. Stanislaus County already has plans to develop 88,558 acres within its cities and their general plans. There are hundreds of acres available for housing within Riverbank's Sphere of Influence. Stanislaus County's formal response to the proposed River Walk project states, "It's premature and does not maintain a logical land-use pattern." Simply stated, Riverbank lacks a justifiable reason to further expand its borders.

Scannell Project

Dale Road North of Kaiser Facility and West to 99 Freeway

July 2024

Stanislaus County is proposing an environmental impact report on the entire Salida Community Plan before a large distribution center project on Kiernan Avenue is allowed to proceed.

August 13th, the county Board of Supervisors was set to approve a \$900,000 agreement with Sacramento-based Ascent Environmental Inc. to conduct a comprehensive environmental study on the 3,400-acre Salida development plan, which received county approval amid controversy in 2007.

The <u>Sacramento firm also would</u> perform a feasibility study on city incorporation of Salida.

The studies <u>would create</u> a 15-month delay for Scannell Properties' 145-acre development, which calls for up to 2.5 million square feet of warehouse, distribution and manufacturing space at the northwest corner of Dale Road and Kiernan, just north of Modesto. In early May, Scannell submitted requests to the county for a general plan amendment and rezoning for the seven industrial buildings.
