## 2020 Annual Meeting in Brief

The following is a brief summary of the topics/discussion points covered at the Woodland LWV annual meeting, held virtually on September 10, 2020. Nineteen members were present, including board members, as well as three guests from the Davis



board members, as well as three guests from the Davis LWV chapter. Actions included the following:

• Treasurer Judy Simas reported that, as of the meeting date, the LWV-W accounts had the following totals: Checking - \$1,910.47; Savings (money

- market) \$2,228.27; CD (which renewed on 7/26/20) \$7,600+.
- As directed by the By-laws, the current League positions were reaffirmed and the 2020/2021 chapter program was presented.
- Carla Cox gave an update on the voter education programs being conducted in coordination with the Davis LWV chapter and the Yolo Board of Elections which have replaced the usual forums in the pandemic era.
- Updates were presented on membership, the housing study and a description of a new director position on the board which will oversee event and coordination of volunteers.
- Several members were recognized: Janet Ruggiero for her selection as Woman of the Year, Carol Souza Cole and Janet Ruggiero for their outstanding work on the LWV Centennial Celebration held this past February, and Karen Urbano received an award on behalf of our chapter presented to the Woodland LWV by the Woodland Joint Unified School District recognizing our efforts in student voter registration.
- The Grace Heffner award was presented by last year's honoree, Lucinda Talkington, to Laura Caruso Kofoid and Eric Kofoid for their many years of tireless work on The Voter. They received mugs and chocolate (virtually, delivered later).
- The slate of candidates for this year's board, compiled by the Election Committee (Carol Souza Cole and Christine Shewmaker, appointed by president Pat Butler), was presented. The slate, which follows, was unanimously approved after no nominations were received from the floor.
  - President Pat Butler; 1st Vice President (Membership) Karen Urbano; 2nd Vice President (Website management and Voter) - Lorna Carriveau; Secretary - Maria Lago; Co-Treasurers - Judy Simas and Evelia Genera;
  - Directors: Events/Volunteers Judy Wohlfrom; Voter Services Carla Cox; Studies/Positions - Janet Ruggiero and Elizabeth Kemper;
  - Directors-at-large: Youth Voter Registration Evelia Genera; YES Liaison Mari Perla.
  - Also announced were two committees: Nominations Audrey Doehne (Chair), Barbara Morrison and Lucinda Talkington; and Finance -Maria Lago (Chair), Daniel Kirsch and Judy Simas.


## **Voter Services Update**

This has been a busy season for us with a presidential election and several open seats on the city council and school board, and due to the pandemic, we've had to take a different approach to voter education as to everything in our lives these days.

 In lieu of our traditional forums, we solicited public input to pose questions to the candidates for city council and WJUSD school board. Their responses were published by the Daily Democrat. Our thanks go to all the committee members who worked hard to develop meaningful and concise questions on a wide range of topics. A big thanks also goes to Jim Smith at the Daily Democrat for his helpfulness and frontpage coverage of the candidates' responses. Our website has links to the five Candidate Q & A articles.

- We distributed Easy Voter Guides in Woodland, West Sacramento, Winters, and smaller towns in northern Yolo county.
- LWV/Voter's Edge yard signs are on display in members' yards around town.

- We partnered with a Davis community group and LWV-Davis to assist the Yolo County Elections Office in putting up posters around the county informing voters about the changes in the voting process this election. Changes include Vote-By-Mail ballots sent to all active registered voters, Ballot Drop Boxes available at 12 locations in the county, and the replacement of traditional polling places around the county with 12 Voter Assistance Centers for voters who want to vote in person, need accommodations or translation assistance, or want to register and cast a provisional ballot.
- We will be putting up notices at the old polling places several days before the election to remind voters that those are closed and providing the hours and locations for the Voter Assistance Centers.

Thank you to everyone who has worked hard to make all of this happen!

#### WE SUPPORT WOODLAND'S MEASURES Y & R

LWV-Woodland's Board of Directors voted "YES" to support City of Woodland's Measure R and Woodland Joint Unified School District's Measure Y at their board meeting last week. Measure R must be approved by a majority of the voters and would continue the one-quarter cent sales tax previously adopted by Woodland voters in 2014 (Measure J) for an additional ten (10) years. Funds would be used for city services, programs and facilities. However, the Council can choose to allocate funds from this tax to voter's preferences gleaned from advisory Measures S, T, U, & V. The City is required to prepare a detailed report of revenue and expenditures for the voters annually.

WJUSD's Measure Y requires a 55% vote and is subject to specific accountability measures for the purpose of construction, reconstruction, rehabilitation or replacement of school facilities, including furnishings, equipment and acquisition or lease of real property for school facilities. Bond proceeds may be used to expand vocational education programs, improve technology/internet access, repair classrooms/school; roofs, HVAC, wiring, plumbing or acquire a variety of instructional, maintenance and operational equipment. The District, though, may only use proceeds for the purposes identified in the Measure and an independent citizens oversight committee is required to insure proceeds are properly expended.

League support for local and county measures must be based on studied positions taken by the local league and/or the California League. For Measure R, the League's position clearly supports the need for local finance measures to meet basic needs of the general population. Additionally, our County Parks & Recreation position calls for financing to maintain and extend adequate services to a growing population. This Measure clearly meets those identified priorities,

Measure Y is supported by the League's position of advocacy for adequate and safe school facilities. The California League's Education K-12 Position clearly

advocates for equitable access to quality education, adequacy of revenue and flexibility of those revenues.

Your Woodland League Board voted unanimously to support these two important Measures as necessary for the stability of our community services and the stability of our schools. The League takes no position on Measures S, T, U & V.

# Housing Position Study Group Update

The Housing Position Study group will meet again on Tuesday, October 27 at 6:30 p.m. via Zoom. We encourage members interested in the Housing issue to join the group as we work



on preparing consensus questions to update our current Local Housing Position for our League.

We will also send you additional information that has been developed during the past meetings of the study group.

Our current LWV-Woodland position written in 1982 states:

Support provision of quality and safe housing for all persons in the community regardless of income or ethnic background.

#### Objectives:

- 1. Encourage the rehabilitation and revitalization of deteriorating housing.
- 2. Support Yolo County's Housing Code enforcement program to eliminate substandard rental housing units within the city.
- 3. Support the City's efforts to apply for and use as many state and federal housing programs as possible to improve and restore existing rental units as well as build new rental units.

Questions that have been raised on our existing housing position include the following:

- Shouldn't policy include support for new construction and the rehabilitation and preservation of quality and older housing for all persons in the community regardless of income, ethnic or racial background.
- Does Woodland have an adequate funding for first time homeownership program?
- Who operates the Housing Code Enforcement program the City or the County? Should there be a rental inspection program?
- Shouldn't we be looking at new rental housing construction as well rehabbing existing units. How do we keep rental housing affordable

Other issues that have come up about our position at other study group meetings, including the League's annual meeting, include:

- Support of infill development, including looking at reduced parking, sustainable and green design especially downtown;
- Need for construction of more rental units including senior units where;
- Housing should be linked to transportation corridors;
- Need for more workforce housing and first-time home buyers;
- Duplexes on corners and smaller homes in the 1300 1500 square foot range;
- Encourage construction on empty lots;
- Encourage different types of housing, accessory dwelling units, co-ops, court yards units, rooming houses; and
- Support for housing the unhoused and providing services for them.

#### The work the Study Group still needs to do follows:

- 1. Do we need more information on housing issues directly related to Woodland?
- 2. We have identified housing questions, ideas and issues. Are there items on housing we are missing?
- 3. Do we break down housing into different categories for the group to work on? Such as Homeownership and affordability, Rental housing, Housing for the Unhoused, Discrimination?
- 4. Develop consensus questions for our members that we can bring to them over the next couple of months.

We need League members to participate in upcoming meetings scheduled for October 27 and December 1. We look forward to seeing you virtually at these meetings. Our intent is to use the next two meetings to determine if any additional research is needed to assist in developing consensus questions that can be brought to our membership in January in order to seek their input on resolving these consensus questions. Based on that input, we will draft a new Housing Position to bring to the Annual Meeting in June 2021 for adoption.
