## ***Steering Committee Report***

February is Black History month, when we reflect on the words of Martin Luther King, Jr. who said "Our lives begin to end the day we become silent about things that matter."

In the current political climate, DEI has been under fire and the word "woke" has been weaponized. What is "woke"? It originated in a blues song in the 1930s, "Stay Woke," warning people to stay alert to injustice. (Google for the song and recent renditions.) Be vigilant, be aware, be awake, be woke. It's important in these times to be woke.

LWVUS issued [THIS STATEMENT](#) on **Federal Immigration Enforcement and Erosion of Constitutional Rights** via their social media accounts and websites. "The League of Women Voters reaffirms that the rights outlined in the Constitution belong to all people, without exception. We will not accept policies or practices that suppress civic participation, weaponize enforcement, or undermine fundamental rights and human dignity."

As a local league we signed on to support LWVUS litigation of the case, [League of Women Voters v. Department of Homeland Security \(DHS\)](#), challenging changes by the federal government to DHS's Systematic Alien Verification for Entitlements (SAVE) system. These changes allow our federal government to abuse its power and access millions of Ameri-

cans' personal information, with several states using these policy changes to harm voters. As a result of our lawsuit, an open comment period was launched by DHS, and another has been opened by the Social Security Administration (SSA). Litigation was filed in the U.S. District Court for the District of Columbia. There was a delay due to the fall government shutdown, there is not yet a scheduled court date. Stay tuned. In the meantime,

### ***“A Civic Moment” Grant***

The Falmouth League of Women Voters has been awarded a \$400 grant from the Lotte Scharfman Memorial Fund to support a new project we are calling “A Civic Moment.”

“A Civic Moment” will be a series of small ads in the *Falmouth Enterprise* that highlight an aspect of civic information or participation in a “Did You Know?” style. For example, one ad might ask: *Name Three Examples of Civic Participation*, with the answers following immediately below:

- *Vote (in local, state, and national elections).*
- *Contact Your Elected Officials.*
- *Write to a Newspaper.*

At the bottom of each ad will be a credit to LWVF with our website. There will be a total of ten ads, which will begin in the next few weeks and run throughout the spring.

The goal of the “Civic Moment” campaign is to heighten public awareness of civics principles, a first step in building grassroots community-based participation in the democratic process. Beyond the ad series, we hope to extend the impact of Civic Moments by reaching out to student newspapers at the local high schools and community college, and radio stations, to offer this same content for their use.

The LWV Lotte Scharfman Memorial Fund is a Massachusetts-based fund that encourages local Leagues to carry out civic education and voter engagement activities. The fund was established in memory of Lotte Scharfman, a

League president who died in 1970 on her 42nd birthday. Lotte Scharfman was a refugee who escaped with her family from Austria during World War II; she devoted her life to working for the democratic process and to helping all people gain access to government. She is widely credited with coining the phrase, “Democracy is not a spectator sport.” Our Falmouth League has received many Scharfman grants for voter education and engagement projects.


## Falmouth Road Race



## Book Review

### *Book and Dagger: How Scholars and Librarians Became the Unlikely Spies of World War II*



How does the United States create an intelligence agency after the bombing of Pearl Harbor? Author Elyse Graham notes that " Pearl Harbor was an intelligence failure." The U.S. had information on the possibilities of an attack, but didn't have the knowledge to interpret this information. An intelligence agency was of immediate importance, even though Secretary of State Henry Stimson declared, in 1929, that "Gentlemen do not read each other's mail," and stopped collecting intelligence "in any comprehensive sense."

William Donovan was tasked with creating an intelligence-gathering agency, which became the Office of Strategic Services (OSS), and eventually the Central Intelligence Agency (CIA). Donovan knew he needed a corps of possible agents who could plow through pages of archives and library documents, and thus pave the way for the invasion of Axis countries.

Harper Collins notes that "... *Book and Dagger* is an inspiring and gripping true story about the academics who helped beat the Nazis — a tale that reveals the indelible power of the humanities to change the world."
