If you've seen recent emails that I've sent, you know that the State League is backing the Voter Not Politicians ballot proposal, and they are part of a lawsuit challenging the current redistricting process in Michigan. Members at the State level are updating the materials we used for redistricting presentations in 2015 so we can continue that educational effort this year.

Check the calendar on the first page of this Voter to get information about meetings that we have scheduled for January and February. We don't meet every month, but there's always a Program Planning meeting in January. This year, we're celebrating the League's 98<sup>th</sup> birthday in February. It's the beginning of a countdown to a big celebration for the League's (and the 19<sup>th</sup> Amendment's) 100<sup>th</sup> birthday in 2020.

There's a National Convention every two years. This year's event will be in Chicago at the end of June. We haven't gotten any details yet, but we should be able to send more than one delegate to this convention. It's always a great time to find out what's going on with the League throughout the country.

We've got voter registration events coming up in the next few weeks. I've already got three speaking engagements scheduled at Schoolcraft and one with the Plymouth Kiwanis Club. If you know of any groups who are interested in learning more about the League, please let me know. We'll see what we can schedule.

Thanks to all of you who renewed your League membership. We've got a lot of exciting work ahead of us this year. The more members who can be involved in that work, the more successful we can be. # Redistricting News

#### **Ballot Proposal**

On December 18, 2017, Voters Not Politicians (VNP) submitted its petitions for an independent redistricting commission ballot proposal to the Secretary of State's office. They gathered a little over 450,000 signatures; there must be at least 315,654 valid signatures from Michigan registered voters in order for the proposal to be on the 2018 ballot.

On December 17, 2017, the State League Board voted to support the VNP ballot proposal. The language of the VNP ballot proposal conforms with the State redistricting position that was developed after local leagues participated in a state redistricting study done in 2011-12. Campaign finance law restricts spending in support of the proposal to less than \$500 in direct or indirect expenditures; so for now, local league members may continue to work on the VNP ballot proposal campaign **only as individuals**.

The State League will update its educational materials, including the power point presentation on redistricting. In addition the State League will develop materials on how to speak in support of the proposal once the Board of State Canvassers approves the 100-word ballot proposal language. The process of certifying the petitions and negotiating the language could take several months.

The State League will continue its work to develop a redistricting reform coalition with other organizations that represent the diversity in our state. The Board believes such a coalition is necessary for a successful ballot campaign.

#### **Lawsuit Filed**

On December 22, 2017, The League of Women Voters of Michigan and eleven individual voters filed a lawsuit in federal court in Detroit against the State of Michigan to end unfair, partisan gerrymandering of Michigan's Congressional, State Senate and House districts. The lawsuit clearly lays out the problem with partisan gerrymandering in Michigan:

Michigan's current electoral maps were drawn in a secretive partisan process with little discussion or debate before being quickly passed by the legislature.

Despite Democrats regularly winning a majority of the votes in the State House, State Senate, and Congressional elections, they hold a minority, sometimes a super-minority of the seats, which is a direct result of partisan gerrymandering.

With sophisticated computer software districts are drawn to dilute voting power, denying fair representation in all districts.

On December 27, 2017, U.S. District Judge Denise Page Hood signed an order allowing a three-judge panel to hear the case.

## Belleville Unit

This month, we are celebrating the two-year anniversary of the beginning of the Belleville Geographical Unit. How did that come about, and where does it go from here? Barbara Miller reached out to the League in late 2015 and asked about starting a Belleville/Van Buren Township/Sumpter Township (Belleville) League. The Northwest Wayne County (NWW) League was asked to be the mentor, and we readily agreed. On a cold winter night in January 2016, Paula Bowman and I, along with Christina Schlitt from the State Board, met with 40 people to hear about the League. By the end of the night, more than 20 people had joined.

For now, anyone from Belleville who joins is a member of the NWW League. There is no specific time period for an area to be a Geographical Unit, but there are some required steps before they move to the next level, Members at Large of the State League. One of those steps is to have a budget and money to fund it. Belleville held a garage sale in September and received some money from last fall's auction.

There are currently three Belleville members on the NWW Board and two members on the Membership and Leadership Development Committee. Mentoring another group was new to NWW members, so we're learning as we go. It's been an exciting, interesting experience. We look forward to what lies ahead in this relationship.
