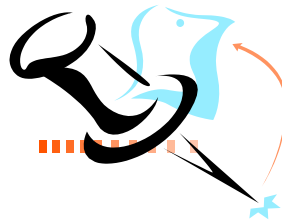

As we look back on our accomplishments this year, we also need to look forward. The State Convention will be held at the Embassy Suites Hotel in Livonia from May 17-19, 2019. At this year's LWVUS Convention, a major topic was diversion, equity, and inclusion (DEI). Periodically, I'll be forwarding emails regarding webinars on this topic. All of us are welcome to participate in the webinars. They will provide us with ideas on how to make our League more diverse and inclusive. We'll be discussing this topic at meetings and developing a plan to implement the suggestions from the webinars.

I recently spoke on behalf of the League at a Livonia City Council meeting regarding a new Planned Parenthood facility that is coming to Livonia. There is a League national position supporting women's health and reproductive rights, so I was able to address this topic. Many of the other speakers were strongly opposed to this facility being established, and it's clear that they will continue protests and other actions against it, even though they don't know whether or not abortions will be performed in this facility. We should work to help the facility to operate safely and without disruption. There's no plan developed at this time, but it's an issue we'll be addressing in the coming months.

Remember that we will have the League's Holiday Party on Sunday, December 9, from 2-4 p.m. at the home of League members Donna Gilkey-Lavin and Manny Lavin. If you haven't been to Belleville, I can tell you that it's easy to reach and a lovely place to visit. This party is a great opportunity to mix and mingle with other League members. Note that carpooling is recommended. I hope you'll be able to attend.

Thanks for your continuing support of the League. Our work is needed now, maybe more than ever.

PRE-ELECTION VOTER SERVICE BY THE NUMBERS

- 7 Candidate forums between September 11 and October 3, covering races for school boards, state house, state senate, the circuit court and a county commissioner. Fifteen League members helped moderate, keep time, question screen and usher at these events, all of which were well attended and informative. We are thankful to all of those who gave up evenings (many members helped at multiple forums) to further the League's mission of informing the public.
- 4 Wayne and Oakland County Leagues worked together to handle shared races that appeared on VOTE411, and to organize the 11th Congressional district and the County Circuit Court judges forums. This is a good partnership between neighboring Leagues, and together we brought important candidate information to voters.
- 71 Local candidates to whom Megan Chenoweth sent questionnaires. Their responses and pictures appeared on VOTE411 by the end of September so that any voter, merely by typing in their home address, could access their ballot and candidates. Forty-four local races and proposals were handled.
- 2,500 State Voter Guides delivered to our League. Thanks to the help of 8 members on an afternoon in early October, these Guides were "stuffed" with 7 versions of local print voter guides. Information gleaned from the candidates' responses were triggered by Megan's VOTE411 questionnaires.
- 22 Libraries, senior centers, offices and schools received our voter guides in early October. We thank all the League members who helped with deliveries. Though our supply was gone, we continued to receive requests for additional voter guides up until Election Day.
- 6 Ballot proposal presentations given by Megan Chenoweth and Paula Bowman at public and private events prior to the election. These educational presentations focused on the 3 statewide ballot proposals.
- ?? The number of 'hits' to our VOTE411 site aren't in yet; we know that we helped thousands of voters make educated decisions on Election Day. All members should be proud of the non-partisan service we deliver to our communities.

Town Hall: Good Government

On October 22, the League and Citizens for Peace co-hosted a Town Hall meeting on Good Government led by the non-profit group, Center for Michigan (COM). We've co-hosted several of their events in the past, when they were called Community Conversations. The format was the same as the prior events. The COM moderator provided some background information on the topic, and he then presented questions with multiple-choice answers. Each person had a clicker with which we could choose the option that best reflected our viewpoint. Within a minute or so, the results of our choices were shown on a screen, and we discussed the findings. The results from this meeting will be aggregated with those from other such events held throughout the state, and a report will be presented to the state legislators. Past reports have led to some very good legislation being passed. We'll receive a copy of the report early next year. It will be interesting to see how our results compare to the ultimate findings.
