## President's Message

Sonoma County has a special connection to National Women's History Month. A Women's History Week was planned and held here by the Educational Task Force of the Sonoma County Commission on the Status of Women on March 8, 1978. Molly MacGregor participated and went on to found the National Women's History Project in 1980 in Santa Rosa with a small group of local women. The Project put together a coalition and petitioned Congress and the White

House to designate a National week to celebrate the role of women in history. In February 1980, President Jimmy Carter issued a Presidential Proclamation declaring the week of March 8 as National Women's History Week. In 1987, the group led a successful effort to have the entire month of March declared National Women's History Month. Recently, the National Women's History Project transitioned to the National Women's History Alliance. They report that tens of thousands of organizations and individuals are finalizing plans for extensive celebrations in 2020 in honor of the passage of the 19<sup>th</sup> Amendment.

The Sonoma County History & Genealogy Library, in partnership with the Alliance, is spearheading a project to highlight individuals in Sonoma County who played a role in the suffrage movement as well as document the places in which suffrage activities occurred. Volunteers and library staff are making discoveries on a weekly basis. Library Manager, Katherine Rinehart, shared this finding about League of Women Voters' founder, Carrie Chapman Catt.

"We just learned that Carrie Chapman Catt (1859-1947), spoke to a large audience at the Petaluma Opera House on October 29, 1896. Mrs. Catt had been invited to speak by the Petaluma Political Equality Club and was introduced by club president, Ellen H. Button. In 1870, she was the treasurer of the Sonoma County Woman Suffrage Association, when she signed her name to a petition for women's suffrage that was sent to the California legislature. Mrs. Ellen H. Button was one of 398 Petaluma residents to sign the petition."

# Grappling with Mental Health Challenges in Sonoma County: The Local Issues Forum

On March18th at 2:30 the Spring Lake Village Local Issues Planning Group, in cooperation with the Sonoma County League of Women Voters, will present its twelfth forum.

The forum's subject is *Grappling with Mental Health Challenges in Sonoma County*. Our county's Department of Health Services has acknowledged the "long standing gap" in the county's mental health system and needed services. The challenges are many. More than half of approximately 3,000 homeless adults report a serious mental health issue. Our Sheriff's department reports 46% of jailed inmates have a mental health issue. At the same time the community, as a whole is experiencing strains associated with rising housing costs and dealing with the trauma of our 2017 fires.

Despite the seriousness of this challenge, many leaders in the community are committed to making a difference in the lives of Sonoma County residents. Come hear a description of the mental health demands on the system, existing measures and their effectiveness as well as plans with anticipated outcomes.

This forum will include a panel of experts. The moderator will be 5<sup>th</sup> District Supervisor Shirley Zane, a longtime advocate of mental health services, panelists Debbie Mason, the CEO of the Health Care Foundation, and Bill Carter, the recently appointed Director of the Behavioral Health Division of the Sonoma County Department of Health Services.

Plan to attend and bring questions. The forum will be held in the Spring Lake Village Auditorium, 5555 Montgomery Drive, Santa Rosa. The Auditorium is near the exit to the main parking lot. Limited Parking; please car pool.

### March 2019 Housing Update

Sonoma County residents are rebuilding many of the homes lost in the wild fires. The City of Santa Rosa and the County of Sonoma have made considerable progress in their efforts to encourage homeowners who lost their homes in the 2017 wildfires to rebuild.

Both the City of Santa Rosa and the County implemented numerous policies and processes to support the rebuild effort, including lowering fees, speeding up the approval process, deferring fees until occupancy, etc.

Tennis Wick, Head of the Sonoma County Permits and Resources Center, reports that the department has issued more permits in the last 12 months than ever before in their history. They have issued building permits for 50% of the housing that was lost in the wildfires in the unincorporated areas of the County.

The City of Santa Rosa has also reached the half-way mark for homes that entered the rebuild process, supported by their Resilient Permit Center. In addition, the City is allowing residential building of up to 10 stories in the core downtown and SMART station areas.

Looking to housing needs beyond the housing lost in the wildfires, the County of Sonoma and the City of Santa Rosa have partnered to create a Regional Housing Joint Powers Agreement (JPA) to look at housing needs on a regional basis. This is the first JPA of this kind in the state. Rather than each jurisdiction just "doing their own thing," the JPA will allow pooling of resources, sharing of best practices, and greater coordination on projects.

And it is not just the County and cities which have increased their efforts. Burbank Housing, with 3,200 rental units, is one of the largest providers of affordable housing in Sonoma County. They have several affordable housing projects recently completed or in the pipeline:

- Crossroads which is 79 housing units in Southwest Santa Rosa, housing 15 formerly homeless people
- 161 affordable units for seniors are planned for the former Journey's End mobile home park and Burbank hopes to build an additional 300-400 units of market rate housing on the same site by building multi-story buildings on the site.
- Lantana Homes is a 48 unit development in Southwest Santa Rosa for those making 100% of the Area median Income (AMI).
- Cartas Homes is a project in downtown Santa Rosa of 134 units for people who have been homeless, with supportive services for residents.

#### Book Club Reads

March 21--Moderated by Mary Fricker

An American Sickness: How Healthcare Became Big Business and How You Can Take It Back Elisabeth Rosenthal, 337 pages, 2017

Rosenthal, a senior writer for the New York Times who has a Harvard Medical School degree and served as a physician at New York-Presbyterian Hospital, asserts that the American medical system has lost its focus on health. An American Sickness is a shocking investigation into our dysfunctional healthcare system - and offers practical solutions to its myriad problems. Breaking down this monolithic business into the individual industries--the hospitals, doctors, insurance companies, and drug manufacturers--that together constitute our healthcare system, Rosenthal exposes the recent evolution of American medicine as never before.

April 16--Moderated by Sukey Robb-Wilder Eager: the surprising, secret life of beavers and why they matter by Ben Goldfarb, 286 pages, 2017

This diverting volume sings the praises of beavers, who, though targets of a multi-century massacre and besieged by urban sprawl, still manage to flourish not only in Walmart parking lots, but in stormwater ponds, golf course water hazards, and even in downtown Martinez CA. Goldfarb, an environmental journalist, makes the case that beavers are a keystone species vital for ensuring healthy ecosystems; yet, their notoriety as a nuisance species is hard to overcome.
