The League of Women Voters is a non-partisan, political organization that encourages informed and active participation in government, works to increase understanding of major public policy issues, and influence public policy through education.



As 2018 ended, we saw a flurry of activity in the State legislature. Hundreds of bills were passed with few hearings or discussion. The League followed many of them. Thankfully, the governor vetoed some that we considered particularly egregious.

After almost two years since the League's lawsuit regarding redistricting was filed against the Republican legislators who drew the current map, we finally had our days in court this week. The trial lasted three days with the Republicans calling just one witness. Now, we wait for the judges' decision.

In the last newsletter, I addressed some of our accomplishments in 2018. Today, I want to mention some of our upcoming events, which will all provide opportunities for you to participate. There are detailed articles elsewhere in this newsletter about them.

The big one is the State League Convention, which will be held in Livonia from May 17 to 19, 2019. As the host League, we'll have a chance to show League members from all over the state how great our members and our community are.

We'll be monitoring three co-op elections in the coming months, one in March and two in April. These are exciting occasions to see democracy at work.

You'll have the opportunity to interview one or more of our Michigan representatives and senators in the coming months. You can choose your own officials, or someone in another community. Either way, it's a great way to get to know the people who are making the decisions in the State Legislature.

As you learn more details about these activities, I hope you'll be able to fit something into your schedule. Most of them will take no more than two or three hours of your time, but I expect that you'll be enriched by the experience.

I appreciate all of you for being members and look forward to seeing you at a meeting or one of the other League events in the coming months.

Seven years ago, the League was hired by the Westwick Square Co-operative in Wayne (4900 Heather Place) to monitor their annual Board of Directors (BD) election. They have invited us back every year since. This year's election will be held on **Tuesday**, **March 12**. We also provide League members ahead of the election to issue proxy votes. We need two members for each of the following time periods:

Legislative Interviews

At the start of every new legislative cycle, the State League asks local Leagues to interview their State Representatives and State Senators. These interviews help to establish a relationship with a legislator. That personal contact can be crucial to the League's future advocacy efforts, helping us determine what issues are important to each legislator. They also help the League anticipate what issues might be addressed in the next legislative session. Legislators who may not be familiar with the League outside of our voter service and candidate forums can also learn what issues our organization follows. These interviews are for internal purposes only, and the results are not published.

Volunteers are provided with questions and background material. Two League members are needed for every interview. Interviews are set up by the members at a date, time and location that works for both the members and the legislator. Locations used in the past have been libraries, coffee shops and restaurants. Secretary of State Ruth Johnson made the following statement regarding the governor's signing of legislation to create an online voter registration option for applicants:

"By allowing voter registration applications to be securely submitted electronically in Michigan, the governor and legislators have given citizens a convenient and secure option. I'm grateful to the supporters on both sides of the aisle who worked together to make this important measure a reality." Johnson has advocated for online voter registration for a number of years. Prior to the Convention, the State League asks all local Leagues to review the state advocacy positions. This is a way for members to learn or review the positions the state already has. Local Leagues can propose an update of a current position, a new study or adoption of a new position by concurrence, or they can accept the State League positions as they are.

On January 26th at the general meeting, we reviewed each of the State positions, and voted to accept the State positions as they are currently written. Belleville Unit

In January 2016, the Belleville Geographical Unit (GU) was formed, under the guidance of the NW Wayne Country League. Since then, members from Belleville have served on the NW Wayne Board of Directors and various committees. Meetings and other events have been held in Belleville, and members from Belleville have participated in activities in other parts of NW Wayne. The formation of a Belleville leadership team is a part of the process for the GU to move on to being a Member at Large Unit, the next step to becoming an independent League. In 2018, we endeavored to recruit someone from Belleville to serve as co-president and shadow the current president. That effort was unsuccessful, and no future leaders of the unit have been identified. We'll continue to work to develop the Belleville GU.

Women Rise from the Crypt by Ann Abdoo

Adelaide Johnson (1859-1995) was known as the "sculptor of the women's movement". She was commissioned by the National Women's Party to create a memorial to the pioneers of women's suffrage, so she sculpted the busts of Susan B. Anthony, Elizabeth Cady Stanton, and Lucretia Mott on a very large piece of marble. On Feb. 15, 1921, the Portrait Monument was unveiled at a ceremony held in the Capitol's Rotunda. The next day it was moved to the basement, known as the crypt.

Fast forward to 1995, Karen Staser, founder of the National Women's History Museum, came upon the sculpture by accident. She did recognize Susan B. Anthony, but not the others. Ms Staser was determined to find out more. She talked with someone from the Belmont-Paul Women's Equality National Monument organization, and learned of their desire to have it moved to the Rotunda by 1995 as part of the 75th anniversary of the passage of the 19th Amendment.

So far their efforts to get it moved had failed, so Karen Staser offered to help. Karen's husband worked for Senator Ted Stevens (R-Ak), and he convinced Senator John Warner (R-VA) to help. There was a press conference where Karen asked people to donate to help cover the \$150,000 cost of the move; however not enough donations were received. The House of Representatives objected to using public funds for such expenditure. The campaign continued with over 100 groups forming the Woman Suffrage Statue Campaign. When Speaker of the House, Newt Gingrich (R-GA), was told ..."You have locked three Republican women in the basement," attitudes started to change; but it was not until 1996 that Congress passed a resolution allowing for the Monument to be moved to the Rotunda for one year. In 1997, the Monument was moved to the Rotunda, rededicated, and remains there today.
