Carver will discuss the ethics commission amendment in the context of New Mexico's ethics environment.

Co-President's Message: Money in Politics, N M Style

If, like me, you are outraged at the way big money dominates our elections (do you remember the definition of "plutocracy" that you learned in high school?), know that New Mexico is trying to clean up campaign financing. The effort is right in line with national League positions.

The LWVUS has been studying and lobbying on Money in Politics for many years. Here is the relevant portion of the national position, which of course has had to take into account the Supreme Court's decision in the Citizens United vs. FEC case that money is speech, and speech can't be limited:

The League of Women Voters of the United States believes that the methods of financing political campaigns should:

- · Protect representative democracy from being distorted by big spending in election campaigns;
- · Ensure transparency and the public's right to know who is using money to influence elections....

In 2017 the NM legislature passed a law governing campaign financing and addressing the concerns of Citizens United, but it was vetoed by the governor. As a result, Secretary of State Maggie Toulouse Oliver has recently proposed similar rules to cover Campaign Finance that can be read at: http://www.sos.state.nm.us/Elections Data/notice-of-proposed-rulemaking.aspx.

Our NM League has given testimony in support of these rules. They are designed to make large donations more transparent and to regulate reporting of so-called "coordinated" expenditures where supposedly independent PACs support specific candidates.

LWVNM President Judith Williams's letter of support closes: "The League of Women Voters believes that an open, transparent government including the running and financing of political campaigns is key to a healthy democracy. The Secretary has done a good job of interpreting existing laws to arrive at a clear and sensible set of disclosure rules."

Now it's our turn. Individuals, whether League members or not, are encouraged to give written comments to the Secretary of State by August 29 at 5 p.m. at sos.rules@state.nm.us. Do your part to make New Mexico great again—well, at least to limit the influence of big money in our elections.

Report of June Lunch with a Leader: Stephanie Garcia Richard's 2017 Legislative Wrap Up

Stephanie Garcia Richard's takeaway for the Legislative session was, "...we cut, we cut and cut and cut." In a 60-day session any bill can be introduced. Most of the bills stalled (in committee, in the House or Senate), or were stopped by a veto by Gov. Susana Martinez. Elected District 43 State Representative in 2012, Richard has learned that almost all bills, even good ones, take more than one session to pass into law.

Several of the bills Richard introduced focused on education, including

- · creating a strategic planning task force;
- · developing a 20-year education plan from early childhood through college;
- · limiting the use of attendance in teacher evaluations;
- · limiting statewide school testing days.

Other of her more high-profile bills were "Unaffiliated Voters In Primary Elections," "Pregnant Worker Accommodation Act," "The Bear Bill," (a constituent-introduced bill calling for an evaluation of whether a bear attack was defensive or predatory before killing the bear), and "Background Checks On Gun Transfers" (that bill was the most controversial issue discussed at the LWV's Legislative Preview). None of these bills succeeded in passing both Houses and gaining the Governor's approval this year.

Some of the other bills that failed during the regular session, but that will come back are the minimum wage bill, campaign finance, and payday lending (the current session passed legislation to cap interest rates at 250%).

In the May Special Session the tax overhaul failed to clear committee, but several bills passed at least either the House or Senate to

- · borrow severance tax money (that would normally go to infrastructure projects);
- · balance the budget;
- · increase both the gas and vehicle excise tax;
- · restore money vetoed by the Governor to fund higher education and the courts;
- · increase funding for cancer research.

Richard admits that service as a legislator requires long hours of hard, frustrating work. The work does not end with the session. She also serves as the House Education Committee Chair and as a member of the Labor and Economic Development Committee between sessions; she must spend time studying the many crucial issues and responding to people opposed to her bills. But she appreciates the opportunity to work with other New Mexicans to determine the future of the state; to meet hundreds of New Mexicans from all political and cultural affiliations; and to work not only with her own party, but across the aisle on some bills to push the state into the 21st century.

Richard noted that her own Girl Scout Troop shadowed her for one day of "training the next generation of women in government." More girls who grow into women participating in politics can redirect the course of our state's government. Richard hopes to help encourage them.

Observer Corps Reports

County Council

Between the County Council meetings on June 6 and July 11, the County Council agreed upon the sale of two adjoining parcels of land in White Rock, encompassing about 60 acres, for mainly residential use. About 1.5 acres of the tracts are expected to be commercial. The two parcels are within the A-19-A tract and lie immediately to the east of Pajarito Road and north of NM 4. Hopefully within a year or two RayLee Homes will start to build on this land.

At the June 27 meeting, County Manager Harry Burgess reported that the turnaround time on all permits from the county is now averaging 1.57 days. That is a major improvement over past performance.

Burgess also reported that the Police Department purchased body-mounted cameras for their officers. The officers have been trained and are now using these cameras. According to Burgess, insurance reimbursed the county for the \$49,000 purchase money for the cameras.

As of July 3, our new Library Manager is Eileen Sullivan. She spent seven years as Library Director in Silver City. Interestingly, she originally graduated from the Wisconsin Conservatory of Music and later earned her Library of Science degree from U. of Texas at Austin. We wish her well as she and her husband join our community.

The County Council met on July 26th to debate a resolution submitted by Councilor Pete Sheehey enumerating the duties of the sheriff's office. Complicating this effort was a threatened lawsuit from Sheriff Lucero's lawyer that would be submitted to the courts if the proposed resolution was not passed. This lawsuit was distributed to Council just prior to the meeting. After much discussion, several council votes, and public comment, the resolution, which had been amended to remove the last paragraph, was tabled. A suggestion by Councilor Chrobocinski that a Charter Committee be established to clarify the Charter language regarding duties of the police and sheriff in Los Alamos County will be discussed at a later date.

Board of Public Utilities

On June 21st the Board of Public Utilities (BPU) approved proposed ordinances to increase the water and sewage rates by 8%. The ordinances will make their way to the County Council to be considered for adoption on August 8th. Additionally, the BPU heard a presentation from a consultant, Pace Global, on the findings for an Integrated Resource Plan (IRP). Assessing risk, cost and other factors, Pace Global looked at future power generation options for the county that would help meet the county's load and goals. A meeting for the public on the IRP findings was held in White Rock on July 12th, and a presentation to the council was made on July 18th.

At the July 19th BPU meeting a public hearing to raise the non-potable water rates (water that is used primarily for irrigation) was tabled until August 16th. The primary customer for non-potable water is Los Alamos County Parks and Recreation.
