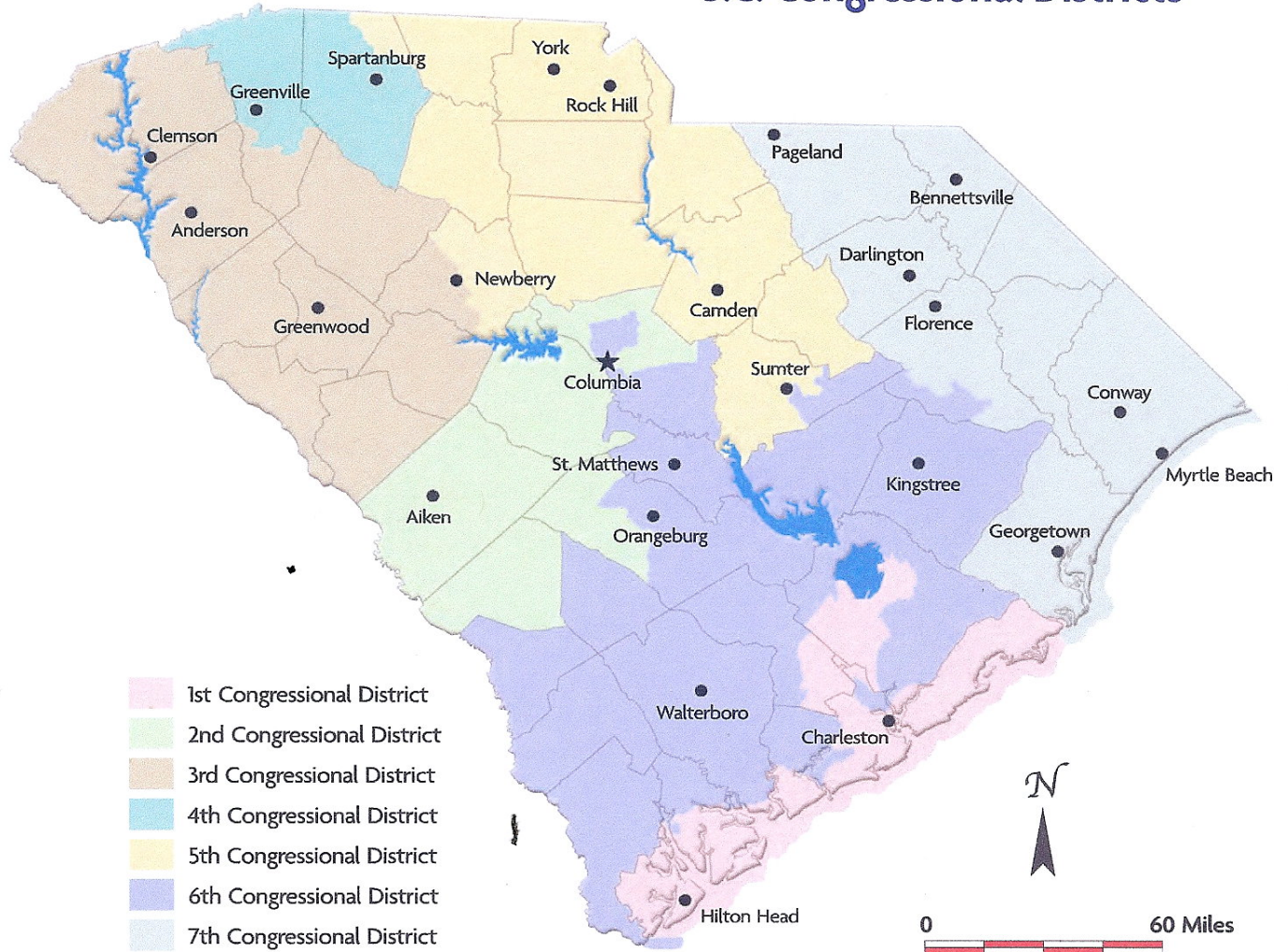

## U.S. House of Representatives

Under the Constitution, each state is entitled to at least one representative. Additional seats are apportioned on the basis of the state's population. Congress fixes the size of the House of Representatives, and each state is apportioned its number of representatives by means of the Department of Commerce's decennial census. South Carolina has seven representatives elected by voters to serve two-year terms.

## The General Assembly

### SC Senate

The General Assembly crafts South Carolina state laws and consists of two bodies: the South Carolina House of Representatives and the South Carolina Senate. There are 46 members of the S.C. Senate, who are elected every four years concurrent with United States Presidential election. The legislature convenes at the State House in Columbia from the second Tuesday in January until the first Thursday in June unless extended by a vote of both bodies.




