<u>Auxiliary & Outreach Committee Report</u>: Committee met prior to board meeting, with presentation by the MAC and radio station, how they promote and communicate for COD, next meeting will by prior to board meeting on Nov. 21 at 5PM.

<u>ACCT New Trustee Orientation Report</u>: Dunn attended a meeting Aug. 8-10 in Washington, DC., on Leadership, She showed a list of topics offered, one of those being how to evaluate self as a board member, ethics, etc. Touch on accreditation and what it is and means, as well as how to measure student success.

<u>ACCT Leadership Congress Report</u>: Napolitano and Fenne attended. They attended a session on Bridges to High Schools sharing ideas on how to increase enrollment. ICCTA Report: Heidi Holan reported that she attended the State Colleges Meeting in Springfield.

Enrollment Update by Dr. Mark Curtis-Chavez. Reported on which divisions have increased enrollments, such as Health Services, and which have lower enrollments, such as English, Math, etc. Headcount of students down 16.7%.
