- Five members attended the New York State League Convention in June.
- The Citizenship Mentoring Group had 31 students this past year, and 6 became new Americans. We also attended 8 naturalization ceremonies, registering 194 new citizens.

Yet on a sadder note, our League lost two long-time members, Helga A. Schroeter and Karen B. Johnson, both civic leaders in our community who will long be remembered fondly and with gratitude. We've learned so much from each of them.

# **Voter Services Report**

## Voter Registration- Peg Foley and Connie Young

The League was very active this year registering people to vote. We held 17 voter registration events, including 7 naturalization ceremonies. We registered 200 people at the naturalization ceremonies, with the remainder at the Kids Arts Festival, Sch'dy Greenmarket, Municipal Housing Authority, Union College, YWCA, SICM food pantry, Price Chopper, SCCC, YMCA, Parsons Child Care and Salvation Army for a grand total of 267 registrations. It's been a great volunteer effort with 33 League members involved. I would list everyone's name, but I'm afraid of leaving someone out! Thank you to all of our volunteers!

#### **Vote411.org**- Mary Jane Shave and Barbara Vivier

Mary Jane and Barbara worked hard, inviting 65 candidates to participate in our online voting guide, Vote411.org. About half of the candidates entered replies to our questions. The guide was published on October 19th, in time for early voting.

#### **Candidate Forums**

We held candidate forums in Schenectady (Oct. 2- Cheryl Nechamen), Glenville (Oct. 3- Vicki Hoshko), Niskayuna (Oct. 15- Connie Young/Carol Furman) and Rotterdam (Oct. 16- Cindy Weissend). Each forum was staffed by a diligent group of volunteers- thank you!

The forums went smoothly as we worked around the county legislature budget meetings some of which seemed to be held the on the same nights as our forums. New this year was the unwillingness of some of the audience to turn off their cell phones for the duration of the gathering. We had to maintain a constant patrol to make sure no one was making recordings which could potentially be manipulated to disparage an opponent under the auspices of the League. The videotapes were edited by Open Stage Media and shown on public access cable. They were also available on our website at lwvschenectady.org and on our Facebook page.

#### TAKE ME TO VOTE

The 2019 Take Me to Vote education project is completed. All 24 Schenectady County elementary schools received polling maps from the Board of Elections and tickets provided by Price Chopper. Each of the wonderful volunteers delivered the material in time for the teachers to explain the voting process. The children returned tickets to the polling places where their parents voted.

This local election like all local elections should be important but always has a poor turn out. In all, 690 slips were collected from the Board of Elections. We will hopefully do better next time. Connie Young

# Trump administration wants to raise costs to become a U.S. citizen by 83 percent

Becoming a U.S. citizen may get a lot more expensive, and groups are urging legal permanent residents to apply as soon as possible.

The Trump administration wants to increase the cost of citizenship applications by 83 percent for roughly 9 million immigrants eligible to become U.S. citizens.

U.S. Citizenship and Immigration Services at the <u>Department of Homeland Security officially</u> announced the <u>proposed price hike</u> Thursday, saying that "current fees do not recover the full costs of providing adjudication and naturalization services."

The citizenship application fee would go from \$640 to \$1,170 and fees associated with legal permanent residency will go up 79 percent — from \$1,220 to \$2,195.

Advocates like Angelica Salas, executive director of the <u>Coalition for Humane Immigrant Rights</u>, or <u>CHIRLA</u>, see the administration's proposal as "a targeted and brazen attack especially on those who are poor and vulnerable" because it seeks to price out immigrants "of their rightful place in our communities and in America."

<u>The proposed rule also outlines a series of other kinds of fee increases</u> that impact immigration-related applications for asylum-seekers, Temporary Protected Status beneficiaries, DACA recipients and legal permanent residents.

DACA renewals would increase from \$495 to \$765, possibly giving Trump officials a tool to limit the program in case the Supreme Court allows the program to continue despite the administration's efforts to end it.

The administration is also seeking to transfer \$207.6 million of USCIS funding and divert it to Immigration and Customs Enforcement (ICE).

# U.S. Citizenship and Immigration Services, DHS.

Proposed rule.

The Department of Homeland Security (DHS) proposes to adjust certain immigration and naturalization benefit request fees charged by U.S. Citizenship and Immigration Services (USCIS). USCIS conducted a comprehensive biennial fee review and determined that current fees do not recover the full costs of providing adjudication and naturalization services. DHS proposes to adjust USCIS fees by a weighted average increase of 21 percent, add new fees for certain benefit requests, establish multiple fees for petitions for nonimmigrant workers, and limit the number of beneficiaries on certain forms to ensure that USCIS has the resources it needs to provide adequate service to applicants and petitioners. Adjustments to the fee schedule are necessary to recover the full operating costs associated with administering the nation's immigration benefits system, safeguarding its integrity, and efficiently and fairly adjudicating immigration benefit requests, while protecting Americans, securing the homeland, and honoring our country's values. USCIS also is proposing changes to certain other immigration benefit request requirements.

USCIS has an open period in which to make comments on the <u>Federal Register</u>, the national journal of the US government, regarding this proposed fee hike. To do so, please click on the link below.

#### CAPITAL REGION SEES HOPE FOR A ZERO WASTE FUTURE

The Zero Waste Capital District Coalition, including the League of Women Voters of Albany County that sponsored Neil Seldman's presentations on October 14 and 15 at the Albany Public Library is very pleased that local and regional officials, organizations and lay people came out and expressed interest and enthusiasm for the ideas and solutions to our waste problems that Dr. Seldman suggested. Zero Waste can be implemented without continuing to increase costs to taxpayers. There may be ways to create local economic benefits to individuals and governments by creating business around materials that would otherwise be treated as waste. Many expressed willingness to participate in ongoing efforts to create local and regional zero waste strategies.

### NEXT STEPS FOR ZERO WASTE CAPITAL DISTRICT

Dr. Seldman has connected us with companies and consultants to help us solve our waste problems. The week after his visit, he organized a conference call with a number of people from the Capital District on "Pay to Throw" (PAYT) as a way to reduce landfill waste by about 40% and increase recycling and composting. We have learned that over 10,000 U.S. municipalities already have PAYT programs in place.
