#### Michael Hoffman - Board of Education



Currently serving as Vice Chair of the Redding Board of Education, Mike is seeking a second term. My goal as a member of the Board of Assessment Appeals would be to assure that assessments are based on accurate information, and are equitable as compared with similar buildings, land, and location. I bring decades of financial experience and an understanding of the Redding community to the task.

#### The top issue you will address if elected.

The top issue facing the Planning Commission is the implementation and monitoring of the new Redding Plan of Conservation and Development. The plan provides the overarching vision for the Town of Redding and encompasses many goals, including conservation of open space and thoughtful residential and business development.

#### What other issues do you feel are important in this election?

Many other issues fall within the umbrella of the town plan. Perhaps the most crucial will be the development of the Georgetown wire mill site. The First Selectman has been making steady progress toward a reasonable resolution, and the Planning Commission will have a key role in the planning and development of that site. We need to ensure—to the extent possible—that the development is consistent with the character of our town while also enhancing both our financial base (via tax revenues) and the diversity of our residential offerings (such as affordable, multi-family housing).

### Background information about yourself (elected and volunteer positions held, experience, family etc.)

I am a professor of psychology, am married and have lived in Redding since 2007. I am currently an alternate on the Planning Commission. I am a former member and Chair of the Redding Board of Ethics and a former alternate on the Redding Zoning Board of Appeals. I also sit on the Board of the Redding League of Women Voters.

#### Regina O'Brien

Regina O'Brien has served on the Redding Planning Commission since 2013. She is a landscape architect based in Redding. Her firm focuses on residential work throughout Connecticut and New York State, with a particular passion for creating plans based on a comprehensive understanding of the landscape and the natural processes intrinsic to a site's forms and ecosystem. Regina's extensive knowledge of landscape construction best practices, horticulture, and cultural history inform and benefit her work with the Planning Commission. As a Planning Commission member, she is committed to seeking a balance between responsible development of the land and a profound respect for a site's natural features and processes. In evaluating large and small projects that come before the Planning Commission, Regina strives for positive solutions that are in keeping with the cultural history and natural landscape of Redding as a whole.

Gerry Casiello, the current Chairman, has served on the Redding Zoning Commission since 1980, at which time the current zoning regulations were being written and enacted into law in 1986. He has held the positions of Chairman and previously Vice Chairman the past 15 years, during which time he has guided Commission to act with unity and purpose. This long service has given him a unique perspective on the land use regulations in town...he understands how and why the regulations were written and how they have been enforced. Gerry has lived in Redding for 42 years and raised 3 children here. For the many of us who decided to move here in the last 4 decades, we owe a debt of gratitude to Gerry for his leadership in keeping Redding the green and great little town it is.

Redevelopment of the Georgetown wire mill looms large in the background of land use in Redding. While it's unfortunate that the nationally recognized plan for the site approved in 2004 was sidetracked with the recession of 2008, you can be assured that our zoning regulations require that any future development will take into account the best interest of all stake holders in Redding.



Matthew Lecher has been a member of the Zoning Commission since 2012, when he was appointed as an alternate. He was elected a full member in 2015 and currently holds the position of Vice Chairman. As an executive in real estate development and property management, Matthew brings strong background and expertise to the table. He and his wife are 20 year residents of Redding and have raised their 2 daughters here. He was appointed to the Historic Review Committee in 2014 and again in 2017 as the Zoning designee. He seeks to continue to contribute his time and expertise participating in upholding the Redding Zoning regulations for the town of Redding while working to help fellow residents and business owners achieve their goals within those regulations.
