### **Changes in voting procedures effective with the April 28, 2020 Primary Election and important options voters need to know.**

Previously, County Board of Elections accepted  
applications for voting registration if postmarked  
by the deadline. That is no longer allowed.

**Applicants must either return their  
application in person or it must be received in  
the mail by the County Board of Election in  
Doylestown by the deadline.** You may now  
vote by mail-in ballot, unless you qualify as an  
absentee voter, in which case you must vote by  
absentee ballot. **You do not need to provide a  
reason or excuse if you want to use a mail-in  
ballot.** You can apply for a mail-in or absentee  
ballot **IN PERSON** at the Bucks County Board  
of Elections, 55 E. Court St., Doylestown and  
ask to have it processed immediately and receive  
a ballot on the spot. **At that time, election  
officials must provide an opportunity  
for the voter to vote in private. The voted ballot  
can then be left with the Board of Elections.**

in Doylestown by 5 P.M.

civilian absentee ballots. Must be received in  
Doylestown by 8 P.M.

**April 28, 2020 GENERAL PRIMARY** Polls  
are open from 7 A.M. to 8 P.M.

**April 29, 2020** First day to register after  
primary

**May 5, 2020** Last day for County Board of  
Elections to receive voted military and  
overseas absentee ballots (submitted for  
delivery no later than 11:59 P.M. on April 27)

**October 19, 2020** Last day to register before  
the November election

**October 27, 2020** Last day to apply for a  
mail-in or civilian absentee ballot. Must  
be received in Doylestown by 5 P.M.

**November 3, 2020** Last day for County Board  
of Elections to receive voted mail-in and  
civilian absentee ballots. Must be received in  
Doylestown by 8 P.M.

**November 3, 2020 GENERAL ELECTION**  
Polls are open from 7 A.M. to 8 P.M.

**November 4, 2020** First day to register  
after November election

**November 10, 2020** Last day for Board of  
Elections in Doylestown to receive voted  
military and overseas absentee ballots  
(submitted for delivery no later than 11:59  
P.M. Nov 2)
