## A Message from the CEC Committee Honoring Women's History Month

Every year March is designated as Women's History Month by a Presidential Proclamation. Ever wonder why and how it began?

As we celebrate Women's History month, I doubt that many are aware that this recognition traces its roots back to March 8,1857. It occurred after women who were working in the factories in New York City protested poor working conditions. It took



quite a long time for women to receive some recognition and laws to be made to improve their working conditions, but the events of that day were later recognized on March 8,1909.

Fast forward to 1980 when a consortium of women's organizations known as the National Women's History Alliance lobbied Congress for a week long recognition. In February that same year, President Jimmy Carter issued the first Presidential Proclamation declaring the Week of March 8th as National Women's History Week. A year later, Congress passed a resolution marking the occasion.

As subsequent presidents continued to proclaim this week-long celebration, things changed in 1987. It was during President Reagan's administration when Congress was once again lobbied by the same alliance and other women mainly from California to expand the week-long recognition into a month-long recognition. As we mark the accomplishments of women who have changed the culture, history, and society of our country, the month is also celebrated in the United Kingdom and Australia.

For Michiganders, this is a perfect time to celebrate the accomplishments of women such as Rosa Parks, Sojourner Truth, and Belle Brotherton who was the first president of the Michigan League of Women Voters. As we commemorate the lives of these women and all the activists and suffragists, we can't overlook the common thread that binds them together - persistence.

## LWVOA Bylaw Revisions to be Voted on at 2021 Annual Meeting

The Board is proposing bylaw revisions to bring our bylaws into agreement with those of LWV-US. Changes were approved at the 2020 National Convention.

The membership will be asked to approve the changes at this year's annual meeting — which might be in questionnaire form as was the one for 2019, or it might be via ZOOM, or perhaps it will be a picnic outside with everyone masked and socially distanced. The board would be pleased to hear your suggestions and preferences. A complete copy of the bylaws is found in your handbook

#### Changes proposed:

ARTICLE II. Purpose and Policy. Section 3 added: Diversity, Equity & Inclusion Policy. The League is fully committed to ensure compliance - in principle and in practice - with LWVUS' Diversity, Equity, and Inclusion Policy.

ARTICLE III. Membership. A [4] is added: Those who are students are defined as individuals enrolled either as full or part time with an accredited institution.

ARTICLE IX. Principles and Programs, Sec. 1 Principles is amended as follows: The principles are concepts of government adopted by the national convention and supported by the League as a whole. They are the authorization for the adoption of national, state and local program. The Principles are concepts of government supported by the League and are the authorization for adoption of national, state and local program. They may be amended by the convention in the same way as program is adopted under Section 2 of this Article.

## **U.S. Electoral College and the Jan.6, 2021 Insurrection**

On Feb. 10, 2021, Maria Woloson presented via Zoom a power point program to the American Associaton of University Women (AAUW) about the U.S. Electoral College. Over 30 women of the AAUW local Birmingham group attended.

This normally boring event, where the US presidential election results are confirmed indirectly by appointed electors, became a headliner on Jan. 6, 2021. At that time, a threatening mob of over 20,000 stormed the US Capitol Building, disrupting the proceedings. Several people were killed and many seriously injured. Congressmen and staff were forced to evacuate the Capitol Chambers. After six terrifying hours, the National Guard halted the violence and stopped the insurrection.

These events furthered LWVUS's position that the Electoral College should be abolished in favor of the nationwide vote directly choosing the president.

### **LWVMI Lame Duck Session Study Consensus**

Fourteen LWVOA members gathered via a Zoom meeting on February 9 to discuss the materials sent to all members by the LWVMI study group and were able to reach consensus on the questions posed by the group. Members may access the questions and study materials at

The consensus is to agree with statements 1, 2 and 7, to not to agree with statements 3, 5 and 8. No consensus was reached on statements 4 and 6. The group was not surprised to learn that both parties have used the Lame Duck Session to pass legislation.

Commenting on the issues raised in the study, the group agreed we should not eliminate the ability to bypass standard procedures when a true emergency exists. Theoretically a true emergency would garner bipartisan support and therefore the ability to come up with a super-majority to bypass standard procedures. We suggested that procedures can be bypassed only with a super-majority.
