## **Proposed Annual Meeting Rules**

**Procedure:** *Robert's Rules of Order, Newly Revised* shall be our authority.

**Delegates:** each voting member is a delegate to this meeting. Privilege of the Floor: all members may have the privilege of the floor when fully recognized by the Chair.

**Debate:** any delegate may debate on the floor. Debate shall be limited to 3 minutes unless the time is extended by a two-thirds vote. No one may speak twice until all who wish to speak have had an opportunity. All remarks should be limited to the question.

**Motion:** all motions will require a second before discussion and voting.

**Voting:** the President shall designate the method of voting to be employed: by voice or by polling.

## **Program Adoption Procedures**

- 1. Membership makes suggestions for local program to the Board of Directors at least two months prior to the Annual Meeting.
- 2. The Board shall consider the suggestions and shall formulate a proposed program.
- 3. The proposed program shall be sent to all members at least 20 days before the Annual Meeting along with a list of the non-recommended program suggestions, if any.
- 4. A majority vote of the voting members present shall be required for adoption of the program proposed by the Board; non-recommended items require a majority vote for consideration and majority vote for adoption.
- 5. The program shall be taken up for debate, possible amendment and adoption at the time designated in the agenda.

# **PROPOSED BYLAWS CHANGES**

The full bylaws may be viewed at our League website. To access, go to lwvscc.org and click on "About the League" in the side bar menu. On the drop-down menu click "Our Local League"; then, in the text, click on the bylaws link. In the proposed changed listed below, additions are in **bold type** and highlighted in yellow; deletions are stricken out and highlighted in blue.

1. **Article II, Purpose and Policy, Section 2** (page 1): In 2020 at the national convention, the LWVUS added a Diversity, Equity, and Inclusion policy to its bylaws, and local Leagues are required to change their bylaws to match. Section 2 is split into parts (a) and (b) to accommodate the following change.

Section 2. Policies. The policies of the League are:

- **a.** Political Policy. The League shall not support or oppose any political party or any candidate.
- b. Diversity, Equity & Inclusion Policy. The League is fully committed to ensure compliance—in principle and in practice—with LWVUS' Diversity, Equity, and Inclusion Policy.
- 2. **Article III, Membership** (page 2): Another change to the LWVUS bylaws adopted at the 2020 convention is the addition of a definition for student membership. Adding this to our bylaws is required to conform to LWVUS bylaws.
  - Section 2. Types of Membership. The membership of the League shall be composed of voting members and associate members. Only voting members shall be members within the meaning of the California Nonprofit Corporation Law.
    - a. Voting Members. Persons at least 16 years of age who join the League shall be voting members of the League, the LWVC and the LWVUS. Those who have been members of the LWVUS for 50 years or more shall be life members excused from the payment of dues. Those who are students are defined as individuals enrolled either as full or part time with an accredited institution.
    - b. Associate Members. All others who join the League shall be associate members.
- **3. Article V, Board of Directors**, Section 7e (page 4): This change was made to broaden the definition of alternative meeting formats for board and other meetings in response to the strictures imposed by the pandemic. This allows the board greater flexibility in choosing what meeting format meets their needs and requirements. Language to conform to the changes made to Article VIII is also added.

[Article V, Section 7, subsections (a through d) remain unchanged.]

- e. Participation in Meetings by Alternative Means. Any one or more members of the board may remotely participate in a meeting by use of conference telephone or similar communications equipment, so long as all participants in the meeting can simultaneously hear each other. Notice, quorum, and other requirements for the conduct of meetings shall apply. This is acceptable for all meetings. Business in virtual meetings will be conducted in the same manner that meetings conducted in person are, including the same notice and quorum requirements. The Board may determine when such alternatives will be used, what communication method to employ, and how those methods will be used.
- **4. Article VII, Financial Administration**, Section 2 (page 5): This change deletes specific policy about half-year membership dues that conflicts with our <u>current membership policy as adopted in 2019</u>. Changes to membership and dues policies are within the powers of the board, and the details do not need to be mentioned in the bylaws.

Section 2. Dues. Annual dues shall be determined at the annual meeting by a majority vote of the local League members present. Such dues shall be payable by each member on July 1. Any member who fails to pay dues within 3 months after they become payable shall be dropped from the membership rolls. Life members shall be exempt from payment of dues. New members joining from February 1 to June 30 will pay half the amount of the annual dues for that year.

**5. Article VIII, Membership Meetings and Voting Rights** (page 6): A new Section 2 is added to allow for alternative meeting formats for membership and other meetings in response to the strictures imposed by the pandemic. This also necessitated changes to the subsequent section numbers 3 through 7 (not shown).

Section 2. Alternative Meeting Formats. One or more members may remotely participate in any meeting, so long as all participants in the meeting can hear the speaker and have a means to communicate in real time with other participants. This is acceptable for all meetings, including board meetings, membership meetings, and the Annual Meeting. Business in virtual meetings will be conducted in the same manner that meetings conducted in person are, including the same notice and quorum requirements. The Board may determine when such alternatives will be used, what communication method to employ, and how those methods will be used.

6. Article XIII, Amendments (page 9): Adding this section allows the board to change the bylaws without membership approval when such changes are required by law or by changes to the bylaws of the LWVUS and LWVC. Note: lack of having this section is the reason why we must have members approve changes to Articles II and III, even though they are required changes.

Section 1. Subject to Section 2 below, these bylaws may shall be amended by a two-thirds vote of the voting members present and voting at the annual meeting, provided that amendments were submitted to the membership in writing at least 20 days in advance of the meeting. The failure of any member to receive such notice shall not invalidate the amendments to the bylaws.

Section 2. When required by law or amendment of the LWVUS or the LWVC bylaws, these bylaws may be amended by the board of directors.
