Our three local state legislators, Senator Susan Moran, Representative David Representative Vieira, and Dylan Fernandes, will be the guests at 7:00 p.m. on Wednesday, October 27, at a public program arranged by your Legislative Committee. It will be broadcast live on FCTV's

During the planned program, our legislators will each have the opportunity to speak briefly about issues they choose. In addition, they will be asked about pending legislation important to the League and your Legislative Committee. We also will

pass along questions posed by you, our League members, and by other members of the public. As you read this notice, think about what you would like to ask our legislators. Then send us an email at this address: msc0512@comcast.net. If you think of questions during the broadcast, it will not be too late to send them. We will use as many as we can.

We plan to have a flexible format. However, as noted above, we hope to seek our legislators' views on at least some of the bills we have been promoting in the Legislative Committee. Voting is a very high

priority. Massachusetts now has the chance to continue the new electoral systems adopted due to Covid and even to expand them further through same-day voter registration. Immigration bills, such

as the Safe Communities Act and Work and Family Mobility, remain important. Common Start offers a fresh look at childcare and early childhood education. Dealing with safety close to home, the League supports a bill to require continuous monitoring of the dry casks that are storing spent nuclear

fuel across the bridges in Plymouth. And almost everyone is curious about how redistricting – and reprecincting – are being carried out. We hope to get to as many of these issues as time allows, keeping in mind both the need to give the legislators an opportunity to briefly address issues of importance

LWVF STEERING COMMITTEE REPORT

The LWVF Board Steering Committee met on Friday, September 24 via zoom. Richard Johnson proposed that League members be fully informed about the Mixed Residential and Commercial Overlay District to be voted on at the November Town meeting. There will be considerable coverage of this in the media between now and November Town Meeting.

There will be no October Voters Service program on redistricting as pertinent census data for Massachusetts will not yet be available and may not be until the end of the year. Instead, Judy Ziss and her Legislative committee will have a public meeting with our state legislators in October so that Voters Service can present its program in March.

Misty Niemeyer announced that an electronic LWVF Membership Directory that can be downloaded and printed at home will soon be available. However, those members who are not able to access the directory online may request a printed copy from the League. She also announced that the League has welcomed another new member. The report to members about Annual Meeting II held at the Cape Verdean Club on September 11 will appear in the Bulletin once three readers approve the draft for publication.

Finally, Marcia Easterling gave a brief report about the organizational meeting of a local Neighborhood Support Team held at Waquoit Congregational Church on September 21 to begin preparations to welcome up to three Afghan evacuee families. The meeting was covered by a reporter from *The Enterprise* and will provide details about the program.

Natural Resources: Special Presentation

Please join the Natural Resources Committee on Thursday, November 18, 7 p.m., at Falmouth Academy (Morse Hall) for a presentation on "Ecological Restoration in Falmouth: The Coonamessett River and Peterson Farm Vernal Pool Restoration Projects." The presenters will be Betsy Gladfelter, Falmouth Conservation and Commission. Mark Kasprzyk, Falmouth Conservation MES Tech.

Betsy will discuss the process of restoring the cranberry production fields along the river to a diverse and rich habitat of native flora and fauna. The

first section of the Coonamessett Heritage Trail has been completed; significant portions upstream are in process, with plans to connect all the way to Coonamessett Pond.

This restoration also significantly increases the storm water storage capacity of the river basin. Mark will discuss methods employed to control invasive species at the river as well as at Peterson Farm's vernal pool, the site of our LWVF Centennial Grove of Tupelo trees.





Both sites are open to the public and well worth visiting. There is an easy trail around the first section of the river, connecting two boardwalks across the river, accessible from two points along John Parker Road. The Gateway overlook off John Parker Road is nearing completion.

Under the direction of Corrie Greene, the Cape Verdean Club members welcomed the Falmouth League to the Club. Maggie Sweasy welcomed all and State Representative Dylan Fernandes expressed his appreciation and thanks for this joint venture of the League and the Cape Verdean Club. Before the League business meeting, Corrie presented a program on the history of the Cape Verdean Club, first organized in 1941, which included an informative video. Following the League business meeting attendees enjoyed a lovely luncheon prepared and graciously served by members of the Cape Verdean Club. The League and the Club had collaborated on the Get Out the Vote program before the November 2020 election.

LWVF Business Meeting

Maggie called the meeting to order and asked for a minute of silence to remember those who perished and all who risked their lives to save others on Tuesday, September 11, 2001. Maggie then welcomed the Co-President of the Massachusetts League, a guest for this very special annual meeting. Sylvia Szulkin then presented the LWVF Awards for outstanding service to the League. Recipients were Jacqueline Webster and Jenny Putnam (in absentia). Sylvia also acknowledged the outstanding contributions to the League by Carol McKeon for her efforts for Voter Services, Denise Morreale for her work with the Observer Corps, Richard Johnson for his effort in getting the Centennial Trees and plaque in place, and Judy Ziss for her diligence in keeping us informed about important legislation pending in Boston. She also commended Brenda Nolan for her work as co-editor of the LWVF Bulletin and presented a Civic Leadership award to Mindy Todd of WCAI for her work in making sure local news is covered and for being a frequent moderator for League-sponsored Candidates Nights before elections.

Meghan Hanawalt directed members to her Treasurer's Report and the proposed budget for 2021-2022 printed in the 2020-2021 Annual Report presented to League members before the meeting began. Kathy Mortenson then directed members to study the proposed local position changes on pp. 6-10 of the Annual Report. Denise Morreale will chair the new LWVF Local Study on Transportation, a re-study through a diversity, equity and inclusion lens.

Joan Boyer announced the Steering Committee for 2021-2022: Joan Boyer, Maggie Sweasy, Richard Johnson, Misty Niemeyer, and Marcia Easterling and introduced new Board members Eileen Mattingly, Mary Fran Buckley, Lynne Rozsa and Maro Titus. Mixed Residential and Commercial Overlay District Update

Attention Falmouth Town Meeting Members:

At the September 23, 2021, ZBA Open Meeting, Town Planner Thomas Bott presented the proposed Mixed Residential and Commercial Overlay District that will go before Town Meeting in November.

This proposed overlay district will allow mixed retail/office/residential development and multi-family residential development in B1, B2 and BR zoning districts along Route 28 and in a few other small areas. The purpose is to allow for high density residential construction in areas well served by public transit and other services (such as Davis Straits, Palmer Ave, Main Street, Rt 28 at the Acapesket, Davisville, and Central Avenue intersections and a few locations in North Falmouth), for the express purpose of increasing the affordable housing stock in Falmouth.

If apartments, 25% of units must be affordable, and lease for no less than 12 months. If condominiums, 50% must be affordable. Approval will be by Site Plan Review by the Planning Board, with notification to abutters within 300'. Density of up to 20 units per acre is allowed on parcels greater than 10,000 sf, and no fewer than four units are permitted on any parcel.

The setbacks are rather unique, intended to move the building closer to the road (maximum front yard setback of 20') and push parking to the side and rear (10' minimum, 20' minimum if abutting residentially zoned land), with parking of one space per unit.

Affordable rental housing poses a challenge as tenants must qualify and enter the housing lottery to get the first lease, and requalify each year in order to renew their lease; it is not quite clear who will monitor this process, as it is not under 40B regulations. With owner occupied housing, prospective buyers must qualify and enter the housing lottery only the first year.
