<p><b>US House of Representatives</b> Under the Constitution, each state is entitled to at least one representative. Additional seats are apportioned based on the state's population. Congress fixes the size of the House and the procedure of apportioning the number among the states. Each state is apportioned its number of representatives by means of the Dept of Commerce's decennial census. South Carolina has 7 representatives elected by voters to serve 2-year terms.</p>

Senate, who are elected every four years, concurrent with the United States presidential election. The legislature convenes at the State House in Columbia from the second Tuesday in January until the second Thursday in May. 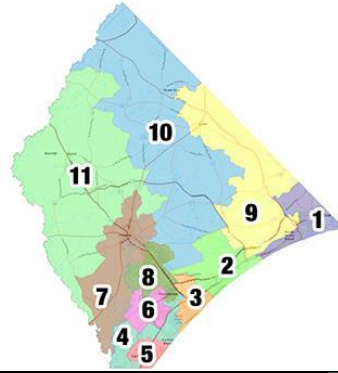
