- SB 21 and SB 22 Clean water protection bills. Would give NM more control over pollution of its waters, including the ephemeral waters
- SB 5 Game commission reform
- Some health care bills aiming to increase number of healthcare providers in the state: interstate compacts medical malpractice removal of GRT for medical services
