## Defend Democracy!

On Saturday, April 5, 2025, hundreds of thousands of Americans (maybe you were among them?) gathered on the streets of villages, towns and cities across all fifty states for the “Hands off “ rally to protest the current administration’s attacks on our democracy. They came out with signs and with their voices in opposition of tariffs; federal cutbacks to public education, Medicaid, Medicare, health and human services, and research; as well as attacks on journalists, institutions of higher education and public media. They exercised their First Amendment right to free speech and peaceful assembly. This is democracy! And it is with this same clarity that we need you to help defend the right to vote.

Below on this page you will find the League’s “talking points” regarding President Donald Trump’s executive order of March 25, 2025. The order mimics the so-called SAVE Act which, if passed, will greatly restrict the right to vote, especially for women, young people, black, rural

and low income Americans. For decades, our League has worked with our county Board of Elections and we can attest to the thorough and careful work of individuals who run that office. Our election system works!

Our message to you is “Be prepared to Defend Democracy!” Review the article on the SAVE Act and spread the word to other groups about the insidiousness of this action.

## The SAVE Act —What You Need to Know!

On March 25, President Donald Trump’s issued an Executive Order that contained many provisions limiting access to voting. The League believes that this order is unlawful and is one more example of executive overreach.

“Let’s keep it real: this order is not about protecting elections; it is about making it harder for voters — particularly women voters — to participate in them,” said LWVUS CEO Celina Stewart. “The President continues to overstep his authority and brazenly disregard settled law in this country. To be very clear — the League of Women Voters is prepared to fight back and defend our democracy.”

The Executive Order mimics the SAVE Act, which passed the House last week. Now, the Senate must reject this bill to prevent it from becoming law. They need to hear from you.

It is already illegal for non-citizens to register and vote in federal or state elections. The bill’s requirement of a document to prove American citizenship to register to vote in federal elections is unnecessary and seeks to divide us. The SAVE Act is also an attempt by the federal government to usurp authority over elections at all levels.

It would require every single American citizen to provide very specific documents, chiefly by either presenting a passport or an original copy of their birth certificate, in person when registering to vote and anytime they update their voter registration. And finally, the bill would establish criminal penalties for election officials who mistakenly register an applicant to vote who has not presented proof of citizenship.

We should not be undoing the work of the past few decades that made it easier to register in New York State. Rural voters, working class voters, voters of color, and older Americans are less likely to hold a passport or readily accessible birth certificate. Members of the US Military could not even use their military ID to register to vote.

### The Results are In! Purple Beats Green at Crayon Carnival

Mary Tedesco and Christina Bourgeois served as “poll workers” as well for the event. Hudi reports kids of all ages enjoyed the League’s two voting activities. On the crucial question of which color crayon kids preferred, it was 40 votes for purple and 29 for green. On the favorite Crayon Carnival activity vote, it was Bounce House by a mile with 20 votes—food came in second with only 7 votes. The largest cluster of voters were in grades 4-6; they were 23 of our 47 voters. We hope to see them all in a few years at a League voter registration event.

## New Dues System Launches. Are You Ready?

The new League dues system has launched! Part of the League’s “Transformation”—a process that began in 2018 to strengthen the League and ensure its future—was to change the dues structure to make it easier for people to join the League. February 1, 2025, marked the launch of the system and members are now joining and renewing across the country.

What will it mean for you? Our League has had an annual dues collection system, which meant members renewed every year starting in September and continuing through January. With the new system, dues will be collected on a rolling basis. Your dues will be up for renewal each year on

the anniversary of when you joined or for members who have been in the League for a long period of time, the anniversary of when you last renewed.

Students will participate in a series of interactive lectures on topics such as the state budget process, the role of lobbyists in the legislative process, and citizen rights to access government information, Shadowing their Senator and their Assemblymember for an afternoon and attending a session on the Chamber floors are two of the highlights of SIA.

Applications for SIA are sent to schools in the area each year in early January. Thanks to Maria Kaltenbach who coordinates the SIA Program for the LWVCA.
