August LWVLA Board minutes – Cecile

Motion: Barbara Calef moved to approve the August meeting minutes. Wendy Swanson seconded. The motion carried unanimously.

Treasurer's Report – Addie Jacobson

Addie emailed the August report to the Board ahead of the meeting.

August 31, 2025, financial position: \$5,040.08 on checking account, \$10,641.12 on savings account, \$35,746.78 on CD maturing 11/12/25, and \$15,149.59 on CD maturing 10/03/25.

Motion: June Fabryka-Martin moved to approve the August Treasurer's Report. Becky Shankland seconded. The motion carried unanimously.

Membership Report – Bob Williams excused

Barbara Calef indicates that the current membership stands at 106, down from 129. Twenty-four memberships have not been renewed. Most of them are for spouses of current members.

The layout of the portal keeps changing. There might be an issue with donations showing on the portal but not being received by the Treasurer. Barbara will check with Addie.

Voter Guide Update – Lynn Jones

All 18 candidates responded to the questions. The material was delivered to Los Alamos Daily Post on September 22. The Voter Guide will come out on October 2.

Lynn inquired about publicity about the Voter Guide. Jody will announce it to the online news. She will also write a Letter to the Editor. Copies will be placed in public places, such as libraries. An electronic copy of the Voter Guide will be posted on the League's website.

Karyl Ann asked what the League could do to incentivize people to run for School Board. Considerations about modifying State Law to allow "at-large" candidates were discussed. The group thought that asking School Board candidates about their position on the issue at the Candidate Forum would be valuable.

Publicity Committee – Leslie Wallstrom

Leslie will schedule a meeting with Jody, Barbara, Akkana and Helena Whyte. The committee will discuss a publicity strategy.

The publicity hopes to recruit someone who is adept at social media. Jody suggested contacting Julie Williams-Hill for her knowledge of the social media landscape in Los Alamos.

The new banner, designed by Barbara and Akkana, has arrived.

National Voter Registration Day, September 16 - Barbara Calef

The proclamation of National Voter Registration Day by the County Council on September 9 was well attended. The photo will be used to publicize the Voter Guide and Candidate Forum.

Barbara reported that two League members stood by Sugar & Cream Café on September 16 and were asked questions by passersby, including ways to join the League. Two League members set up an information table at the Farmers Market on September 25, and two more will be present on October 2.

The theme will be health care issues in Northern New Mexico. Possible guests include representatives from regional hospitals, a consultant from Think New Mexico, and legislators. Cecile suggested reaching out to NM-DOH and possibly the Indian Health Service. Jody asked to consider the impact of heroin use as a topic.

The forum will be open to the public. It will be held in Los Alamos (venue TBD).
