EARLY VOTING OPTION

Early voting is open 9 consecutive days beginning on the second Saturday prior to the election and ending the Sunday before the election. Voting will take place at a polling site designated by your city. Contact your Clerk's office for more information.

VOTING BASICS

TO VOTE IN MICHIGAN, YOU MUST BE

- a U.S. citizen, at least 18 years old on Election Day,
- a resident of Michigan and your city for 30 days,
- not currently serving a sentence in jail or prison, and
- registered to vote (you may register to vote up to and including Election Day).

REGISTRATION

- You can register in person at your clerk's office, online at michigan.gov/vote, by mail, or at any Michigan Secretary of State office.
- You **must** register in person at your local clerk's office beginning two weeks before and up to 8 pm on Election Day.

IF YOU MOVE

- within the city, notify the city clerk.
- to a different city, re-register in the new city.

ABSENTEE VOTING BEFORE ELECTION DAY

- No-excuse absentee ballots are available 45 days before an election. You may also choose to be placed on a permanent absentee voting list.
- If voting absentee, **sign** the envelope and ensure that your ballot is received in your city clerk's office by 8 pm on Election Day.
- Contact your city clerk for more information on how to vote absentee.
