### Registration Deadlines

Online and mail-in voter registrations must be received eight days before Election Day whether they are new registrations or updates of current information. If that deadline is missed, you may go in person to your Auditor's Office up until 8 p.m. on Election Day. If you have a valid Washington State driver's license or ID, you may go to [vote.wa.gov](http://vote.wa.gov) to register, check the status of your registration, or update information online.

### Voter Eligibility

To register to vote in Washington State, you must be:

- A citizen of the United States
- A resident of Washington State
- At least 18 years old by election day
- People aged 16 or 17 may preregister, and they will be sent a ballot when they turn 18
- Not disqualified from voting due to a court order
- Not currently serving a sentence of total confinement in prison under the jurisdiction of the department of corrections for a Washington felony conviction
- Not currently incarcerated for a federal or out-of-state felony conviction

### Voting by Mail

All 39 Washington counties vote by mail. You must complete a voter registration form if you are registering for the first time in Washington or if you have moved to a new county. After you register, you will automatically receive a ballot for each election. You must inform your County Auditor if you change your residence or mailing address. Ballots must be post-marked on or before Election Day. You may also return your ballot to the County Auditor's office or another ballot drop site designated by your County Auditor by 8 p.m. on Election Day.
