**VOTE!** You have three ways to vote in New York State.

**1. VOTE ABSENTEE** to vote absentee, you must first apply for an absentee ballot.

- apply for a ballot online at [www.elections.ny.gov/VotingAbsentee.html](http://www.elections.ny.gov/VotingAbsentee.html)
- pick up an application at the Board of Elections, Meadows Office Complex | 40 County Highway 33W, Cooperstown, NY online at [www.elections.ny.gov/VotingAbsentee.html](http://www.elections.ny.gov/VotingAbsentee.html).
- Fill out your ballot as soon as it arrives in the mail and return it promptly.

**2. EARLY VOTING** Early in-person voting begins October 29 and ends November 6 at the **Otsego County Board of Elections**, Meadows Office Complex, 140 County Highway 33W, Cooperstown and the **Foothills Performing Arts Center**, 24 Market St., Oneonta. Choose the date you plan to vote early:
