VOTING MATTERS-ELECTIONS

On March 5, the Dallas County Commissioners Court approved a plan for implementing county-wide vote centers on election day for Dallas County. That means, beginning with the November 6, 2019 Constitutional Amendment election, we will be able to vote anywhere in the county on election day as we currently do during early voting. Currently, voters may only vote at their precinct polling place, near where they live, on election day.

Reasons to go ahead with this change are:

- The technology is proven. More than 50 counties in this state use vote centers on election day including big counties like Collin, Lubbock and Travis. They've been doing so for years.
- Dallas County has been running vote centers during early voting for decades and knows how to do it.
- Having to travel to a precinct polling place on election day causes an unnecessary hardship and wastes time for voters who work in one part of the county but live in another. Why should a voter who works downtown have to travel to, for example, Farmers Branch, to vote when they could so easily vote in the area where they work?
- Uncounted voter hours are wasted because people don't know where their precinct polling

place is. A few years ago, we conducted an exit poll in conjunction with the statistics department of SMU on election day for a gubernatorial election. We found that 9% of the voters on that day had gone to the wrong polling place and were traveling around trying to find the right one. What a waste of time for people who were just trying to be good citizens.

Several LWV Dallas members were at the meeting to support the item. Diane Tasian and Elaine Wiant were there, and Elizabeth Walley, Bill Betzen and Harryette Ehrhardt spoke in favor.

Dallas County is also planning on changing out election equipment. It has already approved a contract for purchase of "electronic poll books", a modern version of the paper books election workers currently use to check in voters. Next comes purchase of voting equipment. Any voting equipment used by a county in Texas must be certified by the state, and the only two systems currently certified both produce "paper ballots". Therefore, any new equipment purchased by Dallas County will produce a paper ballot that can then be fed into a ballot counter. This is the "paper trail" that voters have been clamoring for.

Honor gifts are a great way to recognize someone's birthday, a wedding anniversary, the birth of a child or grandchild—and a new League member.

Gifts to the Scholarship Fund help a person join and participate in the League. Scholarship gifts are particularly helpful to members who are on a fixed income and young members who may be just starting out and dealing with student loans. You can also make a gift to the Scholarship Fund to pay the dues of a specific person whom you know wants to be a member or would like to renew.

In fact, you can pay the dues of a family member or friend as a way of encouraging that person to learn more about and participate in the League.

Another important way you can support the League is to leave a bequest to the League in your will. You can specify an amount, or you can state a percentage of the residual of the estate after the designated gifts have been made.

The League is the only organization that was involved in the fight for women's suffrage and is still in existence 99 years later. Your gift to the League will help ensure that the League can continue to serve the public 100 years from now with critical, unbiased, nonpartisan information to help Make Democracy Work.

To leave a bequest to the League in your will, you can use the following wording:

Bequests are generally placed in the long-term reserves of LWV Dallas and used as decided by the Board of Directors. Donors who wish to set up an endowment or designate their bequest for a specific purpose are encouraged to discuss those plans with the board's President or Director of Development.

50-YEAR MEMBER SPOTLIGHT

LONG-TIME MEMBERS SPOTLIGHT "TULIE and MICHAEL LOWENBERG"



Julie and Michael Lowenberg just joined the elite group of 50-year League members. Julie is a native of Dallas. She lived on Walnut Hill when it was the northernmost street of Dallas!

As a lawyer, Julie taught the first Gender Discrimination and the Law classes at Southern Methodist University's Law School during the early 1970s. At the time, textbooks were being rendered almost obsolete by groundbreaking U.S. Supreme Court decisions that granted women unprecedented opportunities.

Lowenberg subsequently began her second career as a volunteer with the League of Women Voters, working at the local and state levels to improve women's lives and to secure their civil liberties.

In 1969, a neighbor invited her to a Unit meeting which were then hosted by League members in their homes. That she became an ardent volunteer for the League is an understatement. Julie became involved in studies, voter services at the Local and State levels, as Organization VP and held the position of LWV Women's Health Issue Chair for twenty-five years. Her efforts, testimonies, and action alerts supported the constitutional right of privacy of the individual to make reproductive choices. Julie became LWV Dallas President in 1987 and served for two terms. In 1998, she was elected President of the LWV Texas Board.

Over the years, Julie's volunteerism has not gone unnoticed. Among her recognitions, she received the then known as Maura Award - Women helping Women from the Dallas Women's Foundation (now the Texas Women's Foundation). In recognition of her many years of dedicated volunteerism for the League and in the community, Julie received the Susan B. Anthony Award in 2010. This March, Julie received the Community Award at the Southern Methodist University's Women's Symposium.

While Julie was involved in her many endeavors, her very supportive husband Michael was also making his mark in the community. He has been legal counsel for two firms, most recently for Foley Gardere. Michael has been awarded the Super Lawyer designation for 2003 to 2013. This is a designation of top-rated practicing attorneys selected through extensive evaluation. It is said that Michael is passionate about helping clients solve their issues as quickly as possible. He is a loyal and diligent advocate, as well as a skilled negotiator – an expertise that clients value when they are seeking to avoid litigation. Numerous nonprofit organizations have benefitted from Michael's expertise.

Julie and Michael will celebrate 54 years of wedded bliss in June. They have one daughter, two sons and seven grandchildren.

According to Julie, her best experiences in the League have been meeting great people and her long tenure as Women's Health Issue Chair.

When asked how she would complete the sentence "I wish the League would...", without hesitation she said "I wish the League would be able to clone the many wonderful, dedicated volunteers I have met over the years." She also said she wishes the League could afford to have an Executive Director.

In Memoriam ~ *Patrícia Ann Vaughan* ~ November 26, 1941 – January 3, 2019

Pat Vaughan was a member of the League for 35 years. She served in many capacities, as President, Program and Organization Vice Presidents, Nominating Committee Chair, unit leader, and chair of several committees. She was well versed in how the League worked and was a valued member of the board in whatever position she held.

She received her Masters Degree in Recreation and Park Administration from Indiana University. Pat worked for many years with Camp Fire in various locations and served as the Assistant Executive Director and Director of Camping for the Lone Star Council of Camp Fire in Dallas. She was active in her church, The Episcopal Church of St. Thomas the Apostle; the Texas Women's Foundation; and the Women's Council of Dallas County.

Pat was greatly appreciated for her generous philanthropy to LWV Dallas and LWV TX. She received the President's Meritorious Service and the Myrtle Bales Bulkley Awards in recognition of many years of exceptional service to the League and the community. She also served on the board and contributed to the Texas Women's Foundation and received the Maura Award.

She established the Jonesville Foundation in her hometown to help others, especially to empower women and children to achieve lifelong success. Pat has left her mark on all of us, and we will miss her very much.

Bessie Weed was a 26-year member of the League of Women Voters. She served on the Board and was the Advocacy Vice President during the 1998 controversy over the Trinity River Bond Proposal. Bessie also served as a unit leader of the Far North Dallas unit for several years and was active in several committees.

Bessie received her Masters Degree in Social Work from the University of Texas Austin School of Social Work. She worked for Hope Cottage, the VNA and UTD, among other agencies.

She was a member of the Women's Council and attended the Health and Human Services Coalition meetings, and she served on the Dallas Area Agency on Aging Advisory Council. Bessie will be missed.

In Memoriam ~ Mrs. Essie (Richard) Reed ~ December 30, 1933 – February 25, 2019

Mrs. Essie Reed was an active, lifetime member of the League of Women Voters of Dallas for 56 years. She served on the State Board and attended state and national conventions and local unit meetings regularly. Essie was a very active member in the areas of voter rights, voter education and voter registration for many years. She and her husband John marched with Dr. Martin Luther King, Jr.

Essie received her Masters Degree in Children's Literature from Texas Women's University and began her career with the Dallas Public Library where she worked as a children's librarian. She was the first African American librarian to work with the public and opened and managed three public libraries in Dallas.

She attended Saint Phillips Episcopal, Saint George Episcopal and Saint Anne Episcopal and worked with the "Daughters of the King."

In 2006, Essie received the Susan B. Anthony Award, an annual award presented to "a woman who exemplifies the characteristics of Susan B. Anthony." These characteristics include "independence, persistence, determination and dedication in obtaining equal rights for all." Her commitment to the League never wavered. Essie has made a difference, and we will miss her.
