# **President's Perspective**

It is a surprise to me that this is first time I am participating in a petition drive. Over the years I've signed many a petition, but never got out there to collect signatures. I am one of the League's solicitors for the "Promote the Vote 2022 petition drive. We are looking for qualified voters to sign the "Promote the Vote 2022" petitions that, if successful, will put on the November ballot a state constitutional amendment that will enshrine our voting rights. Elsewhere, the actual petition drive will be covered in an article, but I would like to share what I've learned as I've asked people to sign the petitions.

- People are skeptical there is so much misinformation and disinformation out there, people don't know whom to believe.
- There are too many petition drives happening at the same time. It is a bit overwhelming that we have at least 13 different petition drives going on at the same time. How do we distinguish our petitions from all those other? (You may sign more than one petition on different issues, but not sign more than once on a particular issue.)
- Social interaction on political issues has now become a "full contact" sport. You need to be prepared to be polite, informed and armed with your nicest smile when someone declines to sign in a rude manner.
- The name of "League of Women Voters" stands for something. I have found that when people hear we are one of the partners in this endeavor, they give the petitions the benefit of the doubt. We are still a trusted organization in the public's mind.
- More people feel that the "system" doesn't work for them. I've heard, "Why bother, nothing ever changes," from a number of people.
- There are still good people out there working for positive change and you can count our League members among them.

There are a number of League members who have petitions available for you to sign. We will have them at the Annual Meeting on June 18th. Make sure you stop by the table to sign the petition and make your voice heard. I want to thank Lois Baughman and Jackie Peters for stepping up in leadership positions for this drive. They, along with the other solicitors, are making democracy work the way it was designed to.

We've had a busy year and my crystal ball shows that there is no let-up in sight. With your help, we can do great things. It might take a little more "effort" as we enter our third year dealing with the pandemic, but if we stay focused, encourage each other, and remember that we make a difference, the shared load gets easier to bear. Thank you for defending democracy.

# **Update on the Friedrichs/Bowman Scholarships**

The League's Scholarship Committee has extended the due date for applications for these scholarships to **June 10, 2022**, in consideration of the Memorial Day holiday and vacations. Students enrolled in either Oakland Community College, Schoolcraft College, Washtenaw Community College, or Wayne County Community College are eligible to apply.

Each scholarship will be between \$1,000 and \$2,000, depending on the number of winners, up to a total of \$3,000. Background information and the application form has been provided to the 4 colleges. Winners will also receive a 1-year free membership in our League.

## **Notice About our Annual Convention**

The League will be meeting in Denver, Colorado for the 55th National Convention June 25-27, 2022, under the banner of "Women Powered Democracy. This will be a hybrid convention with opportunities for both in person and virtual attendance. The stated purpose of the convention, as listed on the LWVUS website, "The convention is a biennial event that serves as LWVUS's bylaws-prescribed business meeting as well as an opportunity for League members to gather for training and networking." The League's program will be voted on at this time. Per the LWVUS's website, "League program is the education and advocacy platform that we adopt every national convention to move our mission forward." The big topic this year is the proposed "Structural Transformation Plan."

The League of Women Voters of Northwest Wayne County is entitled to three voting delegates at this convention. The number of voting delegates is determined by the number of members each League has. The three delegates for our League are Valerie Nelson, Lois Baughman and Carrie Moon-Dupree. Lois and Valerie will be attending in person, while Carrie will be

attending virtually. The delegates have been attending pre-convention webinars and Zoom calls getting information on items to be voted on at the convention. Each delegate is not told how to vote, but rather given an education on what will be presented for a vote. LWVMI has made recommendations on their position on some issues, but the delegates can vote their conscience.

After the convention, we will be reporting back to the members our experiences and what the issues were and what was decided. We thank the delegates for taking on this responsibility. Safe travels and wisdom in your deliberations.

# Van Buren Township Planning Commission

I have valued participating in this LWV activity, more so because I've learned so much than that I have served as some sort of watchdog. I had no idea so much work goes on behind the scene.

I signed up to observe a planning commission. Before I realized I needed to focus on my home area, I sat in on a couple of long and informative, meetings of the Detroit Planning Commission. One got very fiery as a presenter clashed with the Board about its timing rules and stormed off; the next week the presenter apologized. Meanwhile, I learned about the historic Armory, the site being fought over. Also, I learned about some new developments in Midtown.

But then, I began to observe the Van Buren Township Planning Commission via Zoom. These bi-monthly meetings follow parliamentary rules and have a precise format for presentations. The agenda and minutes are posted on the Township website before the meeting. They make strong efforts to get community input. This Planning Commission has a very complete space on the Township website which I have reviewed. Currently, there are 18 projects of different size and complexity in various stages of getting finalized. Proposals include architectural plans, reviews by various departments, and other reports with great detail that focus on maintaining safety and attractiveness. One even counted, measured, and identified a couple hundred trees on a nearby woodland area.
