Since the League annual meetings are to be held in May, or no later than June, our state presidents are sharing ideas on how that might be accomplished, in case we are still doing business electronically by then. One idea was to use Survey Monkey, or some other like service, to gather information. Our LWVBF Annual Meeting is scheduled for May 21 but could be held on June 18 as an alternative. We will be considering changes to our bylaws at our annual meeting to formally address connecting electronically.

Karen Crowley from Snohomish County and a member of the League's Washington State Redistricting Committee contacted us regarding a project called "Speak Up Schools." It is intended to prepare residents across the state to provide powerful and effective testimony to the Redistricting Commission in the spring of 2021, after the Census has been tabulated. #### From LWV: The 2020 Census

#### Why it Matters:

The U.S. Census data is used to make decisions about education, healthcare, infrastructure, and political representation. With increased growth in the country, getting an accurate and complete count of every person living within is crucial to ensure that each state receives funding to support the number of residents.

#### What We're Doing:

The League's Census work will occur in three phases: (1) Education; (2) Get Out to Count activities, (3) Watchdog reporting. In the months leading up to Census Day—April 1, 2020—Leagues around the country will be in communities sharing information and resources about how to participate and the importance of the U.S. Census. On Census Day, the League will work in coalition to help get everyone counted, work in Complete Count Committees to share information about low-reporting areas, and communicate where additional support is needed. Once the Census count wraps up in the Summer/Fall of 2020, the Leagues will remain in communities and will report on any issues from the ground.

### 2020 WA State Legislative Update Lora Rathbone

The 2020 Legislative Session adjourned on March 12. Of particular note was the effort to supply extra funding for the Coronavirus response and increased state funding toward solutions for affordable housing and reducing the number of individuals experiencing homelessness. Described here are the bills for democracy that passed. The bill to end advisory votes, which the LWVBF chose to focus on, did not. Please thank your legislators for their support; how they voted is mentioned after each bill. And thank YOU for making the calls that helped to get these bills passed!

#### **Democracy:**

**HB 2421- Election Costs Reimbursement**: The LWVWA worked on this bill for years. It requires the state to pay a proportional cost for each state election as every other jurisdiction does. This will provide a stable funding source to county election officers who can use some of that money for election security and voter outreach. Some counties haven't had a local voters' pamphlet due to lack of funds. This bill specifically requires the production of that pamphlet. Last minute negotiations to keep the additional funding for voter outreach in the bill failed, but the bill as passed is still a major victory! Support for election cost reimbursement came primarily from the county auditors, with the League being the only major group working on its passage. We often hear how critical the League's voice is in representing the voters' interests on these issues. All the 8, 9 and 16<sup>th</sup> LD legislators voted yes.

**SB 6152- Election Financing**: Requires that only entities, including corporations, who certify that less than 50% of their stock is owned by foreign nationals can make political contributions. All the 8, 9 and 16th LD legislators voted yes. **Effective date 6/11/2020.** 

**ESB 6313- Increasing Opportunities for Young Voters:** Allows those who will be 18 by the time of the general election to vote in the primary. It also sets up student engagement hubs at public universities where students can register to vote, get a replacement ballot and receive nonpartisan voter information. All the 8, 9 and 16th LD legislators voted against it. (We will check with WSU- TC to see how we can help this fall.)

## National Vote by Mail Lora Rathbone

The Natural Disaster and Emergency Ballot Act (NDEBA) would ensure voters have 20 days of early voting in all states, require that all mail-in ballots submitted during 21 days leading to an election be counted, and that all voters have the option to request absentee ballots. **Membership:** We have 53 paid members at the end of February. We have a new student, Kylee Yearsley, which brings our total membership to 60.

**Budget Committee:** The budget committee consists of Diane Molleson, Janet Nail and myself. We met in early March and the preliminary FY20-21 Budget is complete. It will be presented at the April meeting. We have budgeted \$10,000 for the 100<sup>th</sup> anniversary celebration in August.

**Ed Funds:** We have \$221.54 in the State Ed fund. The balance in our National Ed Fund of \$479.55 will be deposited in our account to cover most of the TRY printing cost.

National Convention June 25-28, 2020: \$399 – registration fee; two voting delegates eligible.

**State Council:** May 30-31<sup>st</sup> in Yakima: "Registration: \$119 - Includes all materials, breaks, lunch, dinner and—if you stay in the Red Lion hotel (\$99 plus tax per double room)—it includes breakfast, free parking and airport pickup. To get this rate, tell them you are booking for the League of Women Voters event." Stay tuned.

## Center for Sharing at the Collegium Cafe in Pasco Beverly Johnson-Torelli

During 2020, this year of the Centenary, our League is being asked by many groups to participate in their activities. For example, on March 5, in celebration of International Women's Day and with the theme of Bread and Roses, Bev, dressed as a Suffragist, discussed notable local women at the Center for Sharing at the Collegium in Pasco. The women included Josephine Corliss Preston from Walla Walla, the first female elected official in WA. She was the Superintendent of Public Instruction from 1913-1928. Others covered were Zelma Maine Jackson, a black female geologist and one of the Daughters of Hanford; Saundra Hill, retired from the Pasco School District and the 2013 State Superintendent of the Year; and Rebekah Woods who became the first female President of CBC in 2017. Bev was also asked to relate the story of Bread and Roses, featuring Suffragist Helen Todd and four of her friends. They used the new technology of the time, the automobile, to campaign for a woman's right to vote. A group from the Mid-Columbia Mastersingers gave an excellent performance, and other guests described inspirational stories of several amazing women. The event was well attended.

#### **Civics Education**

On March 6, Janet Nail, Lora Rathbone and I had the pleasure of giving a civics presentation to Ryan McCord's English class at Kamiakin High School. Janet and Lora dressed in period costume, and we all wore our "Votes for Women" sashes. We had sent photos in a power point (Continued on next page).

presentation that Ryan had shared with his class. It was a list of government jobs, and students were supposed to identify which level of government was responsible for funding and providing that service.

During the presentation, we discussed the suffrage movement, how voting rights became more inclusive over many decades, and ways they could become better informed, including Vote 411.org and fact checking. Our visit occurred before the presidential primary and one student had already registered and voted. We helped others register and told those who were old enough they could take their form to the Auditor's Office and get a ballot that day.

There wasn't nearly enough time for everything and we tried to include the students in the discussion too. We were planning to present to six classes at Richland High on March 23, but that was postponed, though there is a chance we could do it on Zoom. One of the great things to come out of our presentation was that Kylee Yearsley became our newest student member.

Ryan has done an admirable job of preparing his students to become voting citizens. They have written letters to President Trump and Congressman Newhouse. (I mentioned that Rep. Boehnke was a Kamiakin grad.) When things return to our new normal, I am hoping Ryan can be another educational partner we can work with.

Civics education is fun, but challenging. Trying to condense everything we would like students to know, while trying to inspire them to become lifelong voters is not easy. **Prejudice:** A pre-judgment or unjustifiable, and usually negative, attitude of one type of individual or groups toward another group and its members. Such negative attitudes are typically based on unsupported generalizations (or stereotypes) that deny the right of individual members of certain groups to be recognized and treated as individuals with individual characteristics.
