On April 28, 2018, from 1:00 to 3:00 pm, the LWVNCSD will hold a General Meeting—a discussion of land use and the Safeguard our San Diego Countryside Initiative (SOS Initiative.) The meeting will be at the San Marcos Senior Center, 111 Richmar Ave., San Marcos (MAP).

Our League is beginning the most intense voting season I can ever recall. The battle to represent the 49<sup>th</sup> Congressional district, a seat currently held by Rep. Darrell Issa, has already led to our moderating 4 forums, which have attracted over 1500 people. We have an open seat in the 76<sup>th</sup> State Assembly District, a position currently held by State Assemblyman Rocky Chavez. We are going to collect signatures for a state-wide initiative which will be ferociously opposed by some large corporations but will be a giant boon for local schools and communities if passed. (The California Schools and Local Communities Funding Act of 2018.) We are supporting a county-wide initiative called "Safeguard Our San Diego Countryside". And, of course, there are lots of local, county and state office candidates and an unknown number of state ballot issues to consider. It is going to be a busy Primary season. And then the General Election campaigns will start! Our opportunities to help voters to be educated about the issues and the candidates will be legion during the next eight months. But this is the League's mission, and I am positive we will do a great job.

I also wanted to encourage you to attend our April 28<sup>th</sup> General Meeting. The issue of land use related to a single project has been hotly and frequently contested over the years. Now an initiative for the entire unincorporated area of the county is being put forth for the voters to consider. It strives to keep the non-urban areas of the county low density and concentrate high density development in areas that already have roads, buses, adequate water and sewer facilities, schools, commercial services, and jobs. It will, if passed, make a huge difference in how San Diego County looks in the future. Please plan to come and learn about this important proposal.

By Cathy Greene At the March LWVNCSD board meeting, your board approved support for the "Safeguard our San Diego Countryside" Ballot Initiative

If passed, the measure would require voter approval of amendments to the San Diego County General Plan that significantly increase density on parcels in the unincorporated county now designated for farming, open space, and wildlife uses. The measure exempts minor increases in density, properties within existing village or rural village boundaries, or changes to the plan required to implement state or federal housing law, including laws related to providing affordable housing.

League traditionally does not support "ballot box planning", a concern in supporting measures such as this. League traditionally supports electing competent officials willing to represent their constituents within established governing plans and laws, and to reflect community priorities. But a number of area non-profit organizations and individual volunteers have presented convincing arguments in favor of this initiative.

San Diego County adopted a broadly supported and community-based General Plan in 2011 after spending 13 years and \$18.6 million. It sets appropriate densities for land use in the unincorporated parts of the county. Per state law, the General Plan has zoned sufficient land for housing development to accommodate projected population growth. The plan identifies the best locations to build new housing units in and around existing village centers, where services like sewer, water and schools are already available.

The Board of Supervisors is charged with protecting the General Plan; however, the BOS has a history of overriding it and approving land use changes for large developers. It was only a few years ago that many citizens worked extremely hard to stop the Lilac Hills mega development. But now, in 2018, it is back for reconsideration by the current Board of Supervisors. Philip Pryde, a past chair of the County Planning Commission, comments, "This initiative will close the loophole whereby the Board of Supervisors can repeatedly amend the Plan to allow large nonconforming developments to occur without securing explicit public approval."

A steady stream of developers continues to seek amendments to the plan to clear the way for massive housing developments in areas that are designated for agriculture, open space or rural communities. Examples of proposed developments that would require General Plan Amendments include Lilac Hills Ranch near Valley Center, Newland Sierra northeast of San Marcos, Harmony Grove South and Valiano, both west of Escondido, and Warner Ranch near Pala.

#### Points to consider.

1. This initiative makes no changes to the land use designation of the adopted General Plan, but protects it by giving the public the right to vote on major projects that do not conform to the existing plan.

2. Massive sprawl-style developments enrich developers while worsening traffic, increasing fire danger, adding to air pollution, and undermining efforts to build affordable housing closer to existing services.

The best way to address San Diego's affordable housing crisis is to build the right kind of housing in the right places.

Proponents of the "Safeguard Our San Diego Countryside" Initiative have until mid-May to gather 110,000 signatures from voters registered in San Diego County to succeed in placing the initiative on the ballot. Once the signatures gathered are certified by the County Registrar of Voters, the Board of Supervisors can either approve the measure directly or place it on the November ballot.

# SCHOOLS & COMMUNITIES FIRST

I NEED YOUR HELP! The League of Women Voters has joined a lot of other organizations to collect signatures to put on the ballot the commercial property assessment system which is used in every other state in the USA. You have all received a packet with this initiative, the California Schools and Local Communities Funding Act of 2018 initiative with room for eight signatures on it and have been asked to get it signed by eight registered voters. I hope you will do this and send it back to the League post office box soon. All petitions throughout the state must be turned in to the various county Registrars by April 24, 2018, and we must have them long before that date.

But we can do more to help this initiative make it to the November ballot. The campaign will pay signature gatherers to get some signatures, but those that we collect are free as we are volunteers, and less money has to go to paid people. I would like to organize some League members to collect signatures in front of stores and markets and collect more signatures. <u>But I need some help!</u> I can't do this all by myself – we need to represent the League with teams of two members working together.

I have visited many of the major markets and stores in Encinitas and talked to the managers at each place. Some stores will not allow anyone to collect signatures. Other stores will not oppose it, and a few have specific rules about where to stand, don't obstruct people, etc. It helps that we are volunteers, of course. If you want to do this in your community, you need to talk to the store manager and find out what the rules are for that store. I have posters, initiatives, and instruction sheets to help you get started.

Please return your completed initiative to the League post office as soon as you possibly can. All signatures will be validated by a private firm prior to turning in to the Registrars of each county. This will ensure that we collect the correct number of initiatives in order to qualify for the November ballot.

Just to make it more fun, the people who get the most signatures will be acknowledged at the

Annual Meeting on June 2<sup>nd</sup> and will receive a surprise gift.

On March 12, 2018 the SOAR initiative sponsors submitted their signatures to the City of Oceanside. This starts the formal process to verify that enough Oceanside registered voters signed the initiative to qualify it for the November 2018 ballot. This citizens' initiative was modeled on successful ones passed in Ventura and Napa to help preserve open space and agricultural lands.

It would require a vote of the people of Oceanside if land that is currently zoned as open space or agriculture is proposed to be changed to another land use. Most such land conversions in Oceanside are dense residential units. This results in the loss of these priceless lands, leaves the community with traffic congestion and air pollution- and the adverse social, economic and environmental impacts of poorly planned sprawl development. Protecting agricultural zoning was a key recommendation of our 2015 League Study on Agriculture so we were proud to endorse the initiative. Last week our LWVNCSD Board also voted to endorse the more recent Save Our San Diego Countryside ballot initiative. This would provide similar protection against conversion of farmland in the unincorporated areas of San Diego County. Both measures simply will give the people the right to vote on conversion of these lands to other uses. We all pay the price for the loss of these lands, so we think voters should have a say if such changes to adopted General Plans are proposed. Please spend some time on these campaigns in the fall. Let's make sure that our recommendations about how to preserve agriculture in our region are not forgotten.

During this Board meeting, the following actions were taken.

-The Board, after much review of the initiative and hearing from two speakers, voted to support the San Diego County-wide initiative "Safeguard Our San Diego Countryside".

-The Board, again after much study and hearing from a LWVC member who is an expert on state finances, voted to support a state-wide initiative called "The California Schools and Local Communities Funding Act of 2018". The League of Women Voters of California is one of the sponsors of this initiative. Every LWVNCSD member will be sent a copy of the initiative and asked to collect signatures and return them to LWVNCSD.

-Voted to accept as a Recommended Program all of the Program items developed by members at the Program Planning meeting on 2/17/18. Many thanks to Mary Crowley for organizing and moderating that important meeting. This program will be presented to the members at the Annual Meeting for discussion and a vote.

-Heard from Voter Service Director Elizabeth Brady that we are moderating a candidates' forum for the 49th Congressional District on 3/9 hosted by the Vista Chamber of Commerce. Over 500 people are expected.

-Reviewed our non-partisan policy that we are politically active about issues, but never about candidates or political parties.

# EQUAL MEANS EQUAL-Persisting on the ERA

By now we are all aware that there is currently a strong resurgence of interest in finally achieving passage of the Equal Rights Amendment for which many of us pushed so hard during

the '60's, only to see it fall two states short of passage by the established deadline. Many of the "issues" raised to block its passage have since become moot or discredited: integration of women and men together in prisons, forcing women to serve in the military, forced abortions, equal rights for the LGBT population, loss of protection for homemakers, etc..

Your League Women's Issues Group (WIG) had a wonderful discussion of the current state of the ERA at our last meeting. (League has long raised a voice in support of the ERA.) We used as a springboard for our discussion a short book which we recommend to you as a readable and informative update on the history and current issues surrounding the ERA fight. The book is Equal Means Equal: Why the Time for an Equal Rights Amendment is Now by Jessica Neuwirth and Gloria Steinem. Especially remarkable were the sections which explained why the Amendment is still so important for women's equality before the law and how it's absence continues to disadvantage women. One of its most startling discussions reviews research on how much misinformation is still extant in the general population. Many "remember" vaguely and incorrectly that the ERA actually passed in the '60s!

One of the most poignant quotes was by Ruth Bader Ginsberg, who expressed how much she hoped for the Amendment's passage in her lifetime for the sake of her granddaughters. This current resurgence of action gives her hope life as women and friends of women across the country join this push for equal justice for women under the U.S. Constitution. We shall persist!


