### **Democracy Lobby Day 2019**

The capitol buildings appeared serene but inside there was a beehive of activity during week six of this legislative session. The snow had rearranged schedules in Olympia, and the legislators were working on making up the time and meeting newly revised deadlines.

The LWVWA and FIX DEMOCRACY FIRST (<u>fixdemocracy.org</u>) cosponsored this statewide gathering of about 120 attendees. We met in a large conference room, and enjoyed meeting other league members over coffee/tea. First on the agenda, and paramount, lobby training by our LWV Contract Lobbyists, Nancy Sapiro and Pam Crone. Next up— special guest speakers including senators, representatives, and a county auditor. We took a group photo, had lunch, and dispersed as scheduled to meet with our District's representatives and senators.

Rep. Brad Klippert met with me over his lunch of pork and beans, straight out of the can. Rep. Matt Boehnke was very interested in our civics education materials and voter education efforts. I followed the recommended agenda of BILL PRIORITY talking points, and we discussed five to six League-recommended Bills. I went to Sen. Sharon Brown's office and met her legislative aides. They gave me some time to share why I was on the capitol grounds that day. There was an optional Capitol Campus Tour and House and Senate Committee Hearings I could listen to. I prioritized time with my legislators, and my ride share left for Seattle early to – you guessed it – beat the traffic!

I recommend this experience to all members. It was thrilling to participate in such a direct way. My perspective on the respectability and clout of the League was reinforced. I, for one, will be participating in 2020 and hope others will join me. DEMOCRACY ROCKS!

## **State Convention in Tacoma, June 6-9**

Full registration includes Friday dinner, Saturday lunch, and Saturday banquet. There are also a few Triple and Quad rooms, \$169 and \$179 before tax. Self-parking is \$16 and Valet is \$20/day. Since the Convention starts Friday at 9 a.m., we would pay for Thursday night for the delegates. ### **WA State Legislature**

The 2019 session opened in Olympia on January 14, and is scheduled to end April 28. The LWVWA Lobby Team provides updates on relevant bills in our key areas—Democracy, Social Policies, Education, Environment, and Fair & Adequate Revenue: https://lwvwa.org/issues

Legislative Updates: I have been sending weekly updates covering these key areas, abbreviated from the LWVWA Legislative newsletter. Bills I select to support are chosen from a very extensive list of those the LWVWA supports and are in the committees our legislators serve on. (Sen. Brown and Rep. Boehnke and Rep. Dye are on environmental committees so many of those bills have been included in my updates.) I do not expect people to agree on all the bills, and you are encouraged to support other bills that are not included there. (However, if your representative is not on the appropriate committee, it won't get much notice until the bill comes to the floor.) - The population of the Tri-Cities has increased dramatically from 1976 when he moved here to approximately 300,000 today.

- In 1976, the *Tri-City Herald* had a circulation of 35,000, it had a circulation of 42,000 in 2006 and in 2017 the circulation was 16,620. Our children and grandchildren do not subscribe to the newspaper.
- We are paying more for newspaper subscriptions today because of the lack of advertisers.
- 1,700 daily newspapers have closed in the last decade.
- If you would like to see a better newspaper, encourage your friends and neighbors to subscribe and continue to support your local newspaper.
- The purpose of an editorial article is not to tell you what to think, but to tell you what to think about.
