### Lunch with the League Attendees Try Out New Voting System



On March 27 about 36 League members enjoyed a lovely setting, delicious food, and an enlightening presentation at Charlie's Grill in Windsor. Our Guest Speaker Deva Marie Proto, County Clerk-Recorder-Assessor and Registrar of Voters brought one of the new voting machines and demonstrated the County's new voting system, which was used for the first time this March for the West County Medical Center District vote on the sale of the medical center. Proto said that while the machine is electronic, a paper ballot is printed which is the document which is used for the official count. The election system is very secure and is not connected to the internet. The system was selected from two choices certified by the Secretary of State. The new system will allow periodic updates on vote counts, prior to certification of the final election results.

While about 75% of Sonoma County citizens vote by mail, a significant number still cast their ballots at their local polling place. Districts with less than 250 voters are required to vote by mail. Proto reported that the county is considering a move to an all-mail election, possibly in 2022, with ballots going out to all voters with just 30 "vote centers" around the county.

### **Voter Service Project**

The Voter Service committee is taking advantage of the lull before the storm of the 2020 election cycle with a new project. We are promoting citizen involvement in county commissions. Did you know that there are over ninety commissions, also known as advisory citizen bodies, that report to the Board of Supervisors? Currently there are thirty-four vacancies. These commissions are a vital link between county agencies and the Board and are a way that citizens can help craft policy and set priorities on how money is spent. Commission members are appointed by the Board of Supervisors and usually serve for a two-year term. The variety of commissions is broad. They include everything from very focused, geographic issues to broad county-wide mandates. The application process is simple. Go to the <u>County of Sonoma website</u> and download the application. After completing it, mail it to the County Board of Supervisors.

We will be writing a series of short articles about specific commissions and submitting them to whatever publication is willing to print them. Our goal is to educate readers as to what these commissions do, and to encourage citizens to get involved. ### DECISION COULD SET NATIONWIDE STANDARD FOR REDISTRICTING

The Supreme Court has never struck down a voting district as an unconstitutional gerrymander. On March 26th the Court began hearing cases that might change that. Rucho vs. LWVNC and Rucho v. Common Cause will be argued alongside of each other. The League of Women Voters works closely with partner organization Common Cause. Both cases include First and Fourteenth Amendment claims and ask the Court to affirm the lower court decision which applied a three-part test in determining that the 2016 maps were unconstitutional partisan gerrymanders. The League of Women Voters of Maryland joined as amicus on the Benisek v Lamone case also to be heard by the Supreme Court. Plaintiffs' claims center on the unconstitutionality of Maryland's 6th Congressional District. "The Supreme Court now has a huge opportunity to declare that, once and for all, politicians cannot choose their voter--voters must be free to choose who they want to represent them" (Virginia Kase, LWVUS). The League is hopeful that the Court's decision, expected in June, will create clarity about when the redistricting process is unconstitutional.

In 1812, Massachusetts Governor Elbridge Gerry signed a redistricting bill creating a new voting district specifically designed to favor his party. The district wound and weaved—much like a salamander. A Boston Gazette cartoonist added claws, wings, and fangs, named it "The Gerry-Mander," and the rest, they say, is history.

*Except it's not. More than two centuries later, partisan gerrymandering continues to favor the powerful and well-connected—enabling self-serving politicians on <u>both sides of the aisle</u> to hand-pick their voters, rather than the other way around.* 

It's simple, really. If we want our government to truly represent all the people, then all our votes have to count. And that's what makes partisan gerrymandering so dangerous. But with the help of dedicated members like you, the League of Women Voters is determined to fight for redistricting reform, and will continue to defend our democracy's promise of "one person, one vote." --- Chris Carson, President LWVUS

Most of our March meeting was devoted to the upcoming 2020 census count. Jim Masters, a member of our League and the Center for Community Futures, presented much information on the national plans and the work to be done by the state, and locally, the county and the United Way of the Wine County. The issue about whether there will be a question about citizenship on the census form is still not decided. On other topics, we have ongoing discussions on the state of criminal justice actions in the state and county, a concurrence position on Voter Representation and Election Process (including run-off elections) and the extending of the transportation measure M to be on the 2020 ballot.

### **Outreach Committee Quarterly Highlights**

• A three-person subcommittee of the Outreach Committee is working on a civics curriculum for presentation in our local high schools. Once the presentation is ready for testing, we will pilot it in one or two high schools this spring. We hope to do a bigger launch in the fall. We will schedule a meeting with volunteers after we have piloted the presentation.

- We had a booth at the Women's March in January and at the Los Cien February Luncheon. Our next event will be the Earth Day celebration in April. During the upcoming summer we will be at the Santa Rosa Wednesday Night Market for three nights. Watch for specific dates in the May edition of The Voter.
- As part of the League's focus on Diversity and Inclusion, we continue to work with Los Cien. Their members will be volunteering at our booth at future events this year. We are also working together on Climate Change by encouraging local cities and towns to adopt 100% renewable energy to power their buildings and services, which will decrease greenhouse gas emissions.
- From January 1<sup>st</sup> to March 31<sup>st</sup> the Facebook Subcommittee increased the number of League Facebook Page followers to over 400. Our most popular post was viewed by over 4,000 people.

### **April 2019 Housing Update**

The following are highlights of some of the collaborations between local agriculture and business organizations to increase housing stock in Sonoma county; as well as partnerships between the construction industry and the Sonoma County Office of Education to increase the number of people going into the construction trade.

#### **Agriculture:**

At the Feb 19, 2019 Sonoma Business Journal's forum on Housing in Sonoma County, Karissa Kruse President of the Sonoma Wine Growers, stated that local grape farmers have been working on workforce housing since 2016. Sonoma County has a labor crisis in our Ag industry. The federal H2A program allows workers from other countries to come to work in agriculture in the United States for up to 10

months. Farmers who want to use this program are required to provide housing for these employees. About 1,100 beds currently exist, with 150 added in the past 6 months. Twenty-five percent of these H2A workers are women. Currently 30% of growers provide some kind of worker housing, often on their own land. They want to do more, so in 2017 the growers set up a Housing Recovery fund and raised \$1 million, to date. Many of their employees were impacted by the 2017 wildfires and 280 families have been helped so far. They hope to continue to build additional housing for employees.

#### **Local Businesses:**

The Santa Rosa Metro Chamber has pulled together a round-table of local employers to discuss how employers can support housing development. The Chamber's housing policy states in part, "Our housing crisis is the greatest threat to our long-term economic and cultural success. The Chamber will advocate for incentives and opportunities that create more housing at all levels and organize the private sector to support new housing development in all market levels. We applaud recent progress in streamlining of the local permitting process to encourage housing development. We support similar improvements to the entitlement process to gain process consistency and create needed certainty for developers throughout the city and in priority development areas. We support incentives for in-fill and affordable housing."

Peter Rumble, CEO of the Santa Rosa Metro Chamber, reported at the recent Los Cien Luncheon on housing equity that the Santa Rosa Chamber is launching a local housing trust which already has financial commitments of \$5 million to provide low-cost financing for local housing projects for all income levels. The chamber hopes the housing trust will continue to grow with donations and other funding.

#### **Construction Industry:**

As was stated in the League's 2017 report on Affordable Housing/Homelessness, there is a shortage of trained construction workers in Sonoma County. Several organizations are working diligently to change that. New training programs have begun which will train the next generation of home builders.

The "North Bay Construction Corps" (NBCC) is a program founded and supported by the Career Technical Education Foundation, North Coast Builders Exchange and Sonoma County Office of Education. The mission of the program is to train the next generation of construction workers. NBCC is an after-school, 5-month basic construction training program for seniors in their last semester of high school. Classes are taught by local contractors and construction managers. Participants are introduced to a variety of trades and earn certifications in Forklift and Scissor Lift Operation, Personal Protective Equipment and CPR/First Aid. Successful students earn 3 units of college credit. For more information go to http://ncbeonline.com/nbcc/.

The Sonoma County offices of California Human Development is offering training in demolition, repair, renovation and reconstruction. The Sonoma Lake & Mendocino Counties Building & Construction Trades Council offers a Pre-Apprenticeship training program that will prepares participants to enter the construction field, through a state certified joint apprenticeship training program.

April 16--Moderated by Sukey Robb-Wilder *Eager: the surprising, secret life of beavers and why they matter* by Ben Goldfarb, 286 pages, 2017


This diverting volume sings the praises of beavers, who, though targets of a multi-century massacre and besieged by urban sprawl, still manage to flourish not only in Walmart parking lots, but in stormwater ponds, golf course water hazards, and even in downtown Martinez CA. Goldfarb, an environmental journalist, makes the case that beavers are a keystone species vital for ensuring healthy ecosystems; yet, their notoriety as a nuisance species is hard to overcome.

May 16--Moderated by Nancy Burrington The Browns of California, by Miriam Pawel, 480 pages, 2018

Pulitzer Prize–winning journalist Pawel (The Crusades of Cesar Chavez) continues to explore the California political landscape with this well-written and deeply researched dual biography of the late Pat Brown, the state's governor from 1959 to 1967, and his son Jerry Brown, who was governor from 1975 to 1983 and reelected in 2011. The backdrop for all of this is the rich history of California, illuminated with small historical details that are a testament to Pawel's research.
