LWV MAY FIRST FRIDAY FORUM May 5, 2023: Plans for the Ellen Stone Building

On May 5, 2023, at 9:30 am at the Lexington Community Center, the Lexington League of Women Votes will present a program reviewing the present status of the Ellen Stone Building and future plans for its restoration offered by the Lexington Lyceum Advocates.

On March 31, 2023, Lexington's Town Meeting voted to approve \$400,000 in Community Preservation Act design funds as a first step in a phased process to study, design, repair and restore the historic building (built 200 years ago) for future programming use.

According to the Lexington Observer "The Ellen Stone Building has served many community functions since it was built in 1833: home; abolitionist gathering space; transcendentalist hub; and, most recently, a branch library once frequented by many Lexington families. Today, the Greek-Revival style building sits empty, as it has since a pipe burst in 2007 and shuttered the library branch." Now citizen advocacy seeks to turn the Ellen Stone building into a modern-day lyceum.

The May 5 program will include parts of the power point and video prepared for Town Meeting and presentations by three speakers from the Lexington Lyceum Advocates:

- **Kathleen Dalton, LLA Director**, is a biographer and public historian, and the author of *Theodore Roosevelt: A Strenuous Life* (2002). She has worked as a history teacher, a professor, and a public history consultant with the National Park Service and the Theodore Roosevelt Presidential Library and Museum.
- Mark Manasas, LLA President, has a background in building and leading engineering teams developing medical devices. He is on the board of LexFarm and Lexington Zero Waste and the Vision for Lexington Committee. He served on the Stone Building Feasibility & Reuse Committee and is a Precinct 2 Town Meeting Member

• Meg Muckenhoupt, LLA Treasurer, is a writer and editor focusing on New England history and land use. She served as a liaison to the Stone Building Feasibility & Reuse Committee and is a Precinct 1 Town Meeting Member.

This program is the eighth in the 2022-2023 First Friday Forum series hosted by the League of Women Voters to promote awareness and understanding of public policy issues. There will be time for Q&A after the program. All League programs are free of charge and open to the public. HOW TO GET INVOLVED

Each legislative session, the Massachusetts League of Women Voters, consulting established League positions at the national and state levels, selects bills pending in the Massachusetts legislature to support, or in some cases, oppose. Currently, the state League actively supports some 60 bills in the following areas:

- Children and Families
- Climate Issues

- 1. Find your legislators' contact information at the end of this Bulletin.
- 2. Type the selected bill number into <u>malegislature.gov</u>, and click on the "Petitioners" tab to see if they are already signed on as co-sponsors.
- 3. If they are listed, thank them by email or phone.
- 4. If they aren't listed as co-sponsors, call or email them and request that they sign on as an official co-sponsor of the selected bill, letting them know why that issue is important to you. Include your complete name and address as their constituent.

LWVUS MANAGEMENT

The national League of Women Voters is processing through a Structure Transformation Plan and has reached the stage of engaging members at all levels in the design and planning.

LWVUS has assembled four key working groups made up of local and state League members who will inform each of the four core areas of *Framing the Future*: (1) Business Model Working Group; (2) Data Working Group; (3) Functional Specification Working Group; and (4) League Capacity Working Group. Special care was paid to ensure diversity in age, race, and location among members of the groups. They are meeting over spring 2023 and will make their report at Council 2023.
