## LWVBF Treasurer's Report – Carla Ciotti

**Income and Expenses:** In February, we received one new membership from Dartanya Helgeson. We also collected \$619.00 from members for the Birthday Lunch at CG Public House. We paid \$664.85 to CG Public House. Unfortunately, because of the wintery weather a few members who had sent an RSVP were not able to attend.

**Transition to ChapterSpot Membership Platform:** The National League of Women Voters (LWVUS) launched the new membership system on February 3, 2025. As of March 13th, League members, other than selected officers, have not received an email asking them to log in to the ChapterSpot portal and create a profile. Members will not be asked to renew their membership until it expires in the fall. After the invitations are sent, a group of seven members have volunteered to contact other members to inform them of this step and assist if needed. The Join/Renew button has been placed on the LWVBF webpage and is working. On March 4, Maria Bang joined our league. Welcome, Maria.

**Budget Committee:** The Budget Committee consisting of Shirley Sonnichsen, Janet Nail, Christine Grantham, and Carla Chiotti, met on March 12<sup>th</sup> to create a draft budget for fiscal year 2025-2026. Given the new membership system, this task was quite a challenge. The draft budget will be presented to the Board for approval at the April meeting, and to the general membership at the annual meeting in May for final approval.

**Education Fund:** We received an update on the balance of the Education Fund on February 28, 2025. Three more members sent contributions to our Education Fund at the Seattle address given below. These donations totaled \$2,600. Our balance stands at \$11,640.42.

On February 22, the Project Approval Request to use \$4500 of our Education Fund for scholarships and expenses was approved by the LWVWA Education Fund Board. Our chapter plans to award two scholarships of \$2,000 each.

### Making Donations to LWVBF - Carla Ciotti

Many members of LWVBF have generously made donations to our local league usually by adding money to their annual dues. With the change to the new ChapterSpot Membership System, donations made by increasing your annual dues will be divided among National, State, and Local leagues. Our share will be 20%, minus processing fees.

When you are asked to renew your membership, we would like to encourage you to pay the recommended dues of \$75 (this has been our league's regular dues amount), then use another method to donate extra to our league.

Ways to donate to our local league:

- The recommended method is <u>write a check</u>! A check written to LWVBF and mailed to P.O. Box 765, Richland, WA 99352 will be deposited into our bank account and used for local programs and operating expenses. Every penny of your donation will go to our league. Although our league is a charitable, non-profit organization, we are not a 501(c) 3, so this donation will not be tax-deductible. Donations will be greatly appreciated, especially during the uncertainty of the ChapterSpot transition.
- 2. Go to our website, https://my.lwv.org/washington/benton-franklin-counties. The Donate button will take you to a page where you can donate either to the Education Fund (more on that below) or to the League of Women Voters. If you choose the second option, you will be directed to another page that gives you a choice to either donate by check or to continue and donate using PayPal with your credit card. Donations will come directly to our local league, minus PayPal fees.
- Go through the LWVUS ChapterSpot website when you pay your dues. The donation button for local leagues will be on the page following your dues renewal page. Remember if you simply add money to your dues amount we will only receive a fraction of it. If you use the donation button we will receive the amount minus Stripe transaction fees.

# Go Green Table Talk, March 21st, 2025 – Lora Rathbone

NW Public Broadcasting senior environmental correspondent Courtney Flatt was our guest speaker at our Go Green Table Talk in March. We also heard from Carmine Hanks, a member of the Tri-Cities Citizens' Climate lobby, and current Master of Science in Science Communications student. Having taken a course in <u>solutions journalism</u>, she said there is evidence that it helps with news fatigue and reader agency. Carmine then guided people on being part of the solution by commenting on LWVWA environmental bills currently making it through the Washington State Legislature. A handout was provided with a list of bills. (You can also find the bills at lwvwa.org/2025Issues.) The table was decorated in St. Patrick's Day lucky Irish green, offering green cookies, beverages, and "hot toddies" (tea and coffee).

#### The process to choose bills:

Lora explained the process the LWVWA uses to choose bills for our local leagues to advocate for. The number of bills the LWVWA issue teams consider is impressive! Decisions are based on league positions, including that climate change is real and needs to be addressed. "We now have no time to lose in implementing broad policy to slow planetary warming." [In Feb. 2024, global temperatures passed the critical 1.5C threshold above pre-industrial levels and remained a full 12 months for the first time. - World Meteorological Organization]. Although solutions must align globally, state and local Leagues and individuals have a critical role to play in working to limit future climate change and protect the planet." - *Issue Team Chair: Martin Gibbins, mgibbins@lwvwa.org* 

#### Why should our league be involved?

- The league has a respected moderate voice, and a wide-reaching scope of educated activists, which means we can make a difference!
- Washington state has the capability to lead the nation and the world in the necessary transition from fossil fuels, creating good jobs and better health.
- Locally we are transitioning from Hanford site cleanup to being a center for renewable energy research and development, which is of interest to our legislators.

#### **Courtney Flatt's presentation:**

Courtney stressed that climate change is the biggest environmental problem of our time. She played a recording of her <u>radio story</u> about the impact on the ocean: warming temperatures, lower oxygen levels, and acidification is harming sea life including salmon.

Another story was about <u>people living near a landfill</u>. Courtney is now using Solutions Journalism, and gave HB 1154, re: landfill permits, as an example of how people can be part of the solution. She and other journalists have also moved away from "telling both sides" and just report the facts - what the science says.

## 2025 Legislative Update from the LWVWA – Lora Rathbone

The WA Senate and House will be releasing their budget proposals this week on Monday, March 24th. Negotiations among legislators will then ensue over the next few weeks. The expenditures

approved in the final budget will need to be backed by adequate forecast revenue to be considered a "balanced budget". There are three budgets that the Legislature adopts. These are the operating budget (General Fund), the capital budget and the transportation budget. Each has challenges because the forecast revenues are not adequate to cover the estimated costs of existing services.
