## **2019 LWVWA Convention**

My most memorable experience at the convention was when League delegates were deciding on a program, not previously recommended, to be eligible for consideration and adoption. The program under discussion concerned the Snohomish County League's position on Civil Discourse: "Promote civil discourse through action and education for all government bodies, staff and the public for the purpose of improved public decisions and processes. Civil discourse means, at a minimum, mutual, respectful, courteous, constructive and orderly communication." Their proposal was to establish a formal LWVWA position on civil discourse. Before voting, we had a lengthy 'For' and 'Against' discussion. Those in favor said that we needed to have a civil conversation at a time when society has become so divisive and our democracy is at stake. One league member in support of the proposal described her experience of encountering a boisterous attendee at a forum telling an immigrant, "If you don't like the US, go back to your country." For the argument "Against," one league member said the government already has a code of conduct for elected officials, and the league could not make a rule for the government bodies. Another person "Against" argued that "civil discourse" would mean different things in different cultures. Minority communities may have a different definition of "Respect" than the majority. The arguments on both sides had merit. More people wanted to take a mic to either support or oppose the non-recommended program. But the vote had to be taken. The voice vote sounded even. So the delegate votes had to be counted. The final vote was Yay, 40 and Nay, 53. The delegates decided the non-recommended program was not eligible for consideration and adoption. For me, it was an exciting experience. True civil discourse was unfolding right in front of me. Both sides had different opinions and were so passionate about their principles. I wished this event had been videotaped. The video could be used to show how people can have civil discourse to debate issues they do not agree on.

# From the LWVWA State-Owned Public Banks: A National "Hot Topic"

The LWVWA established a Public Bank Task Force (PBTF) to address League members' interest in discussing the current legislative proposal for the Washington Investment Trust, a state-owned public bank cooperative. If enacted, potential impacts of this proposal may affect both urban and rural communities throughout the state. The PBTF distributes information on the LWVWA This Week In League (TWIL) newsletter with links and will provide resource materials compiled to date on the LWVWA website. However, it is important for us to hear from Local Leagues in both urban and smaller communities, which are often not strongly represented in Olympia. To address the need to share information, educate all League members and determine what, if any, involvement the league should have, the PBTF has begun contacting every local league asking that one person be identified as a point of contact. This person should be the main point of contact for the PBTF to share pertinent documents with the local league members, and to solicit member input. Please reply to the task force by August 11 with the name, email address, and possibly telephone number of the contact person. Also, let the PBTF know if your members are currently aware of the public bank proposal and if they have an opinion of the idea. Please email publicbanktf@lwvwa.org with your comments and questions.
