# LWV 53<sup>rd</sup> National Convention: Creating a More Perfect Democracy Chuck Torelli

On June 28 through July 1, the 53<sup>rd</sup> LWV National convention was held in Chicago, Illinois. Beverly Johnson-Torelli and JoAnn Bengtson represented the LWVBF. The LWV-Yakima, through coordination with the LVW State President and Yakima Board, was represented by Chuck Torelli. Judy Golberg attended as a member of the Nominating Committee for national board members.

For those who have never attended an LWV convention, the format is as follows:

- Morning caucuses, workshops and information meetings.
- Plenary Session with all the delegates (~850 representing 49 states and D.C.), non-voting attendees (~130) and staff (20)
- Evening break for dinner
- Evening caucuses, workshops and information meetings.

The theme of the convention — "Creating a More Perfect Democracy" —was on full display for both external issues and internal self-reflection.

Externally, there were speakers and workshops focused on climate change, redistricting, money in politics, the Electoral College vs. the popular vote, healthcare, and so on. The public policy issues supported by the LWV reflect the value of participation rather than partisanship. The emphasis continues to be on voter involvement. An excellent example occurred Saturday afternoon: League members took the time to make signs and march in 95° heat for reunification of immigrant families and show support for the Dream Act.

The internal focus was seen with sessions on the Transformation Roadmap, Diversity – Equity – Inclusion (DEI), The State of Women, and more. LWV has recognized that for the League to remain relevant, the membership demographics need to be more reflective of society. Current membership is largely older, white, middle/upper middle-class women. Outreach is needed as well as recognizing the unconscious barriers that can be in place.

Finally, this 'write-up' fails to cover the convention's excitement and energy. On specific issues, people disagreed, argued and still came together. Speakers such as Rosie Rios, 43<sup>rd</sup> Treasurer of the U.S., inspired us with her dedication to empowering young girls. Keynote speaker Elaine Weiss, author of *The Woman's Hour*, outlined the struggles of the past and provided hope for the future. Attendees cheered for the ERA and booed gerrymandering. It was a convention with purpose and passion. LWV is about the power of acting and recognizing the dangers of complacency.

It was an honor to be allowed to attend as a delegate and an experience I will always treasure!

### From LWVWA: Behavioral Health Study Request

#### **Barbara Chevalier**

"My name is Barbra Chevalier, and I'm the study chair for the behavioral health (mental illness + chemical dependency) survey study adopted by the LWVWA at Convention in 2017. The original study time frame has been extended to 2021 due to the current overhaul in process for the state Medicaid system.

We are convening a committee focused on behavioral health issues with representatives from as many chapters around the state as possible to begin tracking and following changes occurring at the local level. We hope this committee can lay a foundation for the work to be completed in 2021 and also inform our state advocacy in the interim. The committee will meet quarterly or perhaps biannually via conference call to report out any changes, successes or failures in local behavioral health services. Is there someone in your chapter who would be interested in serving on this committee and being the resident expert on changes to the behavioral health system in your area?"

## **Treasurer's Report**

At the end of June, checking was \$1,101; savings was \$1,856 for a total of \$2,957.

*Income*: None. The fiscal year ends June 30. Dues are due September 30 and a letter will be sent out late August or early September. Expenses: The Secretary of State 990N form was completed and the \$10 paid.

*In Kind Expenses:* Bev Johnson Torelli, Chuck Torelli and Jo Ann Bengtson attended the LWV National Convention in Chicago. After the \$1,000 we paid each of them, Bev and Chuck had "in kind" expenses of \$1,471; Jo Ann's "in kind" expenses were \$930 for a total of \$2,401 "in kind" for National convention, which will give us a good baseline. The total "in kind" expenses for members were \$2,700, but I'm sure there were many more that I haven't received.

*Membership:* We still have 48 paid members and 56 in total. We voted on whether to have students join the LWVBF for free and the motion passed. The mechanisms are set up by National, and their form has been filled out for our League to have students be free until 2021. The survey link was sent to a potential WSU student, Akaana Poor. She was also sent a membership form and the Voter.

A reservation was made at the north pavilion in Howard Amon Park in Richland for our annual picnic on Tuesday, August 28 from 5 to 9 p.m. The picnic will begin at 5:30 pm, but we can start setting up at 5.

#### Book Recommendation Valerie Moffitt

Released in March 2018, *The Woman's Hour: The Great Fight to Win the Vote* by Elaine Weiss chronicles the passing of the 19<sup>th</sup> Amendment, which granted women the right to vote. It follows the key players and recaps the political atmosphere before, during and after the amendment's passage. The book also reflects on how opposing forces are still at work in our political life today as we watch history repeat itself.

The LWV came out of those early days and its mission remains as vital and relevant to our politics today as it was 100 years ago.

# Letter to the Editor: Climate Change

We are breaking heat records again this summer. Imagine what it must be like to work long hours picking our crops in this heat. "Scientists have high confidence that global temperatures will continue to rise for decades to come, largely due to greenhouse gases produced by human activities. Heat waves everywhere are projected to become more intense." <a href="https://climate.nasa.gov/effects/">https://climate.nasa.gov/effects/</a> "Episodes of extreme heat can have serious societal, agricultural, economic, and ecological impacts, with heat being the number one weather-related killer." (National Weather Service 2012). David Arkush and David Michaels (*Spokesman-Review*, July 2018) said "Heat stress is possibly one of the leading workplace dangers in America. And climate change is making it deadlier. We need to protect workers from extreme heat before it grows more intense. That's where we are headed on our current greenhouse-gas pollution path. And as climate impacts go, losing summer outdoor labor in whole regions of the United States is the small stuff. We need to get ahead of this problem before we face devastating consequences for public health and the economy." Representative Newhouse's interest in local agriculture should include concern about the threat of extreme heat to its workforce, and action to slow global warming.
