# The 19th Amendment Celebration Continues...

Thanks to all who rang bells and "toasted to tenacity" on August 26, but our work is not finished.

LWV Beloit asked the Beloit Public Library to host a new popup exhibition from the National Archives, Rightfully Hers, commemorating the 100th anniversary of the ratification of the 19<sup>th</sup> Amendment. Rightfully Hers contains simple messages exploring the history of the ratification of the 19<sup>th</sup> amendment, women's voting rights before and after the 19<sup>th</sup>, and its impact today.

Despite decades of marches, petitions, and public debate to enshrine a woman's right to vote in the constitution, the 19<sup>th</sup> Amendment – while an enormous milestone – did not grant voting rights for all. The challenges of its passage reverberate to the ongoing fight for gender equity today.

#### **Alternative Education**

The LWV of Beloit supports:

- the commitment by the school district to alternative education.
- an organized, sequential, ongoing, comprehensive plan to provide a variety of alternative methods to educate students at all grade levels who are not achieving their full potential in the traditionally structured classroom.
  - comprehensive alternative education plans would not include state-mandated special educational programs
- identification of student needs as criteria for setting up long- and short-range funding priorities within a comprehensive alternative educational plan.
- seeking a variety of sources to finance alternative education programs including community resources, the local tax levy, available grant funds, and state and federal aid.
- the involvement of teachers, administrators, students, parents, and community representatives on an individual basis to determine appropriate support services needed.
- a system of selecting participants for alternative education programs which includes:
- 1. use of established criteria to identify student needs,
- 2. referral by teachers, counselors, or administrators,
- 3. student application.

The LWV of Beloit supports:

- the following for students who have been "placed" in alternative education:
  - ensuring due process is followed during the placement process.
  - specific educational/support goals are developed and implemented.
  - specific criteria for returning to their home school be established at time of "placement" and evaluated at regular intervals.
  - when criteria are met, the placement program will begin the process for readmittance to the home school or other designated alternative education.

The LWV of Beloit supports:

• Students with Individualized Education Program (IEP) and/or 504 plans having equal access to all alternative educational settings.

The LWV of Beloit supports:

- policies which allow the school system to respond to constantly disruptive students, not through punitive measures, such as suspension or expulsion, but through positive interventions, including short-term alternative settings.
- putting a priority on prevention programs at the transitions between elementary and intermediate schools and intermediate and high schools, which appear to put students at greatest risk.
- programs in elementary schools that are targeted primarily for high-risk students and recommends that these and other programs can be expanded as excellent preventative tools.

The LWV of Beloit supports preventive services and positive interventions which take into consideration possibilities of limited funding, such as the following:

- Development of instrumentality\* charter schools to meet the diverse and particular needs of students.
- A truancy abatement program in cooperation with Juvenile Probation and the local Police Department.
- Placement of suspended children into community service projects.
- Increased involvement of other community businesses, agencies and resources to create and fund programming.

The LWV of Beloit does not support:

- voucher schools,
- independent non-instrumentality non-district\* authorized charter schools, and
- Any educational institution that draws funds away from public school districts.

<u>Instrumentality</u> charter schools: are run by public-school district employees and follow district guidelines and charter bylaws; the elected school board governs. Non-instrumentality charter schools may or may not be public school sponsored:

• Non-district authorized, non-instrumentality charter school: governing board of charter makes decisions, independently run



#### Voter Helpline (608-285-2141)

Please see the information below about the Voter Helpline on the state level. Pat Zody will be the contact person for issues related specifically to the Beloit area. Members of the voter service committee will help out with questions or serving as a witness for an absentee ballot when a voter is staying in due to COVID. Also, don't hesitate to share the Voter Helpline phone number with anyone having trouble registering to vote, requesting an absentee ballot, where to vote, etc.

The League of Women Voters of Dane County, through it's partner organization, the Dane County Voter ID Coalition, maintains a Voter Helpline (608-285-2141) that voters throughout the state can call for assistance with voting questions. Dane County volunteers are able to answer most questions to the Helpline. But sometimes local experts are needed to provide information unique to a community or to provide direct assistance, for example serving as a witness for an absentee ballot when a voter is staying in due to COVID. The Helpline's statewide network currently has 17 local experts covering 25 counties and communities, and continues to grow with the participation of local League of Women Voters and ACLU chapters, other grassroots groups and civic-minded individuals.

They have 3,000 members, consisting of training institutions, builders, users, and installers, etc. A total of 8,400 have attended their solar power hour presentations, and 1,500 properties have gone solar. #### How to Watch Rock County Board of Supervisors's Meetings on YouTube

A small silver lining to the pandemic, has been that Rock County Board of Supervisors meetings are now finally able to be viewed remotely on YouTube. All one has to do is to look for a channel on YouTube called: "<u>Rock County Public Meetings</u>". Board meetings are held on the 2nd and 4th Thursday of the month beginning at 6 pm. There is a question to be raised regarding how long this will last or what will happen once meetings are resumed to being held face to face. It appears at this time that if things will proceed as they are, the board will be utilizing Zoom platform for the foreseeable future.

There is no enthusiasm within the board to begin meeting in person until at least the end of the year, and then probably only beginning in the spring or summer. Even then, until there is an effective way of treating the current pandemic, it is hard to see the Board abandoning a familiar and convenient platform. This will no doubt require certain adjustments to make for a smooth transition and some kind of hybrid meetings, allowing Supervisors at home and at the courthouse, to participate in meetings equally. If the county continues to plan for this, (the sound system has just been updated, yet our ability and commitment to streaming video from the meeting room itself remains unclear) all meetings from now on will be viewable online. That is good, if nothing else, because the public won't rely on a supervisor using a phone to stream meetings on Facebook, and can clearly see and hear what public officials are seeing and hearing. Once again, thanks to everyone who tunes in to check out the going-ons of the Board of Supervisors. Transparency in our government is paramount to the success of our democracy.
