Classifications of Pollution

- Point source (PS) pollution is a single definable source of air, water, thermal, noise or light pollution.
- Nonpoint source (NPS) pollution from industrial and sewage treatment plants, comes from many diffuse sources. NPS pollution is caused by rainfall or snowmelt moving over and through the ground. Unlike PS pollution NPS doesn't come out of a pipe.
