- May 14<sup>th</sup>: CMAL Delegates consider Position Revisions
- May 15<sup>th</sup>: CMAL will issue a Press Release as appropriate to County Boards and County Government Interviewees

## LWV Edina Efforts to End Racism

**May 2020 brought much attention to racial issues in the Twin Cities and beyond.**

In response to the racial issues, the LWV Edina stepped up and established a new goal for our organization. This goal simply stated was:

**“To advocate and participate in local action to eradicate discrimination and systemic racism.”**

That was only the beginning of our journey.

LWV Edina established a **Racial Justice Action Committee (RJAC)** with three subcommittees

- LWV and Race - Past, Present, Future
- Voting Rights is a Racial Justice Issue; and
- Learning and Unlearning: The History of Whiteness and Racism.

We realized that ACTION is necessary to move toward this goal.

To that end, in February 2021 our members approved a study to review our social institutions in Edina for an in-depth review of our racial diversity, equity and inclusion issues, which we hoped would lead to the development of best practices for our city. We initially hoped the study would be completed before our Annual Meeting in May 2022, but we realized that our issues were more complicated, and the study will not be finalized until 2023.

The League and RJAC is taking action to educate ourselves and community members to understand what exactly racial justice is.

To help in this education we have:

- Reviewed films such as **Jim Crow of the North**;
- Read and held discussions on books such as: **Caste** and **Stamped: Racism, Antiracism and You**

- Had a Guest Column written for our local newspaper
- Held Events on such topics as:
  - Voting Rights and Indigenous Peoples**
  - Voting Rights and Felon Disenfranchisement**

**Still, this is only the beginning.**

What we have learned so far.

- The importance of Partnerships
  - We have partnered with the Edina Community Foundation and the Edina Anti-Racism Collaborative.
  - These partnerships have been essential in helping our members learn and understand how racial injustice affects individuals and our community.
- There is no “recipe” for the eradication of discrimination and systemic racism.

**As John Lewis once said, “When you see something that is not right, you must say something. You must do something.”**

**I encourage everyone to do something to make our democracy work for all – Colleen.**
