Thomas L. Bowen, M. Div. is the Director of the Mayor's Office on African American Affairs and Religious Affairs, and the Commission on Fathers, Men and Boys for the city of Wash. D. C. Bowen is a graduate of Morehouse College; ministerial and theological training from The Divinity School at the University of Chicago. He was ordained at the Mount Zion Baptist Church of Oberlin, Ohio. A native of Elyria, Ohio he was the youngest person elected to the Elyria Board of Education.

Julia Shearson serves as the Executive Director of the Cleveland Chapter of The Council of American Islamic Relations (C.A.I. R). Under her direction, C.A.I.R. has provided diversity training to over 1600 members of the Cleveland Police Department. Ms. Shearson has a Masters in Linguistics and Middle East Studies from Ohio University and Harvard respectively.

Virginia Simons, LISW; Ms. Simon has been a Family and Couples Therapist for over three decades. Before coming to Ohio and working with physicians at the Cleveland Clinic she was in private practice in Chicago. Ms. Simons spent four years in Chinle Arizona working among the Navajo people. She has also worked as a clinician with Oberlin College in student mental health services.

April Stoltz, Community Activist dedicated to building bridges and encouraging conversation about race, religion and politics. She is a volunteer with **Teatime for Peace**, a program of sharing a little tea and empathy. Participants meet, talk, sip and nosh and hopefully understand others.

Justin Herdman was sworn in as the United States Attorney for the Northern District of Ohio on Aug. 21, 2017. He brings a depth and breadth of experience to his position representing the United States in court in Ohio's northern 40 counties, including Cleveland, Toledo, Akron and Youngstown. Herdman was an Assistant United States Attorney from 2006 through 2013. Prior to becoming U.S. Attorney, Herdman was a partner at Jones Day, where he represented businesses and individuals under investigation.

Francisco X. Dominguez is elected state district judge of the 205th District Court, handling civil and felony criminal cases. Dominguez began his legal career with New York Legal Aid Society – Criminal Defense Division; represented farmworkers and garment workers as a staff attorney with Texas Rural Legal Aid, Inc., and prosecuted employment discrimination cases with the U.S. Equal Employment Opportunity Commission. Judge Dominguez is a 1989 graduate of Oberlin College and serves as an Alumni-Elected Trustee. He resides in El Paso, Texas.

Anabel Barron-Sanchez, LOIRA; An Immigration Specialist with El Centro De Servisioso Sociales, Ms. Barron is an activist with personal experience in working with undocumented immigrants living in Lorain County. She has achieved national prominence for her work.

Anthony Brogdon, Filmmaker is a native of Detroit where he witnessed African-American economic decline in the Motor City. His film is about, The Rise of Black Businesses in America 1800's to 1960's.
