We have been talking about having dues paid by the end of December 2024. A little clarification: League of Women Voters United States is changing the membership process. Currently, members pay their dues to the local leagues they send the per-member-payment (PMP) to LWVUS. Member dues are split between local, state and national. Beginning January 2025, members will pay their dues directly to LWVUS via new membership software. National will send the appropriate portion of dues to local and state leagues. # **Advocacy Corner**

#### Lame Duck is Here

Lame Duck, the period between Election Day and the start of a new legislative session in January of the next year, continues next week. The schedule is <u>here</u>, but items are often added at the last minute, so we recommend checking both the GA schedule and our site frequently. There are a number of bills we are watching closely and taking action when necessary. They include:

- <u>SB 324</u>: Would add provisions to change election law, including but not limited to removing drop boxes, new requirements in initiative petitions, and more involved processes for citizenship verification in voter registration.
- <u>SJR 5:</u> Would modify the process for statutes proposed by initiative petition, primarily eliminating the four-month legislative window to

instead give a two-year safe harbor to newly passed initiated statutes.

• <u>SB 173</u>: Would protect election workers by expunging their home addresses and cell phone numbers from public record.

Here's how to stay informed and get involved:

- Follow all the bills we're tracking in lame duck: Go to our<u>Legislative</u> <u>Tracker</u>, which has been updated with the bills we're following and will be refreshed throughout the period.
- Actions you can take now: Go to our<u>Action Alerts</u> page to contact your legislators on a few key bills.
- Keep an eye out for "Action Alert" emails from us: When there is an opportunity for us to do rapid response, we will send members an email that will allow you to message lawmakers directly.
- Join Lobby Corps: Lobby Corps provides regular advocacy updates on the legislation we are following via email and monthly calls. All members are welcome, and we ask that all Leagues have representation on the calls. To join our listserv, go <u>here</u>.


#### **Ohio Voters and VOTE411**



Voter turnout in Ohio was down for the Nov 5, 2024 election. According to Cincinnati.com and Ohio Secretary of State 5.85 million Ohioans or 71.71% of registered voters cast ballots in 2024 compared to 5.97 million Ohioans and 73.99% of registered voters in 2020.

Vote411.org had 9.1 million users across the country. Ohio had 280,509 users and Hudson had about 1400 users.

Imagine an American president who imprisoned critics, spread a culture of white supremacy, and tried to upend the law so that he could commit crimes with impunity. Constitutional law and political science professor Corey Brettschneider provides a thoroughly researched account of assaults on democracy by not one such president but by five—John Adams, James Buchanan, Andrew Johnson, Woodrow Wilson, and Richard Nixon. This is a book about citizens—Frederick Douglass, Ida B. Wells, Daniel Ellsberg, and more—who fought back against presidential abuse of power. Their examples give us hope about the possibilities of restoring a fragile democracy.
