Voter Service

We participated in a Get Out the Vote rally on Oct. 29th at Volunteer Park in Pasco. There were hot dogs, pizza, popcorn and drinks. There were candidates and signs and music. There was also rain— and no one from the public. The county auditor even kept its office open that Saturday to provide an extra opportunity for people to register before the Oct. 31 deadline. While it may not sound like a success, it was a worthwhile experience. There was a large gazebo, and the rain did let up and many candidates showed up. They all took turns speaking to the group about why they were running and what they wanted to accomplish. It was a much more relaxed atmosphere than we see at our forums, and I think the candidates enjoyed having the opportunity to visit with each other in a less confrontational manner.

On Nov. 15th we assisted in registering new citizens at the Naturalization Ceremony at the Federal Building in Richland. It is always a worthwhile experience and I encourage all of you to attend when you can. After the ceremony, I went to visit Paula Garland and took her lunch. She is spending more time in bed, but is always happy to see me (and anyone else) and she always asks how League is doing. She makes 101 look good.

Treasurer's Report Shirley Sonnichsen

At the end of October, checking was \$3,909; savings was \$1,856 for a total of \$5,765.

Income: We received dues of \$1,385 and contributions of \$245. We also received \$228 for the October table talk luncheon. Total income was \$1,828.

Expense: Total expenses were \$221 for Columbia River catering for the ballot issues Table Talk, \$209 for 2nd quarter State PMP, and \$102 for the post office box rental. Total expenses were \$532.

Membership: We have two new members, Jill McLaughlin who is actually rejoining and Hala Abdel Aal. We have 43 paid members (including two who joined this summer), and 50 in total. I will send the membership list out again soon. Two people (of the 50) have not paid their dues. **IRS:** 990N is an IRS electronic postcard we do every year five months after our fiscal year ends stating that we do not have income of more than \$25,000. It does not cost money and is complete for 2015.

Observer Corps
