# DALLAS ISD TAX RATIFICATION ELECTION

The Dallas Independent School District is home to 222 schools that serve a diverse population of approximately 156,000 students in grades prekindergarten through 12.

Dallas ISD continues to focus on improving student achievement through expanded cademic options such as:

- A prekindergarten program with more classes in every area of the city.
- A growing selection of schools of choice, including leadership, STEM/STEAM, singlegender, personalized learning, two-way dual language and Montessori.



Dallas ISD is making strides toward our vision of becoming a premier urban school district that is the first choice of Dallas families. To maintain this forward momentum requires hard work and funding. Our staff is committed to the work. District leadership is recommending to the Board of Trustees approval of a Tax Ratification Election to provide the funding.

This brochure outlines how TRE funds would be utilized should trustees approve calling an election. The brochure also discusses the estimated costs of a TRE to taxpayers and information regarding community meetings and important dates.





# Frequently asked questions



### WHAT IS A TAX RATIFICATION ELECTION (TRE)?

A TRE is a special election called by a school district's board of trustees that asks voters to approve an increase in its maintenance and operating (M&O) tax rate. M&O taxes cover the day-to-day cost of school district operations. Since 2008, Dallas ISD has maintained an M&O tax rate of \$1.04. The approval of voters is required for the district to exceed the \$1.04 rate. Should Dallas ISD trustees approve calling a tax ratification election, it is anticipated they will seek to increase the M&O tax rate to the state cap of \$1.17.

### **HOW MUCH IS THE PROPOSED TAX INCREASE?**

The District's administration is recommending adding 13 cents to the existing \$1.04 M&O tax rate for a new rate of \$1.17. Coupled with Dallas ISD's current debt service tax rate of \$0.24, the final combined District tax rate would total \$1.41.


# HOW WILL THE TRE AFFECT TAXPAYERS WHO ARE OVER 65 OR DISABLED?

The TRE will not affect taxpayers 65 years or older or those who are disabled if they have a frozen tax levy, which requires filing the appropriate homestead exemptions with the county appraisal district.

## HOW MUCH WILL THE TRE COST HOMEOWNERS?

The median market value of homes in Dallas ISD as determined by the Dallas Central Appraisal District is \$184,574.

If trustees decide to ask voters to increase the tax rate by 13 cents, the increase would raise property taxes on homes at the average market value by \$0.65 cents per day or \$20 a month—less than the cost of a tank of gas.




