League of Women Voter's website, www.lwv.org has recently been re-created to make it more user friendly. No longer does it require a password to access information. At the very bottom of the home page there is a red box that says League Management. Then it might be quicker if you search for it by using Google or another search engine. Type in: LWV Bylaws or whatever topics you wish. Google is not the only search engine available to you. Recently I learned that http://duckduckgo.com is also a good search engine that does not collect "cookies" to track what you are searching for. Try doing a little search to find out what is available.

Mental Health Court

Katy Butler, a judge with the mental health court, and prosecutor Megan Killgore were the guest speakers at our holiday party in December. They spoke about how mental heath court differs from traditional court in that it's non-adversarial and focused on treatment and recovery. Participation in the mental health court is completely voluntary and those who choose—and qualify for—this option come from two tracks: **Stipulated Order of Continuance** (preconviction, case is put on hold for up to two years and dismissed upon completion of mental health court) and **probation** (post-conviction, guilty plea, length of probation can be shortened). Both speakers emphasized the positive outcome of the mental health court, which has improved the participants' quality of life, resulted in over 1,000 hours of community service and reduced the rate of hospitalizations, emergency room visits and contacts with law enforcement. Butler noted how she's watched the participants become a community, build a support system and learn ways to better manage their lives. The mental health court can handle up to 37 participants at a time, and there have been 14 graduates so far. Of those 14, **none has come back into the criminal justice system.** Funded by the public safety sales tax, Benton County's mental health court is the third in Eastern Washington.

Annual Legislative Lunch

State Senator Sharon Brown and Representative Larry Haler (Representative Brad Klippert was unavailable) met with us on December 19th. The Hirst Decision was a major topic, resulting in the bulk of water permit decisions being thrust upon the counties, where resources for needed decisions are lacking. Both felt a solution for Hirst must be found before the capital budget could be passed. Ms. Brown also spoke passionately about youth suicide in the Tri-City area and how imbedding mental health professionals in the primary care could help this situation. She also noted a possible side benefit of recovering valuable earth minerals from commercial geothermal projects.

Treasurer's Report

At the end of December, checking was \$3,552; savings was \$1,856 for a total of \$5,408.

Income: We received \$715 in dues and \$18 in Table Talk contributions for a total of \$733.

Expenses: Second and third quarter National PMP payment for \$736.

We have 35 paid members at the end of December. Eight members do not owe (paid after Jan. 31st) and as of today, five people have not paid. With the board's permission, Shirley Miller will be made a Lifetime member. The PayPal account is working. I found out there is a \$2.48 fee for using their services so we will have to adjust for that next year.

I will be updating the national database for the February 1st deadline and those who haven't paid will be marked inactive. We have two new members from the Program planning meeting at Polly's house: Michele Pirotte and Virginia Rogalsky.

National Convention "A More Perfect Democracy" is June 27 – July 1, 2018 at the Chicago Hilton. We will be able to send one or two members, depending on our membership at February 1st. Rooms are \$209 for League members and the rate is available three days before and three days after the Convention. The early registration fee is \$450. Let's Talk

The first current events/hot topics discussion was held in January. The thirteen members who attended chose Immigration— a pertinent local and national subject. We broke into two groups and covered a wide range of issues. We were in consensus about protecting young people in the DACA program but wondered what we would be willing to give up politically to do that. Most were in agreement that "chain migration" wasn't that important to maintain. Spending billions on a wall did not receive much support either. The recent government shutdown was a good example of such tradeoffs. The importance of immigrants to our economy and the challenge of meeting their needs— twenty-two languages are spoken by students at Westgate Elementary in Kennewick—shows how complicated this issue is.

As usual, we felt it was important to have the facts. Some of our members had just attended the meeting sponsored by the Tri-Cities Immigration Coalition, which was very informative. The date and topic for the next meeting has not yet been determined.

Program Planning

About 18 members and two guests met in January at Polly Parton's home to discuss national and local program planning. The recommendation from the National Board to continue with its efforts for Making Democracy Work – with emphasis on voting rights, improving elections, campaign finance/money in politics and redistricting was well received.

The discussion about local program planning brought up many issues our members would like to learn more about, such as sexual harassment prevention and maintaining safe work environments; the Snake River dams; the Columbia River and possible changes in who controls the river shore; and affordable housing. Public Banking, which is currently being studied, was also mentioned. It is not too late to submit any ideas members might have about topics of interest locally.

February 2 is the cut off for all bills not related to the budget. They must pass their policy committee by Friday in order to remain active:

HB 1800 / ESSB 6002: the Washington Voting Rights Act authorizes district-based elections where at large systems and racially polarized voting have excluded communities of color from a fair chance at representation. This is very similar to the WA Voting Rights Act that LWVWA has supported for the last five years. ESSB 6002 passed the Senate with a strong bipartisan vote and was heard in the House State Government Committee. HB 1800 is in the House and is expected to come up for a vote soon. Please let your Representatives know you strongly support all versions of this bill.

HB 2455 / SB 5991: Despite our campaign finance reporting requirements, special interests have found another loophole that allows them to donate virtually unlimited amounts of cash to campaign efforts without any of us ever knowing who they are. And now they are flooding elected officials' offices with emails demanding that that loophole remain. Let your legislators know you support the DISCLOSE act—HB 2455 / SB 5991.
