Since the conclusion of the 2019 fundraising auction, we've had a number of people sign up for events that were offered at the auction. I'm happy to report that the May 16 **Detroit bus tour sold out soon after the auction, and we had great response to four other** events.

The one event coming up which still has availability is the **documentary**, *Uncle Jessie White - Portrait of a Delta Bluesman in Detroit*. The documentary took over twenty years to complete and has been shown in film festivals in eight countries.

The documentary is sixty minutes long, and a discussion will follow the showing. Hosted by Anne Marie Graham-Hudak, the film will be shown at **noon, February 29**, at a place to be determined. #### CLERK ENGAGEMENT PROJECT By Paula Bowman

Nineteen of our League members will be interviewing the 13 city or township clerks in our service area in the next several weeks. The LWV of Michigan is working on this project in conjunction with other voting rights groups, but at least in our area, the interviews are only being done by League members.

The goal of this initiative is to make sure that the voters in each community are receiving accurate information about the new voting rights laws as a result of the passage of Proposal 3 last November. Another goal is to further our good relationship with the clerks' offices by letting them know that we are willing to assist in educating the public and helping their offices recruit poll workers if that is a need.

Many of our community clerks are already on top of the new voting rights laws. We have only to look at their websites to see a link to an absentee ballot application that anyone, for any reason, can use now, or a link to the on-line voter registration. But we're also looking for other voter information tools such as polling locations posted on-line or a sign-up to be on a permanent absentee list. These are among the issues that will be discussed at each of our short meetings. We are grateful to the members who are involved in this project and we'll provide a summary when the interviews are completed.

#### **PRE-EMPTIVE ACTION** By Paula Bowman

The LWV of Michigan's Board of Directors took action at its January meeting to be ready to oppose a *possible* law that would make it a felony for medical providers to perform what's known as a dilation and evacuation abortion, a procedure commonly used in the second trimester of pregnancy. If this sounds familiar, it's because similar legislation was passed in the Michigan legislature last May, but was vetoed by Gov. Whitmer.

Anti-choice groups who supported this legislation have moved on to Plan B, and have now submitted almost 380,000 signatures to get this on the November 2020 ballot. It is anticipated that instead of allowing the proposal to advance to the November ballot, the state legislature will approve the legislation, making it a law that the Governor can not act upon .

The League of Women Voters supports a woman's right to make decisions about her own reproductive health. This legislation would restrict her choice by making it a crime to access a procedure that's often necessary to protect a woman's health.

We are waiting for the bureau of elections to determine whether there are enough valid signatures to qualify for the ballot. If so, the legislature will have 40 days to adopt it as a law. It is during this period that the State League will be advocating that this proposal not become law in Michigan. If the issue does advance to the November ballot, we will also be advocating for Michigan voters to vote no. Stay tuned!

This juried art show honors and recognizes the centennial of the 19<sup>th</sup> Amendment that was ratified on August 18, 1920. It is important to remember the strength of the suffrage movement that campaigned for 70 years before the 19<sup>th</sup> Amendment was passed, and the continuing campaign for women to have equal pay for equal work, and the right for women to make their own decisions about their health and bodies.
