LWVSA Work With Immigrants & Refugees Continues

LWVSA's successful voter education work this past year translating general election ballots into nine languages and conducting voter education workshops across Spokane has resulted in the establishment of a new Immigration Committee.

The Immigration Committee's first LWVSA program takes place at our February member meeting. Attorney Samuel Smith, who works with Manzanita House, will conduct a know-your-rights workshop for League members. The workshop will cover the constitutional rights of immigrants and refugees in the United States, and will give us an opportunity to learn how we can continue to support Spokane's immigrant communities.


2. Welcoming Immigrants to Washington State Study, PDF to download and registration for the Feb. 6 information sessions are here: https://lwvwa.org/immigration

AHHS Interview with Zeke Smith, President Empire Health Foundation

When our committee first formed in 2020, we didn't understand housing and homelessness. We began by talking to city officials, providers, and advocates. The information we gathered led to the resolution we submitted to the LWVSA Board. When it was adopted, LWVSA leadership submitted it to the Spokane City Council and Mayor Nadine Woodward. Truly little has changed since we submitted that resolution. Spokane still lacks low-income and affordable housing. For two years the Spokane Regional Housing Collaboration has been meeting to discuss ways to work together to reduce homelessness and increase low-income and affordable housing. Our committee will spend the next several months interviewing the leaders of Spokane and their views on how to move forward.

In December several of our committee members met with Zeke Smith, President of the Empire Health Foundation. We wanted to learn more about Empire's role in the current housing and homelessness crisis in Spokane. We are especially interested in learning about their plans for moving forward.

As a background Zeke explained they became involved with Camp Hope, partnering with Jewels Helping Hands (JHH) and United Way to manage the funds from Commerce. From there they have continued to manage funds to other programs dealing with homelessness in our communities.

Navigation Center: Currently this is a pilot program, temporarily funded by the city operated by Empire, while Revive is the service provider. CHAS Health makes visits as needed. Being a pilot program means they are constantly collecting data and evaluating the program to make improvements and determine how to move forward. They realize already that they need more resources and engagement with the State for funding. The center located at the Cannon Building accepts referrals only from Truth Ministries, The Way Out and JHH. Drop-in centers include Truth Ministries, The Way Out Center and House of Charity. JHH runs respite centers and is based on referrals. The facility only has 30 beds plus a few inclement weather beds. They are committed to fit within the Spokane mayor's goals but realize the navigation hub needs to become bigger at some point, as beds are full and as with every other site there is a wait list. The challenge is to not mix populations, chronic homeless, recently homeless, formerly incarcerated,

as examples, adapt to change in needs, and not duplicate services across the city.

Empire works with the city to fund three scattered sites, Truth Ministries, and Jewels Helping Hands (JHH) at Cedar Center and

Morningstar. Westminster Respite Center, a joint operation with Providence Heath, JHH and Empire, opened on Jan 13. Conversations continue with other groups to expand the scattered site concept. The challenge is to create spaces that are small and accept specific populations based on gender, age, physical condition, and marital relationships, for example. But it requires funding and resources that are not currently available. Even the holidays play a part in the current needs as families offer housing at that time for other family members.

We discussed the TRAC shelter closure with Zeke who noted the facility was not well-equipped to handle the needs, lacked a system to connect to housing, and was expensive. Nor in his opinion is TRAC or "warehousing" the answer for emergency environmental shelter.

Zeke supports the regional approach under discussion by the Spokane area authorities and supports working collaboratively with the business community and those with lived experience. Honest discussions and review of what does and does not work are also needed. Empire also recognizes this takes time we don't have.

He left us with these final words:

"With the current estimate of the homeless population in Spokane we need 30 scattered site shelters and we can't over-extend the shelters. With that in mind, we may never get to 30 shelters."

LWV Member Dues Collection Changes

On February 3, 2025, the national organization (LWVUS) begins handling all LWV membership enrollments and renewals. Instead of a fixed dues rate, members may choose their dues amount under a pay-what-you-can policy. The goal of these changes is to increase and diversify League membership and strengthen LWV operations across the nation to deliver on our mission and continue as a powerful voice for democracy.

The idea is that a consistent and aligned membership system across all levels of Leagues (local, state, national) will eliminate financial barriers to participation, create an equitable division of dues between levels of the League, and simplify joining the League.

Changes include:

- Recommended dues are \$75; minimum dues \$20; higher dues also an option ie. pay-what-you-can!
- Membership will be for individuals. Household and student membership, along with sustaining and benefactor member designations are no longer recognized.
- Members will have the option to have their membership auto-renew one year after they have joined or renewed. Membership for all

Leagues will now be on a rolling basis, so a membership lasts for one year, regardless of when it begins.

- Members will receive an email renewal reminder 60 days prior to their expiration date. All emails will provide members with links to the LWVUS member website.
- Members are encouraged to join and renew online by credit card, debit card and other electronic bank transfer.
- Checks will continue to be accepted as long as they are payable to the LWVUS and mailed to the local League office.
- Dues allocations are changing 20% goes to the local League; 80% is shared between the state and national League.
- **IMPORTANT NOTE:** Donations may be made directly to the Spokane League through the LWVSA website with 100% of the donation going to our local League.

Once the new system is up and running, we'll provide Spokane League members with tech navigation details about how exactly the system works. *Watch for the March issue of The Voter!*

Observer Corps is an opportunity to see first-hand our local government in action and be a connection for the LWVSA if there is something important we may want to take action on. Most meetings can be attended virtually and reporting back to the League is relatively simple. *"Many hands make our work light"*. League of Women Voters' positions and advocacy on Reproductive Rights

At our January member meeting, reproductive rights was the topic of most concern during discussions of LWVSA's program of work for 2025-2027. Here is a summary of League positions and actions.

League of Women Voters' Statement of Position on Public Policy on Reproductive Choices, as announced by the national board, January 1983: "The League of Women Voters of the United States believes that public policy in a pluralistic society must affirm the constitutional right of privacy of the individual to make reproductive choices."

One Year after Dobbs: Women in Democracy Will Save Reproductive Rights

- By raising women's voices through public office
- Rights will apply to people who identify female, including nonbinary and transgender people who experience pregnancy. Supporting people who can become pregnant means fighting for a world where equality of the sexes is real and recognized.

At the 2024 Convention, delegates passed a resolution reaffirming the League's commitment to fight for reproductive rights and justice, including bodily autonomy, privacy, reproductive health, and access to contraception and abortion.

LWV's national legislative focuses in 2025:

- Passing voter legislation that protects a woman's right to vote
- Adding sex-based equality to the Constitution with the Equal Rights Amendment
- Restoring our reproductive rights

LWV Washington State: last year and now *In 2024, the state League:*

- Supported successful HB 1009, concerning student health plans to make them subject to the abortion requirements applicable to other health plans.
- Supported successful SB 5068, extending coverage during post partum period through 1 year post partum.
- Supported successfully SB 5140, protecting pregnancy and miscarriage-related patient care.
- Successfully opposed HB 1008, successfully prohibiting abortion on the basis of Down Syndrome.
